If all you wanted for Christmas was new Western Dressage tests, you're in for a great holiday! The new 2022 Western Dressage tests are posted on the WDAA website.

Our test writing committee was headed up by Joyce Swanson with Susan Lang, Sharron Sarchet, Jodi Ely, Joanne Coy and myself. Formatting was done by WDAA contractor, Gail Matheus. The committee and staff was very thorough in writing the tests, assuring that the training scale was appropriately maintained and tests are not too long or short, that they are interesting, flow well, and allow horses to accomplish the goals for each test. Maneuvers were placed where they have just the right balance between setting the rider up for success and challenging the rider. The new tests were written, then timed, tested, tweaked, and re-timed and re-tested as many times as needed. Tests were diagrammed and formatted. Then, the diagrams and the instructions on the tests were re-examined to make sure they are easy for riders and judges to interpret. The process took all year, but it was a labor of love and the committee is excited to share the new tests with you. We hope you enjoy them, share them and use them as a toolbox to make the most of your journeys with your horse/s.

Show managers may opt to offer the 2022 tests or the 2017 tests at shows between now and March 1, 2022. Prize lists for shows before March 1, 2022 will indicate which tests will be used at that show. On March 1, 2022, the 2017 tests will be officially retired and only the 2022 tests will be used at all shows after March 1, 2022.

The WDAA Executive World Show Committee is happy to announce that Jim Porcher of New Mexico will be our new 2022 World Show Manager. Here is a little introduction to Jim and his background.

I have been involved in the horse industry as a trainer and breeder since the 1970s, primarily with Arabian horses, although I have also shown and trained Morgans and American Saddlebreds, as well as open Hunters.

I have trained and shown National winners in Western Pleasure, Country English Pleasure, Hunter Pleasure, Show Hack, Halter and Working Hunters; National winners in Spain and International winners at the European World Cup.

I have been managing horse shows since 2002, starting with Arabian horse shows in New Mexico. I currently manage recognized Arabian shows around the country to include Region 8 Championships and the Arabian Sport Horse Nationals.

Currently I am the AHA Sport Horse Nationals Show Commission Chair; Vice-Director of AHA Region 8 and Chair of the Region 8 Show Commission; Vice-Chair of the AHA Hunter/Jumper Committee and the President and a founding member of the Spanish Arabian Horse Society.

I am an Arabian and Morgan judge and have adjudicated at the U.S. Arabian National Championships (twice) and the Morgan Grand National and World Championships.

I show in the Working Hunter division on my homebred Anglo Arabians. I was raised on a working cattle ranch in New Mexico; have an appreciation and respect for all areas of the Working Western horse and am honored to be invited to manage the WDAA Western Dressage World Championship Show.

2022 Show dates for the 2022 WDAA Western Dressage World Championship Show are Sept 27th-Oct 1st. and it will be held in Guthrie, OK at the Lazy E Arena, judges will be announced soon.

Important messages concerning USEF WD rules

 Presidential Modification Regarding WD130
 Lexington, Ky. – A Presidential Modification has been approved to WD130 for the 2022 competition year. The Presidential Modification clarifies the recently updated rule, *to now include* including "in the same competition year" at the conclusion of the added sentence, "To be eligible for Intro Level, a horse/rider combination must not have shown in a Western Dressage Test at First Level or above."

WD130 should be followed as written below *for the* in 2022 competition year:

1. Introductory Level. Tests provide an introduction to the discipline of Western Dressage; the horse performs only at the gaits of walk and jog. The rider may sit or post the jog. The rider should demonstrate correct basic position, use of basic aids, and understanding of the figures. The horse should show relaxation and harmony between horse and rider is important. The horse accepts the aids and influence of the rider. The jog should be a natural gait within the horse's scope and should demonstrate a swinging back. To be eligible for Intro Level, a horse/rider combination must not have shown in a Western Dressage Test at First Level or above in the same competition year.

A standard rule change is in process to make this addition permanent, but if approved it will not be in effect until 2023, if approved.
