#### Dear Friends,



One of my favorite things about WDAA is that we are never stagnant. We are constantly looking for ways to improve member services.

I am excited to say that WDAA has commissioned another Mike Corcoran Harmony Award Saddle to be awarded at the 2022 WDAA World Championship Show! To be eligible to win it, riders must earn an "8" or higher for harmony on at least one test from the WDAA Online International Challenge and at least one test from the WDAA World Championship Show. There will be a drawing for the saddle. Eligible riders will get one chance for every "8" or above earned in Harmony from the two shows.

Also, because last year's classes were so large, WDAA is making a small change in the WDAA Online International Challenge. We will be dividing the Amateur Intro classes by rider age!

If you haven't looked at the Equitation Section rules in the USEF rulebook in awhile, take a look. We have made some recent changes to clarify what the judges are looking for and to require judges to use a score system. Also, horsemanship patterns have been updated to ensure all patterns can be done inside the dressage court. We hope this will promote better uniformity of the patterns, especially in online shows. Updated patterns can be found on the same WDAA website page where the tests are.

With respect to results from our membership poll on the subject, we are working to add "open" divisions in all equitation classes. These classes will also be eligible for USEF Horse of the Year awards.

We are using the new 2022 tests, including the new Level 5 at all shows now! Exhibitors are reporting much love for the new tests which makes all this hard work extra worthwhile.

The 2022 judges' seminar in Denver was fantastic! We have a very promising crop of new judge applicants. Changes to the seminar included a new host hotel which offers a free airport shuttle, a completely reworked judges' manual, and implementation of a central management plan which included backing up all presentations to minimize technical problems. Dr. Gail Hoff Carmona shared a systematic method of assigning scores to promote more consistency between judges.

The 2021 online judges' seminar has received rave reviews and is still available to all WDAA members via our website. We will be updating the online seminar for judges who need a maintenance seminar in 2022.

I am grateful beyond words for WDAA staff, contractors and volunteers who give their all to make our dreams come true. How lucky we all are to have such amazing people in our lives!

### News concerning USEF rulebook WD102

#### WD102.8. WDAA Membership.

a. To be eligible to participate and/or compete as an exhibitor, owner, lessee, agent, coach, or trainer in any Western Dressage class or at any Western Dressage [USEF] Federation Licensed Competition persons must be active members of WDAA or pay a non-member fee equal to the price of an annual membership for each competition....



PLEASE NOTE - Lite shows are an exception to this rule, no WDAA membership is required to show at USEF lite shows (although we would appreciate it!)
