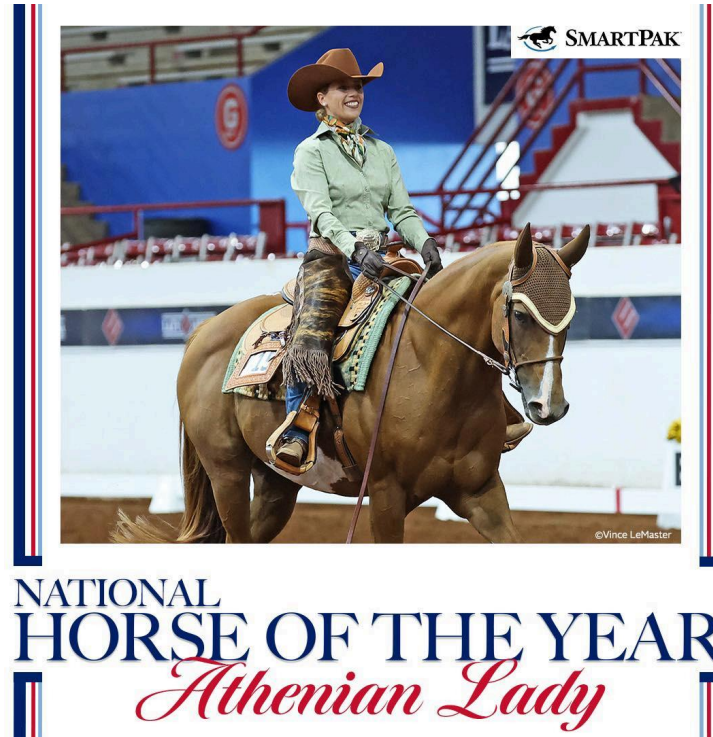

Owned by **Amanda Delgado**, Athenian Lady's selection reflects not only her consistent excellence in competition, but also the extraordinary journey that brought her there. Once a fearful, feral rescue mare found in a pasture scattered with horse skeletons, Athena's transformation is a testament to Amanda's patience, compassion, and belief in her potential.

Through years of dedication, Amanda helped Athena heal both **physically** from barbed wire scars, emaciation, and a deep digital flexor tendon injury that two veterinarians advised euthanasia for and **emotionally** building a partnership rooted in trust.

It was at the Pinto World Show that Amanda and Athena discovered western dressage, Amanda recognizing it as the discipline where Athena truly belonged. In the western dressage arena, Amanda felt welcomed, and Athena was appreciated for who she was. Rescue horses are not only welcomed in western dressage, they are valued, alongside horses of all breeds.

This achievement is a significant honor for the Western Dressage community, and WDAA extends its congratulations to Amanda Delgado and all those who have been part of Athenian Lady's journey.

An exciting new program to help celebrate Western Dressage riders!

Born into existence in 2025, this USEF program spotlights the growing discipline of Western Dressage and celebrates the correct training and equitation that goes into a successful partnership. **USEF member riders** may qualify in either a Western Dressage Seat On The Rail class or a Western Dressage Horsemanship class at a **USEF licensed show**. The final will be conducted in the format of a Combined Equitation class, with both an On The Rail section and a Horsemanship pattern, each of which totals 50% of the rider's final score.

2026 Date & Location: 2026 WDAA World Championship Show Guthrie, OK at the Lazy E Arena, September 15 last class of the day.

- The qualifying period for the 2026 Final begins on October 1st, 2025, and runs through August 31st, 2026.
- The Qualified Riders list will be published **by USEF** after the beginning of the Qualifying Period.

UPDATED WDAA Equipment & Attire Guide

Our UPDATED **WDAA Equipment & Attire Guide** is officially live and it's a HUGE upgrade from the previous version.

If you've ever had questions about tack, this guide has the answers you're looking for.

2026 Equipment & Attire Guide

The purpose of this WDAA Equipment and Attire Guide is to provide explanations, additional information and visual guides regarding the appointments (attire and tack) allowed and not allowed under the USEF Western Dressage Division. In the case of conflicting verbiage, the current USEF WD Rule Book will supersede this document.

"At Federation Licensed Competitions, the C2 Steward or the person who is under the direction of the Steward and appointed by the competition management will be responsible for overseeing the checking of the horse, tack, and attire. A horse must be eliminated from the test just completed if the horse or any tack and/or attire are in violation of the rules and/or the tongue has been tied. C2 Stewards or Equipment Inspectors are only required to inspect bits and other appointments on a minimum of one-third of the horses in a class." (See WD124)

At a non-USEF WDAA competition or a USEF Competition Lite, a designated individual must assume the responsibility of overseeing the checking of horses, tack, bits, and attire.

See separate WDAA document entitled Western Dressage Equipment Check Protocol for proper equipment check procedures in place at shows.

Horses with prohibited equipment in the warm-up ring will be eliminated from the next class they are entering unless the equipment can be corrected before the scheduled ride time for that entry. Knowing or repeated use of prohibited equipment in warmup may subject the competitor to elimination, a Warning Card or citation of a Rule Violation. See WD 128 – Elimination and GR 1037 – Recorded Warning and Yellow Cards. Horses with prohibited equipment in the performance ring will be eliminated by the judge or through the steward and show management if prohibited equipment is found during the equipment check after the ride.

WDAA Test Revisions to Date

UPDATE

- Level 1 Freestyle: 4/5/2022 Total points correction on cover page only.
- Level 2 Test 2: 3/30/2022 Movement 15 clarification that the collect jog begins at V. Changed sidepass from 4 steps to 4 strides.
- Level 2 Test 2: 5/23/2022 Changed sidepass from # of strides to go to the first quarter line.
- Level 2 Test 4: 2/15/2022 Changed sidepass from 4 steps to 4 strides.
- Level 2 Test 4: 5/23/2022 Changed sidepass from # of strides to go to the first quarter line.
- Level 2 Freestyle: 1/7/2022 Movement 10 has had the verbiage "through the jog" removed. And now states only "Simple change of lead".
- Level 3 Freestyle: 4/26/2022 Total points correction on cover page only.
- Level 4 Freestyle: 4/26/2022 Added L|R to movements 9 & 10. Removed L|R from box 11. Corrected total points on cover page.
- Level 5 Test 1: 12/10/2021 Added "Left Lead" to movement #1 to clarify the lead to take from the halt.
- Level 5 Test 3: 12/10/2021 Added "Left Lead" to movement #1 to clarify the lead to take from the halt.
- 2022 Western Dressage Equitation Tests: 11/30/2022 Tests Retired.

- 2023 Western Dressage Equitation Tests: 12/1/2022 Added using the new Walk-Jog, Intermediate, and Advanced categories.
- 2023 Western Dressage Equitation Patterns: 02/22/2023 Changed the word “test” to “pattern”.
- 2024 Western Dressage Equitation patterns: 01/18/2024 Movement #4 Lope to Halt movement changed to “Halt through the Jog.”

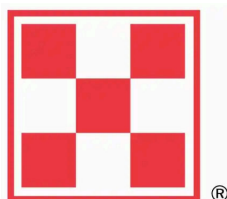
