

Go to <u>www.gaitkeeper.com</u> to enter on-line. It is easy and fast! Otherwise email the entry form. The form can be filled, saved and attached or printed, filled out and scanned into a PDF file. <u>Copies of membership cards and horse registration papers do NOT need to be sent</u> but make certain the numbers are correct and you have included 1A, etc., for Half-Arabians and CAHR or CPAR for Canadian Registry. <u>The ENTRY AGREEMENT page &</u> <u>WAIVER OF LIABILITY must be signed and submitted by all parties</u>. If there is no trainer, the owner/agent must sign both lines. The person who signs as trainer must be 18 or over. Parent/guardian signature is required on entry forms for juniors, or if not available, the trainer must sign on the minor's behalf. *(See definition of trainers and coaches in general rules)* By submitting an entry to this show, it is your intent to show and agree to our rules. You agree to pay all fees due and understand that refunds will not be made.

PAYMENT

- You can enter your credit card information on-line. Your card will be charged after your entry has been processed and confirmed. A 3% convenience fee (minimum \$5) will be added to all credit cards.
- You may pay by bank check or money order. Make checks payable in US Funds to COMSTOCK ARABIAN ASSOCIATION Checks must be received by April 16. In fairness to all exhibitors, open checks are not allowed for the initial entry. If an open check is sent, it will be closed for the amount due at the time the entry is processed and will be deposited. Postdated checks will not be accepted. Secretary reserves the right to finalize open checks.
- At the show all exhibitors will be required to leave an open check or credit card, separate from their entries at check-in, before show numbers will be released, to cover any fines or penalties incurred at the show.

CANCELLATIONS AND REFUNDS

- To encourage early entries, Management agrees to cancel and refund entry and stall fees on any horse not fit to show providing written notice is given to the Show Secretary on or before the entry closing date of <u>April 8, 2022</u>
- Refunds will be considered for any horse suffering from illness or injury upon the presentation of a veterinarian's certificate to the Show Secretary PRIOR to <u>7PM Thursday</u>, April 28, 2022, and will be subject to the Management's decision.
- Refunds will be considered for any exhibitor suffering from illness or injury upon the presentation of a doctor's letter to the Show Secretary PRIOR to <u>7PM Thursday, April 28, 2022</u>, and will be subject to the Management's decision.
- All other requests for refunds will be made in writing and submitted to Management for consideration.
- On approved refunds, such refund will include all fees less a \$50 cancellation fee.
- Substitution of horses will be permitted in accordance with USEF GR910.
- Horses may be scratched from a class or the entire show at the exhibitor's option but will not be entitled to a refund. As a COURTESY to the Gate person, Announcer and the Show Office exhibitors are requested to notify the gate person & show office when it is necessary to scratch or cancel a class entered. This courtesy will enable the Show to run more efficiently. Thank you so much!

FACILITY INFORMATION

ARENAS (SHOW AND WARM-UP) • The MAIN INDOOR Show Arena is 150' x 300'. Warm Up 90 100x200. Arenas are comprised of a mixture of native soil and sand.

- **DOGS AND OTHER COMPANION ANIMALS** are not permitted to be in Arenas, Rest Rooms, show office or loose on competition grounds and must be held on a leash or otherwise restrained in a safe place away from horses, people and other dogs at all times. Please clean up after your pet. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses, or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule will be issued a yellow warning card from the USEF Steward and may be subject to penalty.
- HAY & GRAIN is only 10 minutes away. Green's Feed, 75 Bailey Dr. Reno, NV. Call 775.323.1502 for product availability and hours of operation.
- FOOD SERVICE Food items, which includes breakfast, lunch, snacks and drinks, will be available in the Main Arena on the mezzanine Friday, Saturday and Sunday. Reno-Sparks Livestock Event Center regulations prohibit any person from bringing food and drink onto the show grounds.
- **MOTORIZED VEHICLES** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the abovedescribed motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. (01/19/2022)
- **RV/OVERNIGHT PARKING RSLEC (775)688-5752** Please call the Reno- Sparks Livestock Events Center office to reserve a spot. There are 67 fullhookup spaces and 22 partial hook-up spaces. Permits will be issued from RSLEC and must always be displayed in vehicle. A FREE dump station is located at the South End of the East lot by Gate #5. Absolutely NO dumping of gray or brown water is allowed anywhere on RSLEC grounds except at designated pedestals or the dump station.
- SHARPS CONTAINERS (needles, syringes, etc.) are available in every barn. A \$100 fine per violation will be passed on to the violator for improper disposal of needles or other medical waste.
- **SHOW OFFICE AND REGISTRATION** Registration at the Horse Show the stabling Office by the exhibitor is required. The Horse Show Office is located in the Main Arena and will be open on Thursday, April 28 at 1PM & remain open until 7PM. On Friday, Saturday and Sunday the office will be open 1 hour before start of each session through ½ hour after each session ends.
- SHOWING FROM TRAILERS Exhibitors may show from their trailers and must park in the designated parking areas. The trailer-in/grounds fee is \$20.00 PER HORSE PER DAY. Every horse is required to pay a stall fee or a trailer-in/grounds fee. Horses on the grounds overnight must be stalled.

SMOKING is never permitted in any of the Reno-Sparks Livestock Events Center buildings (stables, office, arenas, concourse etc.)


- STABLING ASSIGNMENTS Exhibitors wishing to be stabled together should complete a Stabling Form and send to the Show Secretary. Each stall is 12 feet by 12 feet with a top door and bottom door. There are 18 barns which have 24 stalls each. Exhibitors may be charged for any damage to the stalls or other facilities. Absolutely NO nails are allowed in permanent stalls or stall doors. Do not use contact cement or any other permanent adhesive to attach stall signs or drapes to the barns. Do not tie horses to water or electrical pipes. Any exhibitor found in violation will be charged accordingly for repair. Bark cannot be used for decorating. RLEC will levy a \$250 clean up fee for bark. Facility requires that stalls with horses be bedded with shavings. ** Reminder per USEF Rule GR844 All horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus rhinopneumonitis vaccinations within six months prior to stabling.
- SHAVINGS Bedding is not included in your stall fee. RSLE does not allow outside shavings or straw. Order your shavings on your entry to expedite your check-in to your stalls. Your Barn Manager is Derek Gunn. His phone number during the show for assistance with your stalls is (775) 287-1722. All shavings orders must be made (and paid for) at the show office.
- **STALL CLEANING** Manure dumping will be at the North and South corners of the show stall barn. Barrels are placed at the end of aisles for refuse. Deposit refuse directly in barrels provided. Do not mix manure and other refuse.
- TRAVEL REQUIREMENTS A Veterinary Health Certificate, Negative Coggins Test and Horse Transportation Permit are required for all horses entering into and traveling in the State of Nevada. Call the State of Nevada Division of Agriculture in Reno, Nevada for information at (775) 688-1180. ** Reminder per USEF Rule GR844 All horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus rhinopneumonitis vaccinations within six months prior to stabling.

- I-80 Heading West (from Sparks, Fernley) Use exit 14 (Wells Avenue), turn right on Wells Avenue. Turn right at Ninth Street. At the first stop light, turn left at Sutro Street. Turn left at the Livestock Events Center Entrance Gate 6.
- U.S. 395 Heading South (from Susanville) Use exit 69 (Oddie Blvd), turn right on Oddie Blvd. Turn left at Sutro Street. Turn right at the Livestock Events Center Entrance Gate 6.

Times are limited! Entries received after closing date are not guaranteed accommodation. For that matter, neither are entries received before closing date, if all times are filled. Enter early! Classes may not be scheduled in this order. Classes may be split or combined as entries warrant. However, a horse may only be entered in a class once, including "Test of Choice". Order of go will be assigned and posted in the Show office. Lower-level classes might be held in short court (20m x 40m); court size posted with ride times. Current tests will be ridden. Training devices will not be allowed in the designated dressage area at any time or in any other warm-up areas when warming up for Dressage. The designated Dressage warm-up area will be the Center/Warm-Up Arena. Dressage exhibitors must wear their entry number at all times on the show grounds when warming up for Dressage.

In Hand order of go will be assigned and posted in the Show office. Order of Go for Sport Horse In-Hand classes will ultimately be determined by the gate person aka "Lord of the Ring" with consideration to handlers presenting multiple horses. Show management reserves the right to use the Open Card system. **Protective headgear** is recommended for all handlers.

Classes at this show, this year, **will not be split by type**, but in all Sport Horse classes -- In-Hand, Under Saddle and Show Hack -- tack and appointments must match one discipline, Dressage or Hunter. Much Hunter tack/attire is legal for Dressage, but you may not mix-and-match, for example, a shanked bit and a rhinestone browband on the same snaffle bridle.

CLASS 373 - A/HA/AA LIBERTY

Liberty Rules: 1) Open to Arabian & HA/AA horses, two years old and older. 2) Horses must be shown without tack, equipment, artificial appliances or appendages. 3) A three (3)-minute time limit will be allowed for each horse to perform at Liberty. 4) No more than two (2) handlers per horse are allowed in the ring at one time. 5) Handlers will lead horse to designated marker. 6) Time and music will start when halter is removed. 7) Time will expire at the signal of the timekeeper; at this time handlers have 2 minutes to retrieve horse or it will be eliminated and no score will be given. 7) While at Liberty, the horse may perform at any gait. Horses may perform tricks within their 3 minute time at Liberty to count towards their performance score. 7) Handlers shall not touch the horse with whip or ride the horse at any time from



entrance into the show ring until after the expiration of the time limit. 8) The use of a standard halter show whip is allowed (AR114.2). 9) Horses are encouraged to exhibit Arabian presence. 10) Each entry must furnish the name of the song for their performance. The music must be identified with the horse's name, and entry number and turned in to the show office by 10 AM on Saturday morning.

GENERAL INFORMATION & RULES

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH. EACH PARTICIPANT IS RESPONSIBLE FOR KNOWLEDGE OF AND IS SUBJECT TO THE USEF RULE BOOK. THE USEF RULE BOOK IS AVAILABLE AT <u>WWW.USEF.ORG</u> THE EXECUTIVE COMMITTEE WILL DECIDE QUESTIONS NOT COVERED BY USEF RULES AND ITS DECISIONS WILL BE FINAL.

- ACADEMY HORSE Horse must be a regularly used schooling horse. Trainer/Instructor must sign affidavit verifying this. Any breed horse or pony is eligible. USEF/AHA membership requirements do not apply. Entries should be made on the separate Academy Class entry form. School horses may cross enter regular show classes at the same show. Academy Horse classes ARE NOT recognized by USEF; classes do not count for CAA Awards. Academy class horses are exempt from the Drug/USEF fee (but not the rules) if shown in Academy classes only.
- ADDING CLASSES aka "Post Entry" For the Friday Sport Horse classes, classes may be added between 2PM. and 7PM Thursday. Dressage, Western Dressage & In-Hand post entries are only allowed in the event a ride/run time becomes available. On Saturday and Sunday, entries will be closed after the last class of the session before the class is held. Horses originally entered prior to the closing date will pay a post entry "add" per class. Horses entered after the closing date will pay a flat Late Entry Fee. No post entries for classes the current session after it has started.
- AGE OF HORSES AND RIDER For horse show purposes any horse will be considered to be 1 year old on the first day of January following the actual foaling date. Horses entered in Dressage classes must be 36 months old. Junior exhibitors are those who have not reached their 19th birthday by 12/1/2021. Junior exhibitors are considered amateurs and do not need amateur certification. Please include birthdates for Adult Amateur; Junior, Leadline and Walk/Trot riders This information will be used for SPLITTING classes if necessary and determining eligibility.
- AMATEUR OWNER CLASSES Horses entered in amateur owner and junior owner classes must be registered in the name of the competitor or a member of the competitor's family, as defined by USEF Rules. Horses registered in a farm/ranch/syndicate/ partnership/corporation name may be shown in Amateur Owner classes provided the family is the sole owner of the farm or entity. The sale of a horse does not eliminate this registration requirement. Every competitor must be an amateur and the owner, or an amateur member of the owner's family. Leased horses are not eligible. (Contracts of Sale or Bill of Sale will not be accepted in Owner Classes.)
- **AMATEUR OWNER "FAMILY" DEFINITION** For ownership by the same family, the term family includes the following: spouse, parent, stepparent, child, stepchild, brother, sister, half brother and sister, aunt, uncle, niece, nephew, step-brother and sister, grandparents and grandchildren, and in-laws of the same relation as stated above.
- ARABIAN REGISTRATION Horses shown in the Arabian division must have been issued a certificate of registration from the Arabian Horse Association Registry and/or the Canadian Arabian Horse Registry or, if under one year of age, be eligible for registry, and registration applied for and must be entered under their full registered name. Half-Arabians and Anglo Arabians must be registered with the AHA Registry in the Half-Arabian and/or the Anglo-Arabian registry or be eligible for registration and registration applied for and must be entered under their full registered name.
- **ANNOUNCEMENTS** Official updates to this prize list, ride times, TBA/added classes and other announcements will be posted at https://comstockarabianassociation.com/. It is the exhibitor's responsibility to secure the most current version of posted show information. Starting the day prior to competition, announcements will be posted at the show office.
- AWARDS & RIBBONS Each judge who officiates will pin the class and present an Award to first, ribbons through fifth place in all halter and performance classes. In Junior Exhibitor Classes there will be an Award to first, ribbons first through eighth. In AHA Medal Classes Medal to first, ribbons first through eighth. In Breeding/In-Hand Championship classes, a Champion & Reserve ribbon will be presented. In classes with purse money offered, each first-place winner will receive \$50. (Double judged = total of \$100 presented). Prize money will be paid within 30 days.
- BREEDING, IN-HAND & PERFORMANCE HALTER CLASSES will follow the in-ring halter procedure and will be judged using the Arabian Comparative System outlined in the 2022 AHA Handbook and 2022 USEF Rulebook.
- **CALL JUDGE** The call judge will declare change of gait, reversal of tracking on the rail and line-up at the end of the class. Judge A will serve as Call Judge for the Morning Sessions on Saturday and Sunday. Judge B will serve as Call Judge for the Afternoon Sessions on Saturday and Sunday.
- CHANGES, CANCELLATION OR DIVISION OF CLASSES Management reserves the right to make changes of arenas, judges, or class order to facilitate time schedule and conditions for betterment of the Show. The Show Committee reserves the right to cancel, combine, or divide any classes or make any scheduling changes necessary. All changes will be posted on the Announcement Board at the office. Any performance championship that reaches 30 entries competing will be shown as a semifinal class with horses selected by the judges for final competition.
- **CHANGE OF DATE OR CANCELLATION OF SHOW** Show Management reserves the right to change the dates and/or the location of the show or to cancel the show altogether. In the event of a cancellation, all entry fees and stall fees will be refunded. Office fees are non-refundable. Neither the Show Management nor AHA will have any liability to any exhibitor, owner, handler or other person, firm, or corporation by reason of any change or cancellation of the show, except for the return of the aforementionedfees.
- CHANGE OF HANDLER OR RIDER It is the obligation of the exhibitor to notify the show office of any change in rider, driver, handler or cancellation of entry and exhibitors must fill out a handler/rider change form with correct association numbers, documentation, and signatures in the show office **prior to their class**. This also applies to **equitation horses** changed after entry has been processed. Changes must be submitted before the end of the session before the class is held.
- **COACH** is defined as an adult who receives remuneration for having or sharing the responsibility for instructing, teaching, schooling, or advising a rider, driver, handler, or vaulter in equestrian skills. That person must sign the entry and provide proof of USEF membership if coaching on the show grounds.
- **DISCIPLINE** Exhibitors are advised that any act of discourtesy or disobedience to staff or officials of this show on part of the owner, exhibitor, agent, lessee, trainer, groom, rider, driver, handler, or family of the person participating in the show, will disqualify the horse from adjudication. Management reserves the right to remove a horse or any person from the show without being liable for compensation or damages.

GENERAL INFORMATION & RULES

DISPUTES NOT COVERED BY THE RULES • Should any question or dispute arise not provided for in the governing rules of USEF and AHA, the same will be referred to the Executive Committee whose decision will be final.

DRUG AND MEDICATION RULE • Refer to USEF Chapter 4. The official Medication Report Form is now on-line at:

https://competitions.usef.org/drugs-and-meds/medication-report-form/usef. Lead line, Walk-Trot/Jog and Academy horses are NOT exempt from the Drugs and Medication rule.

- **GATE RULE/GATE HOLDS** When a gate hold is be requested by an exhibitor, such request will be made to the Paddock Master prior to the close of judging of the class immediately before the class requiring the gate hold. The reason for the request should be stated. The gate-hold will be a maximum of three (3) minutes. Appropriate warning will be given to all exhibitors if there is a gate hold in effect. AR 107.1: When horses are competing collectively, if a first horse does not enter the in-gate ready to participate within one minute from when the class is called into the ring, a warning is issued. a. Exhibitors will then have one additional minute to start the steady stream of horses into the in-gate. b. If no horses have entered the gate at the conclusion of the additional one minute, the gate will be closed, and the class is deemed concluded. c. Once the first horse has entered the in-gate, a steady stream of horses must be maintained. d. Should the steady stream be broken after the two minutes have elapsed, the gate will be closed, and judging will commence. e. A steady stream is defined as a constant flow of horses moving forward through the in-gate with a reasonable and safe distance between them (i.e., two to four horse or horse and buggy lengths in between). f. Show Management in conjunction with the Steward may deviate from this procedure as circumstances warrant. GR831.2: A starting order will be established in all classes in which horses compete individually and one minute allowed for an entry to enter the ring.
- **HEADGEAR** (GR801) Except as may otherwise be mandated by local law, the Federation strongly encourages all riders, while riding anywhere on the competition grounds, to wear protective headgear with harness secured which passes or surpasses ASTM/SEI standards for equestrian use and carries the SEI tag. (Exception hunter, jumper, or hunter/jumper competitions refer to GR801.2) It is the responsibility of the rider, or the parent or guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards for protective headgear intended for equestrian use, and is properly fitted and in good condition, and the Federation, Show Committee, Competition Management, and Licensed Officials are not responsible for checking headgear worn for such compliance.
 - *Important information for all Dressage exhibitors:* USEF Rule DR120.1.1: Helmets are required for all riders as noted in the following USEF rule From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place.
- **INCOMPLETE ENTRY FEE** may be assessed on any entry received that is illegible, incomplete, or incorrect. All required information must be clear, easily read, and correct. An entry will be considered incomplete if there are missing registration numbers; missing numbers of AHA, USEF, USDF or WDAA memberships for trainers, owners, riders, or handlers; missing signatures; missing or incorrect payment for entries.
- **LEASED HORSES** may not be shown by the lessee in Amateur Owner To Ride (AOTR) classes. The lessee becomes the bona fide owner of the horse for the period of the lease (except for Owner classes) for Federation award purposes. The horse must be entered in the ownership of the lessee and must be shown in accordance with USEF Chapter 11.
- ORDER OF GO All Breeding/Gelding In-Hand classes will be youngest to oldest, including post entries. All working western, equitation pattern classes and showmanship classes will have a posted order of go. All "orders of go" will be posted on the Announcement Board at the Show Office and given to the Paddock Master not less than one hour prior to the start of that class. Accommodations may be made by the Paddock Master in the case of class conflicts.
- **PARKING** All vehicles must be kept in designated parking areas. Trailers may be pulled to the barns to load and unload quickly. All aisles and roadways around barns must be kept open due to fire regulations. Absolutely no vehicles will be allowed in the barn aisles, including the side or front of the barns during the show. Owners will be asked to move vehicles or risk towing and/or fines.
- **POST ENTRIES** will be closed after the last class of the session before the class is held. Horses entered prior to the closing date will pay a post entry "add" per class. Horses entered after the closing date will pay a flat Late Entry Fee. Dressage, Western Dressage & In-Hand post entries are limited and only allowed in the event a ride/run time becomes available.
- QUALIFICATIONS FOR REGIONAL CHAMPIONSHIPS The rules for qualification have changed. It is so much easier to get qualified for multiple regions!! Participation at local shows for Regional classes must be obtained in the same AHA Section listed in the AHA Standard Class List. It's easy to qualify for the 2022 Championship shows. There are different rules that apply depending on the age of the horse and the particular class in which it will be shown. Riders who show in equitation or showmanship have specific rider qualifications that must be met. Read More . . .
- **RDNE (RODE DID NOT ENTER)** Any entry which shows in a class in which it was not properly entered will be charged the regular class fee plus a \$25.00 RDNE fee. To be properly entered in a class, the class must have been listed on the original entry blank or on a properly submitted Add/Scratch Form in the show office. Telling the paddock master to add an entry to a class does not constitute a proper entry and will result in an RDNE charge. Further, the paddock master is not responsible for keeping an entry out of a class that is not properly entered in it.
- **REFUNDS** Entry fees will not be refunded in the event that all or part of the competition is cancelled due to a storm, acts of God, illness, accident, or other emergency at the show. Refunds for improperly entered classes only in cases of secretary error.

GENERAL INFORMATION & RULES

- **REFUSAL OF ENTRIES** Entries may be refused from anyone who has an outstanding obligation to an affiliated club, show or contracted services. Management reserves the right to hold classes conditionally, or cancel entries of any contestant, as stated in USEF Rules. Management reserves the right to remove any horse or person from the show who has shown an objectionable attitude or behavior towards its management, or previous unsportsmanlike behavior, without being liable for compensation or damages.
- **SCORE SHEETS** If a mathematical scoring error on the score sheet is discovered, it must be reported to Show Secretary within one hour of the official posting of the scores from the last scored class of that competition day or the error will stand with no change in class placings. Please claim all Dressage test sheets and In-Hand score sheets at the awards room before you leave the show; they will not be mailed.
- **STALLIONS** Arabian stallions may be shown by junior exhibitors in any class in this show except Showmanship, Walk- Trot/Jog, Lead line and Academy classes.
- TBA "BUY A CLASS" There are only 4 slots allowed in our schedule. They will be handed out first paid first choice until all slots are filled. Contact Show Secretary to reserve your class. TBA may be sponsored for \$50 (\$100 if the class is a Championship), plus the regular class fee. TBA Championships do not include purse money. All exhibitors may enter these classes at the show without post-entry. TBA Sponsorships must be in the CAA show office by 7PM on Thursday, April 28, 2022. "TBA" Class Sponsorships will not be sold after the start of the show! Any Class on the AHA Class List or that is recognized by AHA (and can be adjudicated with the current judges panel) with the exception of Carriage Pleasure Driving, Dressage, Sport Horse In-Hand, Sport Horse Under Saddle, Cutting, Working Cow Horse, Reined Cow Horse, Working Hunter, Team Penning, Jumper or Eventing will be considered.
- TRAINER USEF defines Trainer as "the adult is responsible for the horse (care and custody) while it is on the show grounds." The parent or guardian of a minor exhibitor must assume the responsibilities of "Trainer." Therefore, every horse does have a Trainer, and that person must sign the entry and provide copies of membership cards or pay associated fees. Parents signing as Trainer for minor children are exempt from association fees. If you keep your horse at home (or board out) and pay for riding lessons, but do not pay for full time training and care, the person you pay for lessons is your "Coach".
- **UNRELATED OWNERS IN "OWNER" CLASSES** *Now in effect as of Dec. 1, 2018.* For the purposes of showing in Junior Owner and Amateur Owner classes, two non-related owners will now be able to co-own a horse and show in owner classes provided the following rules are followed. The ownership MUST be an AND relationship and not an OR relationship. No family member of a professional may enter into this relationship. "Non-family owners" are defined as two distinct individuals who are not related as family as defined by US Equestrian or Equestrian Canada. The horse must be registered with one of the five Registries in US or Canada or another approved Registry. Family members of these two co-owners are NOT permitted to show in owner classes. Both co-owners must be members of USEF or EC and hold valid amateur cards. Co-ownership is limited to two distinct individuals (no farms or business entities). A horse can only be in (1) one non-related Co-ownership per show season if a co-ownership is terminated, another co-ownership cannot be entered into for that horse until the next year. An individual can only enter into (2) two distinct non-related co-ownerships at any one time. Show management may deny horses in this relationship entry into AO/JO classes with payout in excess of \$2,500. Please see USEF AR110.4.e. for complete requirements and limitations.
- VETERINARIAN A licensed veterinarian from Comstock Equine Hospital will be ON CALL from NooN until 5PM Thursday; 7AM to 5PM Friday, Saturday & Sunday. The telephone number (775) 849-0120 will be posted in the office and in the barn. All animals are subject to physical inspection by the show veterinarian at the discretion of the Show Committee. Show Management reserves the right to refuse entry onto the show grounds to any horse exposed to, or which may be harboring a communicable disease.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals,

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

MEMBERSHIP REQUIREMENTS

USEF MEMBERSHIP STATEMENT



Life, senior active and junior active members will be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory

level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes (01/19/2022)

- Amateur Certification Only active Federation members may obtain amateur certification. Every person who has reached his/her 19th birthday and competes in classes for amateurs under Federation rules must possess current amateur certification issued by the Federation. Only active Federation members may obtain amateur certification, Amateur cards are no longer available for non-members. Any person who has not reached his/her 19th birthday is an amateur and does not require amateur certification. An amateur continues to be such until he/she has received a change in status from the Federation. There is no fee for amateur certification for Senior Active or Life Members. Refer to GR1306 & GR1307. Any Active Equine Canada member who is not a current USEF member and wants to compete in an amateur class must fill out the USEF membership application with their name, signature, date of birth and check the "Amateur" box in order to be eligible to compete. They are not required to pay for a USEF membership or a Show Pass fee. Once the application has been processed, their amateur status will then show up on the USEF website – usef.org and under Search, Membership as "Non-Member Amateur – INACTIVE".
- USEF Non-Member Participation if proper competing membership documentation is not submitted to the competition and the competition cannot verify such information, the exhibitor will be required to complete a Show Pass form and pay a non-refundable Show Pass fee of \$45.00. (GR1308.2b) Purchase of a Show Pass fee does NOT allow a competitor to show in amateur classes. To show in an amateur class, an adult competitor must provide proof of membership with amateur certification. Walk/trot only riders are exempt. www.usef.org

REMINDER: US EQUESTRIAN SAFE SPORT –All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. The competitions will be responsible for forwarding a list of the names of individuals who pay non-member fees at the competition to WDAA with the post competition report. Payment of non-member fees for the purpose of competing does not entitle the individual to any privileges of the WDAA membership. *Effective 12/1/21*.

MEMBERSHIP REQUIREMENTS

<u>USDF Membership Benefits:</u> USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the USDF Member Guide or the USDF website at www.usdf.org.

<u>Membership Requirements for USEF-licensed/USDF-recognized Competitions:</u> Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non- Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the

competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires
 or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular
 Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this
 requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity
 classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
 identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan[®]/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day. 03/20
