All exhibitors *must* be a current WDAA & WDAFL member. You DO NOT have to be a USEF member to participate in this show, with the exception of amateur riders. To ride in amateur classes, amateurs must be a USEF member and have an amateur status card. If you are not a USEF amateur, you will be placed in the Open classes. All USEF members over 18 years of age must complete the Safe Sport online classes. All USEF riders *must* have a current WDAA membership card.

"Championship Award" for Saturday <u>and</u> Sunday

Youth, Amateur and Open Division for each Level (Intro - Level 5)

To be eligible, a horse/rider combination will earn an average score of their 2 highest scores in one level, with one of the scores being test 4.

That's a possible 21 awards to be offered each day!

The HIGH-SCORE BREED AWARD is back!

If your horse fits into one of the "Breeds" that has been sponsored, you have a chance to win a beautiful award!

Bring a copy of your registration papers and sign up when you arrive on Friday. Scores will be posted, by the office, as the show progresses.

To make sure your favorite "Breed" is a part of this exciting award, become a sponsor. The sponsorship form must be sent in at least 45 days prior to the show date.

BELT BUCKLE AWARD

Sponsored by SHADY OAKS STABLES (Saturday) and CHRISTENSEN PERFORMANCE HORSES (Sunday)

We will be offering 3 belt buckles (per day) from **MOLLY'S CUSTOM SILVER** to be awarded to the highest scoring <u>Youth</u>, <u>Amateur</u> and <u>Open</u> rider in test 4. Rider may win only one buckle for the whole weekend.

Just like at the WDAA World Show, we will be offering a high score award for **"Silver Spur"** (horse/rider combination age equals 70 or more) and an **"Armed Forces"** award. (Any active, veteran, or retired military competitor). Rider must show both days to be eligible. *Please bring a copy of proof.* **ENTRIES:** All entries must be postmarked by October 15th. Correct fees, current Coggins Report and completed forms. All competitors *must* be a current WDAA/WDAFL member to show. Please add a copy of the membership card. *Entries will not be processed without full payment.*

LATE ENTRIES: must be postmarked on or before the closing date. Late entries will be accepted at the discretion of management and will incur a late fee of \$30

NONCOMPETING HORSES: must complete an entry form and waivers and pay a \$55 schooling/grounds fee plus a stall fee if needed. A negative Coggins is required.

CLASS CHANGES: must be approved by management: \$10 per change. Anyone not appearing for their scheduled ride without notifying the show office will be scratched and no refunds will be given.

STABLING: stalls and tack stalls will be assigned on a "first come, first serve" basis by receipt of entry. If the requested stall area is filled, competitors will be assigned to other stall areas. High quality permanent (12 x 12) stalls, all have full sliding doors and solid floors. Initial bedding (2 bags) is included. Additional bags of bedding available. Please preorder extra bedding on the entry form. Additional nights - \$50. All electric plugs and fans must have the proper "grounded plug".

NO REFUNDS: after the closing date. Refunds before the closing date will be issued for the amount minus the \$50 office fee. Returned checks (NSF) will incur a \$50 fee. If not rectified within 10 days, the matter will be turned over to USEF for disciplinary action.

AWARDS: Ribbons will be awarded first through sixth place. No awards will be mailed unless arrangements are made through the WDAFL secretary. A Level champion will be awarded for Sunday's show.

RIDE TIMES: Tentative ride times will be available online at wdafl.org by the Wednesday prior to the show. All ride times, including the pre-printed showbill, are to be considered tentative until noon the day before the show. Please check your ride times outside the show office, on the results board, for up-to-date times.

FOOTING and COURTS: (2) – 20m x 60m courts will be set up in a 375' x 212' covered arena with an improved clay/sand mixture. A grass area near the arena will be available for warm up and lunging.

RV HOOK UPS: 30- amp electric service and water are available on a first come-first serve basis. Please add request on the entry form.

ACCOMODATIONS: There are several hotels within 3 miles. Nearest location is just off Hwy 484 and I-75 which is south of the park entrance.

GOLF CARTS: are available for rent through Masters Golf Cars, Inc. 352-307-0111 Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license.

VETERINARIAN & FARRIER : On call – names and numbers to be posted at the office.


SHARPS DISPOSAL: containers are located in each barn.

MANAGEMENT: reserves the right to refuse, accept conditionally and/or cancel awards of prizes without claims for damages & change order of classes, cancel, split, or combine classes at its discretion if entries deem necessary.

FOOD AND BEVERAGES: located on the grounds will be available through food truck vendors.

DOGS: are welcome but must be on a leash no longer than 6', at all times. Any loose dogs will result in the owner being charged \$50 that will be donated to the local Humane Society. Any nuisance dogs will be asked to leave the grounds.

DIRECTIONS: 11008 CR 475A is the trailer entrance. <u>From I-75:</u> Exit #341, HWY 484, head east on 484 to SW 16th Ave, turn left onto SW 16th Ave. Park entrance on the right approximately 2 miles. <u>From Orlando area:</u> Take FI turnpike (tolls) north towards Ocala merge onto I-75. Exit #341, HWY 484. Head east on 484 to SW 16th Ave, turn left. Park entrance on right approximately 2 miles. <u>From Jacksonville area:</u> Follow I-10 west, US 301 S and I-75 S. Exit 341, HWY 484, head east on 484 to SW 16th Ave, turn left onto SW 16th Ave. Park entrance on the right approximately 2 miles.

A. RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of USEF as published in the USEF Rule Book and on the website at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or specta-tors; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.
