# COVID-19 PROTOCOLS AND PRACTICES

*For this show, we will be observing the following practices and expect competitors to comply with all signage and published information. Updates and additions per state, local and Federation guidelines may be added at any time and will be distributed electronically to all competitors. It is your responsibility to disseminate the information to everyone in your group.*

- California is no longer under quarantine restrictions. The following practices are encouraged.
- **Temperatures:** Everyone on the grounds is recommended to self-monitor their temperature. 100.4 F or below is acceptable.
- **Face Masks:** Face coverings are optional for those fully vaccinated. A participant may choose to wear a face mask or face covering when mounted on a horse and cannot be disqualified or penalized for doing so while competing.
- **Social Distancing:** It is recommended by the state of California to practice social distancing.
- **Hand Washing:** Do it often!
- **Show Office:** We hope to conduct as much office business as possible by text, email, or phone.
- **Spectators:** Are allowed
- **Hospitality:** Food will be available for purchase.
- **Awards:** Tests and awards will be available in the awards tent . Scores will be posted and will be available at [www.foxvillage.com/results](http://www.foxvillage.com/results).

## Equine Herpes Virus Show Requirements – Notice to ALL competitors

### Recommended best practices:

#### The Disease

Equine Herpes Virus-1 (EHV-1) is a virus that is ubiquitous in the environment and found in most horses all over the world. All equids are susceptible to EHV-1. The virus is not transmissible to humans. EHV-1 infection in horses can cause respiratory disease, abortion in mares, neonatal foal death, and neurological disease. Horses are typically exposed to the virus at a young age with no serious side effects. It is unknown what causes some horses to develop the serious neurological form of the disease. The neurological form of the disease is known as Equine Herpes Myeloencephalopathy (EHM). In this syndrome, the EHV-1 virus damages blood vessels in the brain and spinal cord causing the various neurological clinical presentations of the disease.

#### Transmission

EHV-1 is easily spread and typically has an incubation period between 2-10 days. Respiratory shedding of the virus generally occurs for 7-10 days, but may persist longer in clinically infected horses. Similar to herpes viruses in other species, the latent form of EHV-1 can reactivate at a later date, but generally with a low viral load posing a low risk of infecting other horses. EHV-1 is spread through direct horse to horse contact. The virus may also be spread indirectly through contact with objects contaminated with the virus, such as clothing, human hands, tack, trailers, feed/water buckets and wash rags. Since the size of the virus limits the capacity for airborne transmission, to distances of less than 30 feet, direct and indirect contact are the most important routes of transmission. Horses infected with EHV-1 and horses incubating the virus, shed it via nasal secretions. Horses with severe clinical signs consistent with the neurologic form most often shed large viral loads in nasal secretions and present the greatest risk for disease spread.

### **Per USEF guidelines the following requirements and best practices for biosecurity are required on entry to the showgrounds:**

- Check and record temperatures twice daily and post on stall door
- Any suspicion of illness in horses, including a temperature over 101.5°F, **MUST** be immediately reported to the show office and veterinarian.
- Immediately isolate and/or quarantine any horse exhibiting symptoms of illness
- DO NOT travel to another competition for 14 days
- Avoid animal-to-animal contact
- Do not share equipment between horses. IF YOU MUST SHARE, scrub and clean equipment with detergent and dry completely between shared use.
- **When filling water buckets, DO NOT dip the end of the hose in each bucket. Hold the hose above the water when filling.**
- Wash/sanitize hands thoroughly before and after direct horse contact
- Limit human-horse contact
- Because humans can be a means of disease transmission, avoid moving between barns unless absolutely necessary

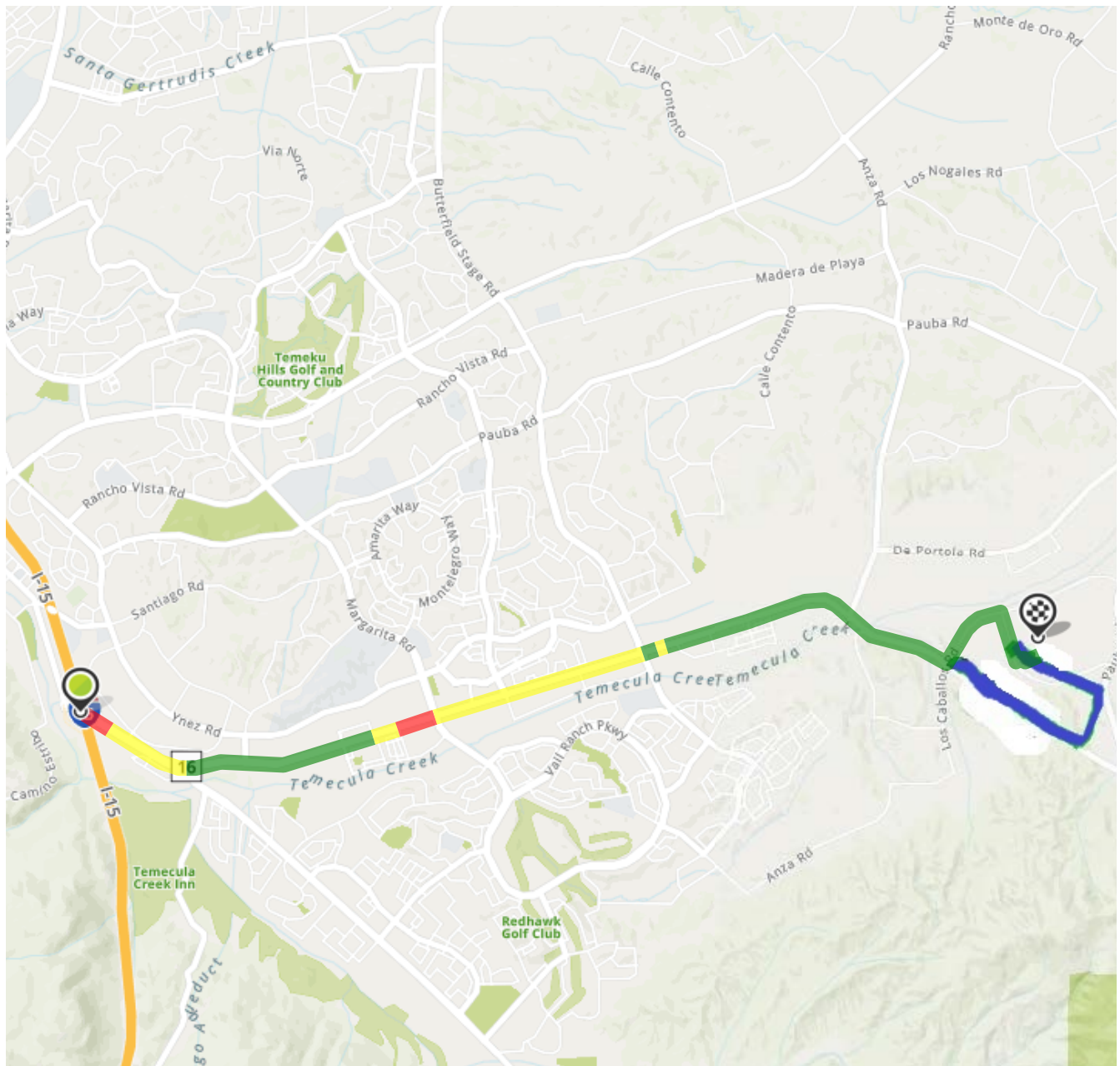

Directions to Galway Downs, 38801 Los Corralitos Rd., Temecula 92592

- From I-15 drive east on Temecula Parkway (Hwy 79 south) 5.92 miles to Los Caballos Rd, turn left. Then in 0.51 miles turn right on Los Corralitos Rd. Continue 0.32 miles (past main entrance, past mobile park) to stable gate. Turn left. Gate code is 9999#.
- Alternate route - avoids speed bumps. From I-15 drive east on Temecula Parkway (Hwy 79 south) past Los Caballos Rd about 1 mile to Pauba Rd (well marked) turn left. Drive north about 1/2 mile to Los Corralitos Rd., turn left go to stable gate 0.17 miles, turn right. This route marked in blue on map.
- Permanent stabling on the left after entering. Temporary FEI stabling to the right at the east end of the oval arenas.
- Day parking and trailer parking on the right after entering in the big open area. Please do not park trailers up close to the arena.
- RV parking adjacent to the temporary FEI barns.

## RULES AND GENERAL INFORMATION

1. EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.
2. All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.
3. Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.
4. The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries and cancel award prizes without claims for damages; to cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges.
5. Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees.
6. Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation.
7. In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided. All exhibitors and their agents are responsible for the proper disposal of this waste.
8. No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform.
9. It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitable presented to appear before an audience.
- 10. Life, Senior active and Junior active CDS Members shall be eligible to participate, A non-member may participate as a rider, owner, lessee, or agent upon payment of a \$25 CDS non-member fee. Participants in the following classes are exempted from the requirements of this rule: USDF introductory level tests, pas de deux, quadrille and Opportunity classes**
- 11. ENTRY PROCEDURE:** Entries must be made on an official entry form or photocopy of same and must be filled out completely, including all classes entered, all signatures, (no dittos), organization membership numbers and fees. **Please include a photocopy of current CDS membership ID for rider and owner.** Amateur must provide a copy of their USEF Amateur card or proof of application for an Amateur card. An Internet search *will* be done for entries missing any of the required membership photocopies at a charge of \$25. Entries are accepted on a first-come, first served basis until classes are filled. Entries received after the closing date will be accepted only if the schedule permits. Each late entry that has been accepted shall be assessed a late fee of \$50. Changes to entries (\$25 per class) after the closing date will be at the sole discretion of the show management. **No telephone** entries will be accepted. All entries must be completed and RECEIVED by the closing date with check or credit card information. **PRIOR TO THE CLOSING DATE**, entries may be faxed to 760- 758-8358 or emailed to TEVCDS@gmail.com. A 5% handling fee for credit card payments will be added. Payment in full or an open check or credit card information must accompany the entry. Mail completed entries to: E.R. Hamilton, PO Box 732, Bonsall, CA 92003.
- 12. AMATEURS AND JUNIORS:** Amateurs are defined by the rules and specifications of the current USEF Rule Book. All riders entering the Amateur classes must possess or have applied for an USEF Amateur Card prior to riding in the class. **All riders in Amateur Divisions must present an USEF Amateur Card by the closing date or they will be entered in the Open Division.** Cards may be applied for at the show office. Individuals are eligible as Juniors until the end of the calendar year in which they will be 18 years of age. **Individuals are eligible as Young Riders** from the beginning of the calendar year in which they reach the age of 16 years and until the end of the calendar year in which they reach 21 years of age. Competitors will compete as Adults from the beginning of the calendar year in which they reach the age of 22. Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22.
- 13. REFUNDS:** All fees, less a \$30 administrative fee, will be returned if horse is scratched before the Closing Date. Scratches within 48 hours after closing, stabling and drug fees will be refunded. **THEREAFTER, NO REFUNDS FOR ANY REASON.**
- 14. RETURNED CHECKS:** Checks returned by the bank for any reason are regarded as a most serious offense and will be handled according to the following procedure: A 10% penalty (minimum \$25.00) will be assessed for each returned check. Credit cards that do not go through will incur a penalty of at least \$10 for each occurrence.
- 15. ARENA:** Show arena is 20 X 60 meters. Footing consists of sand mixed with dirt and textile footing. Only those horses registered with the show management are permitted use of the show facilities, warm-up arena and show arena. All horses in the warm-up arena must wear their competition numbers. Lunging is allowed in specific areas only and upon receiving permission of the ring steward.

## **RULES AND GENERAL INFORMATION continued**

**16. STABLING, GROUNDS FEE:** Permanent stalls, cinder block construction, 12x12 stalls with Dutch doors. Temporary stalls, composite construction, center isles 10x14 stalls with bottom doors. Stalls, and grooming stalls and tack stalls \$180 (Friday thru Sunday.) If you need to arrive before Friday, or stay longer than Sunday, you must call and make arrangements (760-724-8430), extra days @ \$25. Late entry stall fees \$220 (Friday thru Sunday, adding Thursday \$50.) Grounds fee per show day of \$55 applies if not stabled.

**17. BEDDING and FEED:** Shavings and hay may be ordered on your entry or by emailing [TEVCDS@gmail.com](mailto:TEVCDS@gmail.com) or texting to 760-724-8430. No straw allowed.

**18. RV PARKING:** In temporary stable area. Please make arrangements with Galway Downs directly at [www.GalwayDowns.net](http://www.GalwayDowns.net)

**19. SHOW STATUS:** In the event of inclement weather, natural or other disasters prior to the show, it is the competitor's responsibility to contact management as to the show status. Please call 760-724-8430. **IN THE EVENT OF UNEXPECTED TRAFFIC DELAYS, it is the rider's responsibility to TEXT show management (760-724-8430) a minimum of 1 hour prior to the start of the class.** Please note that if a competitor is a NO-SHOW for ANY class, the rider forfeits his/her subsequent class reservation(s) and said slot may be given to another rider.

**20. DOGS:** Dogs must be on a leash. All animals should be managed so as to not disturb the competitors.

**21. SCORED TEST:** Tests will be distributed to riders, or their authorized representative, after the results have been finalized and awards presented. Scores will be posted when available and will be available at [www.foxvillage.com](http://www.foxvillage.com).

**22. STALLIONS:** Stallions must be in a stall or remain in the trailer unless being managed by a qualified person.

**23. SCHOOLING HORSES:** Horses not entered in the show must be registered with the Horse Show office and will be given a number to be worn at all times when not in a stall or tied to a trailer. Appropriate stall or grounds fees (\$55.00) and mandatory fees (\$66.00) per day fee must be paid. Any person(s) riding a schooling horse must have signed an official entry blank. A schooling horse may be allowed in the warm-up arena at the discretion of the ring steward.

**24. RIDE TIMES:** Times will be emailed & posted at [www.foxvillage.com](http://www.foxvillage.com) & [TEV-CDS.com](http://TEV-CDS.com). It is the exhibitor's responsibility to contact show management if times are not received. Failure to enter the arena at the specified time may incur elimination.

**25. HEADGEAR RULE:** From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds including non-competing riders, riders on non-competing horses, and those competing in all classes and tests, including Para-Equestrian tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted. If there are questions regarding this rule or the use of protective headgear at USEF dressage competitions please contact Halley Griffin by email at [hgriffin@usef.org](mailto:hgriffin@usef.org) or by phone (859)225-6918.

**26. GOLF CARTS:** and all other motorized vehicles require a valid driver's license to operate. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to Segway, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

### **27. GR845 Equine Vaccination Rule:**

- At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine 103 manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.
- In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration.



- In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration.
- In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested.

# **CDS PONY AWARD**

CDS has created a Pony Award. The high scoring pony at Training - Grand Prix (Freestyles excluded) at each CDS recognized show will receive a High Score Pony Ribbon.

The shows should:

1. Identify the high scoring pony on their CDS COVER SHEET.
2. ATTACH a copy of the USEF DRESSAGE pony measurement card.

The CDS Central Office will send out the award to the pony rider. All pony riders should inform show management that they would like to be considered for the CDS Pony Award.

To be eligible, all ponies **must** have a current USEF DRESSAGE Pony Measurement Card.

If the pony is measured at a show and receives a temporary show measurement, that measurement will be good for all CDS shows during that show season.

CDS will also offer a Year End Award to the Highest Scoring Pony in Open, Amateur and Junior Divisions.

## **Ponies**

Technical Delegates are certified to measure ponies with the USEF approved stick. Measuring must be performed by a TD, with the show veterinarian. In order to be officially measured, the pony must be entered in the competition. The owner must be a USEF member or pay a fee.

Dressage and/or DSHB competitions which offer classes or divisions limited to ponies are required to have an official measuring stick available and the TD must be on the Federation list of those approved to measure, or a licensed Steward must be present.

If classes restricted to ponies are not offered, the competitor is responsible for arranging the measurement and the cost of the on-call vet.

Adults and Juniors may show ponies in dressage. If you own a pony, read the entire section in the USEF Dressage Rules. [www.usef.org](http://www.usef.org).

CDS will accept temporary show measurements and the competitor may take that measurement form and use it for that show and any CDS show during the current show year. The USEF official DRESSAGE PONY measurement cards will be accepted as a valid card.

There are no courtesy, or trial measurements. Once the show officials place the stick on the pony, the measurement is final. Ponies must be re-measured annually until they reach the age of eight.

Your responsibility as a pony owner and or rider:

1. Know the rules. If you have any questions, call USEF.
2. If a pony class is offered at a show and your pony does not have a current measurement card, contact the show management to make sure they have an approved metric stick, and at the same time letting them know your pony needs to be measured prior to its class.
3. If you are in possession of a valid USEF DRESSAGE pony measurement card, then, simply enclose a copy of it with your entry.

## Horse Lifetime Points & Awards Program

### WDAA Horse Lifetime Points & Awards Program

The WDAA Horse Lifetime Points & Awards Program tracks points achieved by a horse throughout their Western Dressage career.

Points must be earned at WDAA recognized shows (find shows under Events on WDAA website)

Open to all horses, ponies, and mules regardless of breed, type, age, etc.

Points may be earned with more than one rider.

Owners and persons participating and/or riding a horse in the program must be current WDAA members in good standing.

Points awarded at all WD levels and Freestyle tests, as well as for rail classes.

WDAA World Championship Show test/classes earn triple points.

**USEF shows** with a USEF-licensed Western Dressage judge earn double points. Check the WD judge directory on the WDAA home page under "Important Links" to see whether your judge qualifies for double points.

- Horse Enrollment Fee: \$100
- Annual Recording Fee: \$50
- Test Submission Fee: \$10/test or rail class

## USDF 2022 Regional Schooling Show Awards Program Rules

### General Information:

1. Program year is December 1 through November 30.
2. Scores may be earned in any USDF region.
3. Late nominations, scores and applications will not be accepted.

### Rider Eligibility & Requirements:

1. Rider must have a USDF Group Membership that is recorded by the Group Member Organization (GMO) at the time the scores are earned.
2. Riders affiliated with an International GMO must declare a USDF region.
3. **There are no membership requirements for the owner of the horse and no USDF non-member fee is required. USDF Group Membership is only required for the rider.**
4. Horse must have at least a USDF Horse Identification Number at the time the scores are earned.
5. **Nominations of horse/rider combinations, along with the \$35 nomination fee, can be made at any time during the program year. The deadline to submit a nomination for the program year is December 21, 2022 (after the 11/30 end of the program year).**
6. Riders may change their division status during the program year. A rider's status will be determined at the end of the program year.
7. **Riders must submit scores through the USDF website, and they may be submitted at any time during the program year. The deadline to submit a score for the program year is December 21, 2022 (after the 11/30 end of the program year).**
8. Results submitted by competition management are only used to verify scores submitted on the USDF website by the nominee.
9. Only USDF members in good standing are eligible to compete in the USDF Regional Schooling Show Awards Program and receive awards.

### Award Divisions & Levels:

1. Four award divisions will be recognized per region:
  - a. Open: from the beginning of the calendar year the rider reaches age 22, not a USEF Adult Amateur (AA), not a non-professional.
  - b. Junior/Young Rider (Jr/YR): up until the end of the calendar year the rider reaches age 21.
  - c. AA: from the beginning of the calendar year the rider reaches age 22 and possess a current USEF AA card.
  - d. Non-Professional: from the beginning of the calendar year the rider reaches age 22, not a current USEF AA, not a professional.
2. Seven levels (freestyle, pas de deux and quadrille not included) will be recognized per division. Exception: only 6 levels are recognized in the open division:
  - a. Introductory (only in Jr/YR, AA and non-professional divisions)
  - b. Training
  - c. First
  - d. Second
  - e. Third
  - f. Fourth
  - g. FEI – combination of Prix St. Georges, Intermediate I, Intermediate II and Grand Prix scores.

3. Equivalencies listed in the current *USDF Member Guide* are eligible. Tests not listed as equivalencies will not be eligible.
4. Preliminary standings will be ranked using a median of all eligible scores and will be available on the USDF website.
5. Final awards standings will be based on the rider's region of primary residence in the USDF database as of November 30.

### **Score requirements:**

1. Introductory Level:
  - a. Must have a minimum of **three** scores
  - b. From **two** different judges
  - c. From **two** different competitions
2. Training through Fourth Levels (levels may not be combined to meet requirements):
  - a. Must have a minimum of **three** scores
  - b. From **two** different judges
  - c. From **two** different competitions
  - d. At least one score must be earned from the highest test of the level
3. FEI Level (levels may be combined to meet requirements):
  - a. Must have a minimum of **three** scores
  - b. From **two** different judges
  - c. From **two** different competitions

### **Prizes:**

1. Up to ten placings per division/level will be recognized.
2. Ribbons will be mailed to the rider.
3. Certificates will be available online.

### **Competition Management Requirements:**

1. Any non-USEF-licensed/non-USDF-recognized competition may participate.
2. To participate, competition management must submit online application and \$25 participation fee to USDF at least 30 calendar days prior to the start date of the competition.
3. The prize list must be submitted to USDF no later than 14 calendar days prior to the competition.
4. Competition management is prohibited from charging competitors a fee for their scores to be eligible for the USDF Regional Schooling Show Awards Program.
5. Competition judges must be one of the following:
  - a. Current USDF L Graduate, with or without distinction, which has met USDF continuing education requirements and Safe Sport training.
  - b. USEF or retired FEI dressage judge.
6. FEI classes must be judged by USEF or retired FEI dressage judges or USDF L Graduates with distinction.
7. Competition arenas must be in compliance with US Equestrian DR126 for level 1 competitions.
8. All classical dressage scores must be submitted to USDF regardless if competition management was provided with USDF numbers for the riders and/or horses.
9. Competition results must be submitted to USDF as a .dat or excel file via the USDF Electronic Results Submission Standard (ERSS) format (using the USEF Universal Spreadsheet Template) or the simplified blank results template provided on the USDF website by no later than 21 calendar days from the end date of the competition.
10. A \$25 fee will be assessed for late competition results.
