USDF Membership Benefits: USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the USDF Member Guide or the USDF website at www.usdf.org.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.) Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary. Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.

Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined:

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF- licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program. Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.


Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- •On the USDF website: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.
- •In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

GOLF CARTS: Golf cart rentals will be handled through Brad's Golf Cars @ 336-595-2006. Arrangements for golf cart reservations are 100% between Brad's Golf Cars and the Exhibitor. If golf carts are not preordered, Show Management cannot guarantee one will be available at the show. The maximum number of passengers on a golf cart should NOT exceed the number of seats.

SHOW RULES AND REGULATIONS

Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith. It is the exhibitor's responsibility to submit entries that do not constitute a violation of USEF GR1304.

Management reserves the right to change or alter the officials listed.

The show will be under the absolute control of Management. Only qualified persons shall be allowed in the ring during judging. Exhibitors are notified that any act of discourtesy or disobedience to the judge or officials on the part of trainer, owner, rider, or groom will disqualify horse or rider and the owner shall forfeit his entry fees and other fees.

The Southern States Regional Morgan Horse Show, or its agents and employees, will not be responsible for any loss or damage that may occur, and it will be a condition of the entry that each Exhibitor shall hold the Horse Show and the NC State Fairgrounds blameless for any loss or accident to his or her horse, horses, or equipment that may occur from sickness, fire, or otherwise. Nor shall they be responsible for any article of a kind or nature that is lost destroyed or stolen; and will not be responsible for or liable for injury sustained in any way to exhibitors, spectators, employees, or any other interested parties. All owners and exhibitors will be held responsible for any damages, incurred by them or their agents to barns or other properties on the Show Grounds and will be BILLED ACCORDINGLY. All trainers, owners, exhibitors and agents will be held responsible for any damages, incurred by them or their agents to barns or other properties on the show ground and will be billed accordingly. The NC State Fair will be checking for this during and after the show. Damages include but not limited to nails, fasteners, staples boards.

STALLIONS may not be entered in classes which specify Ladies or Junior Exhibitors to ride or drive.

JUNIOR EXHIBITORS are those who had not reached their 18th birthday as of December 1st of the year preceding the show.

AMATEURS

AGE. Amateur rider/driver must be at least 18 years old. (USEF GR103.)

CARDS. Every person who competes in classes for amateurs under Federation rules must possess a current amateur certification issued by the Federation and send a copy with their entries. See USEF GR1306 or GR1307. All exhibitors in Classic Pleasure classes and Saddlebred pleasure classes (except Park Pleasure) are required to have amateur certification.

ARENAS, WARM-UP RINGS & EXERCISE AREAS

Turnout is not allowed in any arena or round pen. Ring availability, quiet time, and live time will be posted and a schedule will also be available at the show office.

Main Performance Arena: 138'x248'; footing is a dirt base with sand and sawdust mixture on top

Covered Arena, Warm Up Arena/Paddock: 120'x240"; footing is a dirt base with sand and sawdust mixture on top

Work Ring: 120'x480'; Stone dust footing

<u>Sport Horse Arena I</u>: 120'x240'; Sand/Stone dust footing <u>Sport Horse Arena II</u>: 300'x400'; Stone dust footing

During show sessions, the covered warm-up arena will be available only for the next class to show in the Indoor Show Arena. Lungeing is not allowed in any of the warm-up arenas while the show is in session and is not allowed at any time in the Main Performance Arena.

ARRIVALS & DEPARTURES

IMPORTANT: The show grounds are available for arrival on Monday, May 23, at 7:00 am, preceding the show and must be vacated by 12:00 noon on the Monday after the show. There may be stalls available for those exhibitors needing early arrival. **Arrangements must be made with the Show Manager as early as possible and no later than two weeks prior to the Monday preceding the show. There will be a charge of \$20 per stall.** All stalls must be vacated by 12 noon the day following the show unless other arrangements have been made with the Show Manager.

ARTIFICIAL APPLIANCES

Boots and other artificial appliances are forbidden in the Morgan division except in Reining, Roadster, and Jumper classes where boots are permissible. Protective bell boots, splint boots, or quarter boots may be used in designated training areas; however, care must be taken to see that they comply with the Horse Protection Regulations as revised in 1989. Rubber or elastic (except on boots) attached in any way to the legs or hooves shall not be used on the competition grounds at any time. Vertical half-cup blinkers are acceptable on the show grounds and in the warm-up ring. Blinders of any kind are not allowed.

ATTENTION-GETTING DEVICES

Attention-getting devices and/or other noisemakers (including but not limited to tape measures, blow horns, altered bamboo poles, explosives, etc.) are not allowed in and around the makeup/schooling/warm-up and competition rings during the scheduled competition sessions. Use of explosives and fire extinguishers by or for exhibitors/competitors (except in the case of fire) are not allowed on competition grounds at any time.

CAMPER HOOKUPS

Available through the NC State Fair Security Office on a first come, first serve basis. **Note: Any vehicle** connected to electricity and/or water will be considered a camper and will be charged the camper fee.

DOGS

Will not be allowed on the show grounds unless restrained on a leash and under control of the owner or responsible person at all times. Dogs will not be allowed in the restaurant at any time.

ENTRIES

Entry Blanks must be signed by owners and/or owner's agent; by the trainer; by each rider, driver, or handler; and by the coach (if applicable). If the owner or exhibitor is under 18 years of age, the entry blank must be signed by a representative who is of age and who accepts responsibility and risk as stated above the signature. **ONE owner per entry blank.** All fees must accompany entry blanks.

Copies of membership cards and registration papers must be submitted with entries.

IF REQUIRED DOCUMENTATION IS NOT SUBMITTED WITH ENTRIES, A \$10 LOOKUP FEE PER HORSE WILL BE ASSESSED.

Entries must be postmarked by **April 19, 2022.** Entries received after the closing date will be accepted with a post-entry fee of \$30 per horse.

Management reserves the right to cancel a class if entries are insufficient or to combine or divide a class and to reschedule any divided class. Management reserves the right to decline any entry and to return any entry fee before or during the show with- out being liable for compensation. Management reserves the right to decline entry to the show grounds to any horse not entered in the Horse Show.

Entry adds and scratches must be made one hour prior to the scheduled start of a session to avoid a late fee.

The Horse Show requires that a signed open check be placed in the show office before any numbers are released. It is the responsibility of each exhibitor or agent to settle his or her account by the end of the Show. Failing to do so, the Horse Show Secretary will fill in the correct amount on the open check and the exhibitor or agent relinquishes the right for adjustment after leaving the Show.

Horses must be entered and shown under the name of the recorded owner or lessee.

GATE HOLDS

A two minute gate hold will be in force throughout the show. Requests for holds will be granted only by the Show Manager, and only in cases of back-to-back classes and must be requested prior to the start of the session. All holds will be limited to two minutes. Exhibitors are to report scratches to the Secretary as early as possible. A FEE OF \$10 PER CLASS WILL BE ASSESSED ANY EXHIBITOR WHO FAILS TO NOTIFY OF A SCRATCH PRIOR TO THE CLASS.

HEALTH REQUIREMENTS

The Southern States Regional Morgan Horse Show requires all horses, including in- state horses over 9 months old, be in possession of a current (within 12 months) negative Coggins test. Any horse on the grounds that does not have a current negative Coggins will have to be removed from the grounds immediately. NO EXCEPTIONS. Each exhibitor must provide two copies. A COPY MUST BE MAILED WITH ENTRIES AND A COPY MUST ALSO BE PUT IN THE HOLDER ON FRONT OF THE STALL FOR INSPECTION BY THE NC STATE VETERINARIAN.

Health Certificates are not required for horses coming into NC for less than 30 days. For specific questions, contact Rollins Diagnostics Lab in Raleigh, NC: 919-733-7601.

At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within 6 months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds. Copies of documentation must be submitted with entries.

MOTORIZED VEHICLE STATEMENT

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. Failure to comply will result in possible fines, forfeiture of the ability to participate in the competition, forfeiture of entry and other fees, possible issuance of warning cards and the potential removal from the competition grounds.

OPPORTUNITY CLASSES

Classes are open to all breeds and riders. No USEF memberships or non-member fees are required. However, if the rider is a member of USEF or the horse has been issued a USEF Horse ID number, those numbers must appear on the entry blank. Exhibitors are exempt from the USEF Drug Fee if showing only in the Opportunity division.

PREMIUMS

All premium money will be mailed to the owner of the horse within 30 days after the completion of the show and becomes non-negotiable after 60 days. It is imperative that the correct full name and address of the owner along with the name assigned to the Social Security # or Federal ID # submitted be on the entry blank. In addition, if the owner of the horse is a corporation, please include that information. No prize money will be mailed unless all required information is provided. A trophy and six ribbons will be awarded in classes except as noted in certain championships.

REFUNDS

All entry and stall fees will be refunded on request before the closing date of entries. After this date, refunds of entry fees will be made due to bona fide casualty to horse, exhibitor, or exhibitor's family provided cancellation and appropriate certificates are received no later than the first day of the show. Office fees will not be refunded. No request for stall refunds will be honored after May 19, 2022. All scratches must be made one hour prior to the start of each session to avoid late fees and receive credit for scratches.

In the event all or part of the competition is canceled due to a storm, accident or other emergency prior to May 19,

2022, all fees, including stall fees will be refunded in full, minus the office fee. If classes are canceled once the competition has begun, entryfees for remaining classes will be refunded. No stall fees will be refunded.

SHOW OFFICE

The show office will be open on Monday, May 23, from 1 p.m. to 6 p.m.

On Tuesday, May 25, the office is open from 9 a.m. to 6 p.m.

Show days, the office will open at least one hour before the session begins and close at the end of the evening session.

The office will NOT be open on Sunday, May 29.

SMOKING

Smoking is not allowed in State of North Carolina owned facilities which includes the show arena and barns.

STALLS

Permanent stalls with doors are available on Monday, May 23, at \$125 each for the duration of the show. Early arrivals will be charged a \$20 per stall, per day, and must be approved by Horse Show Manager in advance. Initial bedding will NOT be provided but will be available on the grounds. Exhibitors who do not require stabling may show out of vans or trailers at a grounds fee of \$25 per horse for the duration of the show. This includes non-showing horses. **Bedding may be ordered with entries and will be delivered to your stalls before you arrive.** Commercial delivery of shavings is not allowed. Any outside vendors hauling feed or bedding will be charged a vendor fee of \$300. The Show Manager will assign stabling possessing knowledge of history and location on an annual basis with careful consideration for the efficient use of the total available stalls.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

FEDERATION ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the SOUTHERN STATES REGIONAL MORGAN HORSE SHOW (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply withthe U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. Persons who are not in good standing with AMHECT, AMHA or any Regional Show may not participate in this show, whether as an exhibitor, owner, trainer or otherwise. This policy includes all horses registered in the name of any such person, whether leased or under contract for sale. Procedures have been established to resolve any disputes concerning accounts with AMHECT, AMHA or any Regional Show.

CARRIAGE DRIVING SECTION

Classes in this section may be divided for novice horses or drivers if entries warrant. See USEF Chapter Division CP (Carriage Pleasure Driving) Rules for class descriptions and judging specifications. If there is a driver change it is the driver's responsibility to notify the show office and obtain a separate entry number. Carriage competitors will compete for the Southern States High Point Carriage Horse title featuring the Carriage Driving Single Horse Champion Trophy. WESTERN DRESSAGE DIVISION

NEW FOR 2022: A USEF/WD rule change went into effect December 1, 2021, concerning the requirement for WDAA memberships at USEF-licensed shows offering western dressage classes. Previously, USEF WD rule 102 provided an exception for breed shows to require exhibitors, owners, and trainers to be members of Western Dressage Association at their shows that include a western dressage section or classes. This exception has been removed from the rule, which means that breed shows must now verify WDAA memberships for exhibitors, owners, and trainers. Non-member fees from individuals who are not members of WDAA must be paid at the show, including \$35 for adults and \$25 for juniors (junior members as defined by USEF Rule GR128), which are forwarded to WDAA after the show with a report of all fees collected.

Classes are open to all breeds and riders. Please refer to the current USEF Rule Book Division Chapter WD (Western Dressage) for rules and regulations. High SCORE award will be presented to the horse with the highest scoring ride in each of the following: Intro, Basic, Level 1, Level 2 and Level 3. Horses enrolled in WDAA Horse Lifetime Points & Awards Program earn double points.

RANCH HORSE PLEASURE SECTION

- The purpose of Ranch Pleasure should reflect the versatility, attitude, and movement of a working horse. The horse's performance should simulate a horse working outside the confines of an arena and that of a working ranch horse. This class should show the horse's ability to work at a forward, working speed while under control of the rider. Light contact should be rewarded and the horse shall not be shown on a full drape of reins. The overall manners and responsiveness of the horse while performing the maneuver requirements and the horse's quality of movement are the primary considerations.
- Horses should NOT perform or be rewarded for performing gaits as they do in Western Pleasure. The horses
 are to be presented in a more forward-moving style than thetypical Western Pleasure Horse. The horse and
 rider will be scored on movement, which is cadence and rhythm of gaits, smoothness and consistency in
 performance, along with how they perform the optional maneuvers.
- Each horse will work individually, performing both required and optional maneuvers, and scored on the basis
 of 0 to 100, with 70 denoting an average performance.
- The required maneuvers will include the walk, jog, and lope both directions; and the extended jog and extended lope going at least one direction; as well as stops, and a back. Optional maneuvers are side pass, turns of 360 degrees or more, change of lead(simple or flying), walk, jog or lope over a pole(s); or someone combination of maneuvers that would be reasonable for a ranch horse to perform.
- The overall cadence and performance of the gaits should be free-flowing and ground covering at all gaits, with an emphasis on forward movement. Transitions should be performed where designated, with smoothness and responsiveness.

ACADEMY DIVISION

- Open to all breeds. Academy horses are exempt from the USEF drug fee and riders/owners are exempt from the USEF non-memberShow Pass fee.
- Riders in this division are students who are enrolled in a professionally operated program and are to be judged on their basic riding skills. Riding suits are NOT allowed; jodhpur boots and pants are suggested. All age riders are encouraged towear helmets but they are MANDATORY for riders 12 & Under.
- Riders may NOT cross enter into any performance classes with the exception of driving classes. A rider who
 has shown in a regular division class or in a full riding suit is prohibited from further participation in the
 Academy division with the EXCEPTION of Academy Show Rider Classes.
- Horses are to be lesson type horses and must display the characteristics of such. A rider may show his/her
 horse as long as the horse is regularly used in a lesson program. Horses must not be in training. Horses may
 be shown in a snaffle bridle with martingale or a Pelham/full bridle. Blinkers not allowed in under saddle
 classes. Flatcutback English saddles are to be used. Hoof blacking is optional and ribbon braids are NOT
 allowed. HORSES ARE NOT TO BE JUDGED.
- Over-mounting of riders WILL be penalized.
- Horse is to be tacked as if giving a lesson. Any leverage bit rein is PROHIBITED through the martingale.
- Classes will split into further age groups if numbers warrant so rider age should belisted on entry blank.
- Classes may be combined so there are no 1 horse classes.
- Horses deemed to be a danger will be eliminated by authority of Horse Show Management and/or the Paddock Master.

2022 SOUTHERN STATES MORGAN HORSE SHOW SHOW SAFETY AND SECURITY RULES

All persons on the competition grounds must comply with all safety rules and procedures. Failure to comply may result in, suspension/halting of overall competition, fines, issuance of warning cards, forfeiture of the ability to participate in the competition, forfeiture of entry and other fees, and/or removal from the competition grounds. Show Management reserves the right to remove anyone from the competition grounds for any unsafe actions, illegal behavior, or failure to comply with any safety rules/procedures at the Show Manager's, Steward's, or Safety Coordinator's discretion.

- Anyone participating in the competition (rider, trainer, owner, volunteers, and officials) are required to complete a show specific general liability waiver form prior to participation.
- All dogs/pets must always remain on a leash anywhere on the competition grounds. Dogs/pets are not allowed in any food service or serving area. Failure to comply will result in a \$100 fine, forfeiture of the ability to participate in the competition, forfeiture of entry and other fees, possible issuance of warning cards, and potential removal from the competition grounds. All dogs/pets must have current inoculations for rabies as prescribed by the state of residency. Show management reserves the right to remove any dog/pet from the competition grounds at any time.
- Dogs/pets must not be left unattended in vehicles and/or trailers. Failure to comply will result in an issuance of warning cards, potential forfeiture of the ability to participate in the competition, forfeiture of entry and other fees, fines, potential removal from the competition grounds, and reporting to local animal control/law enforcement.
- All local and state adopted fire safety codes and regulations must be followed. This includes ensuring adequate ingress/egress ability (minimum 4' path), exits are not blocked, use of flame-resistant draping, approved electrical cords and appliances are utilized appropriately, electrical circuits are not overloaded, utilization of fire watch, etc.
- Fireworks and/or explosives are not allowed on the competition grounds.
- Smoking and vaping are prohibited in the show arena, warm up arena, and inside the barns. No outdoor burning or campfires will be allowed on competition grounds.
- Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles if they are accompanied by an adult with a valid driver's license. Failure to comply will result in possible fines, forfeiture of the ability to participate in the competition, forfeiture of entry and other fees, possible issuance of warning cards, and potential removal from the competition grounds
- The maximum number of passengers on a golf cart should not exceed the number of seats.
- Non powered/powered scooters, bicycles, skateboards, in line skates, and heelers (skates in shoes) are not permitted in the show arena, warmup arena, or the interior of any barns.
- Anyone involved in damaging/destroying property, stealing property, communicating threats, conducting acts of violence, assault/abuse (physical, emotional, verbal, sexual), stalking, harassment, disorderly conduct, animal cruelty, or any other illegal activities will be removed from the competition grounds and prosecuted to the fullest extent of the law.
- Any act of discourtesy, disobedience, bullying, harassment, retaliation, slander, or unsportsmanlike conduct to the judges, officials, show management, show staff, or other participants, on the part of an owner, rider/driver, trainer/agent, attendee, or groom will disqualify horse or rider/driver.

Failure to comply will result in possible fines, forfeiture of the ability to participate in the competition, forfeiture of entry and other fees, possible issuance of warning cards, and potential removal from the competition grounds.

- Unattended children, excessive noise, running, or other actions that may disrupt competitors is not allowed in the competition arena. Parents/guardians must always maintain supervision of their children while inside the arena and ensure they remain seated and are not disrupting the competition or competitors. Children under the age of 12 are not allowed along the rail.
- Individuals under the age of 21 are not allowed possess and/or consume alcohol. Anyone under the age of 21 caught in possession will be immediately reported to law enforcement and removed permanently from the competition grounds. Any adult 21 or older caught providing alcohol to an individual under the age of 21 and/or knowingly allowing them to consume alcohol will result in forfeiture of the ability to participate in the competition, forfeiture of entry and other fees, possible issuance of warning cards, reporting to law enforcement, and removal from the competition grounds. Show management reserves the right to verify age by checking the identification of any individual in possession or believed to be in possession of alcohol on the competition grounds.
- Anyone who is under the influence of alcohol, or a controlled substance are prohibited from operating a motorized vehicle, riding/driving a horse, or participating in the competition while they are in an impaired state that may endanger themselves or others.
- Show management reserves the right to remove any individual from the competition grounds and involve law enforcement (as needed) who appear or are found to be under the influence of alcohol or a controlled substance at any time.
- Anyone entering the competition grounds must agree to following all COVID-19 safety policies. The competition will adhere to any local, state, and federal requirements related to COVID-19.
- No parking will be allowed in the barn area, in an area that impedes the flow of vehicular or pedestrian traffic, in any area designated as a fire lane, and/or blocking a manure pit or trash receptacle. Motor vehicles must park in appropriate designated areas and follow all traffic safety laws on the competition grounds. Show management reserves the right to tow any vehicle improperly parked at the vehicle owner's expense.
- Sharp containers are provided in convenient locations throughout the barns for the disposal of needles, medical waste, and other disposable sharp instruments. Failure to comply will result in a \$100 fine, forfeiture of the ability to participate in the competition, forfeiture of entry and other fees, possible issuance of warning cards, and potential removal from the competition grounds.
- Any loss, theft, accident, injury, damage to personal property, or illegal activity should be reported to the show office/management immediately.
- Show management and officials reserves the right to suspend competition temporally or permanently during any event that may impact the safety, security, health, and the general well-being of participants on the competition grounds.
- Lost and found will be located in the show office.


