## **General Information:**

- \*Entries still must be mailed with payment for each show by closing date provided on entry form for your video to be judged. There will be NO LATE ENTRIES. Due to the process of making this work, entries must be received by the closing date, please plan ahead.
- \*The participant is responsible for uploading their video to YouTube and emailing the viewable link to cmhadressage@gmail.com no later than September 11, 2023!
- \*Depending on the amount of entries the judging will completed as soon as possible. Once results are received back from the judge, scores will be posted on the website and tests and ribbons will be mailed to each participant. Please expect about 2 weeks after the show date for tests to be mailed.

Tests and awards will be returned by mail as soon as they are received back from the judge and scored.

Please follow the guidelines provided below for each test you wish to ride for the video to be judged.

- \*To make things easier and quicker for our judges they have asked that all intro, training and basic level tests be ridden in the small area. All first level or level one and higher should be ridden in the large arena. Please be sure to make sure that letters are large and easily seen.
- \*All videos must be recorded in one continuous loop, any videos with editing present will be disqualified. Videos must be filmed in landscape orientation.
- \*All videos must be videoed from "C" where the judge would normally sit and the entire horse and rider must be kept within the frame, slight zooming is encouraged when the team is at the far end of the arena but please keep surrounding letters in video.
- \*The volume must be on, and normal, natural background sounds must be heard. No musical background or coaching is permissible and will be grounds for disqualification. \*A reader of the test is permissible.
- \*Prior to beginning the test the camera person must video the show sign (will need a separate one for each test) that can be found on our Facebook page or website. The test can begin once this information is recorded. Following the last salute the rider will proceed to "C" and the camera person will walk a circle around the mounted rider and horse to show proper equipment and attire. The rider will then dismount, remove the bridle and show the bit before the video ends following WDAA online show guidelines.
- \*Show clothes are not required but appropriate boots, spurs and helmet or western hat are required. However, all western dressage riders must follow USEF WD rules for showing attire. The horses tack must be appropriate to seat ridden.
- \*You may not use the same video for multiple shows; each show requires a new video.
- \*Videos must be uploaded to YouTube and a link emailed to <a href="mailto:cmhadressage@gmail.com">cmhadressage@gmail.com</a> no later than September 11, 2023.
