Payments accepted via check made to Xanadu Farms, Entry forms will be accepted on a first come, first served basis with a limited number of rides available. Rides per entry must be from two consecutive levels. Please include a copy of the current Coggins test and shot record.

Stabling: Is on a first come first served basis. There is a VERY LIMITED AVAILABILITY. Submitting a paid entry is the only way to guarantee a stall. However, 'jump outs' are allowed.

<u>Scratches & Cancellations:</u> Scratches and cancellations made before the closing date will be refunded. No refunds or credits will be made after the closing date.

Awards: Ribbons will be awarded for 1st-6th place. USEF/WDAA rules will be followed regarding tack, headgear, etc.

Acceptance: Making an entry online, agrees to acceptance of the rules.

RELEASE, ASSUMPTION OF RISK, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

*This document waives legal rights. Read it carefully before signing. "STABLE" hereafter refers to any owner and affiliated person with Kramer Stables and Xanadu Farm.

I AGREE for myself, and/or my child, my/our administrators and assigns, in consideration for my, and/or my child's, participation in this STABLE's activity to the following:

I AGREE that I choose to participate voluntarily in an STABLE activity, as a rider, driver, handler, lessee, owner, agent, spectator, volunteer, and/or trainer. I am fully aware and acknowledge that horse sports and this STABLE's activities involve inherent dangerous risks of accident, loss, and serious bodily injury including, but not limited to, broken bones, head injuries, trauma, pain, suffering or death ("Harm"). I fully understand that this release covers, but is not limited to, inherent risks of an equine activity which mean a danger or condition that is an integral part of an equine activity, including but not limited to, any of the following:

- The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals;
 - Hazards, including, but not limited to, surface or subsurface conditions;
 - A collision with another equine, another animal, a person, or an object;
- The potential of an equine activity instructor to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

I AGREE to release this STABLE, its successors or assigns, officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations from all claims including, but not limited to, claims for money or property, disability, covenants, actions, suits, causes or action, obligations, debts, costs, expenses, attorneys' fees, judgments, orders and liabilities of

whatsoever kind or nature in law, equity or otherwise, whether now known or unknown, suspected or unsuspected, and whether concealed or hidden, including but not limited to any state or federal statutory or common law claim or remedy of any kind whatsoever arising out of or in any way connected with any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of this STABLE or this STABLE's activity.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of this STABLE or this STABLE's activity, and specifically agree to the applicable state statute/law regarding equine/farm animal activity liability and signed posting (if any), in any state in which I or my child participates in this STABLE, or related activity.

I understand under Missouri law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to the Revised Statutes of Missouri, (Missouri Revised Statutes, Section 537.325).

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) this STABLE and this STABLE's activity and to hold them harmless with respect to claims for Harm to me or my horse, and my guest's and for claims made by others for any Harm caused by me or my horse in this STABLE's activity.

I AGREE that neither I, nor any one claiming through me, will hereafter bring, commence, prosecute or maintain, or cause or permit to be brought, commenced, prosecuted or maintained, any suit or action, either at law or in equity, in any court in the United States or in any state thereof, or elsewhere, against the STABLE, its successors or assigns, for, on account of, arising out of, or in any way connected with any Harm to me or my horse, and that neither I, nor anyone claiming through me, will enforce, prosecute, or recover upon, or attempt to enforce, prosecute, or recover upon, any claim or right of action whatsoever, which I, or anyone claiming through me, may now have or hereafter assert, in any way connected with claims for Harm to me or my horse, and for claims made by others for any Harms caused by me or my horse at this STABLE's activity.

FURTHERMORE, I AGREE that I release this STABLE and AFFILIATES from all liability related to the use of equipment, tools, implements and facilities I may use, including but not limited: pool, utvs, atvs, tractors, mowers, weed eaters, trampoline, vehicles and all other farm and recreational items. I use and participate in these activities of my own free will and take full responsibility for any consequences of such.

I AGREE this Agreement is the entire agreement of the parties, and supersedes all prior oral and written understandings and agreements. This Agreement may be modified only by a written amendment signed by both parties. This Agreement does not expire and is considered valid in perpetuity.

I AGREE that if any provision of the Agreement is found to be invalid or illegal by a court of competent jurisdiction, the remaining provisions shall be construed as if the affected provision had not been included in order to effectuate the intent of the parties. In the event this form is signed by the parent/guardian of a child, then all representations and acknowledgements herein are expressly made by, for, and on behalf of the parent/guardian and child.

RIDING HELMETS ARE REQUIRED FOR ANYONE 18 years of age and under.
