PGHA Year End Award Eligibility:

- Be a SHOWING member in good standing
- Exhibit a NOMINATED horse
- Work a minimum of ten (10) Volunteer Hours
- Show in four (4) shows within the current show season- 50% plus one (1) judge/show
  - Must have six (6) scores in same Level
  - Can qualify in multiple levels BUT Levels must be concurrent (Basic and Level 1 for example)
