## **ENTRIES**

Accepted on first come, first serve basis by mail ONLY. One entry per horse/rider combination. Opening date is April 6<sup>th</sup>, 2024. Closing date is April 20<sup>th</sup>, 2024.

**Review entry cancellation policy before submitting entry**

**MAIL ENTRIES:** Complete entries with signatures and payment. (Incomplete entries will not be accepted)

***A \$50 NSF fee will be charged for all returned checks.***

**Entry Cancellation/Refunds:** Office fee is not refundable. Entries with written cancellation on or before the closing date will receive 100% refund of class fees minus the \$25.00 office fee.

**NO REFUNDS after Closing Date** even if original Closing Date is extended. Entries must be received by 6:00 pm on the Closing Date.

**Ride Times:** Ride times will be sent by email and will also be posted on our Website at <http://www.wdaaz.org>. Email address on your entry form must be valid and legible. Due to the nature of this show, in which Joyce Swanson will judge your ride and then your test will be reviewed by Cliff Swanson, we will not be able to adjust ride times. We will be allowing at least 1 hour between your rides. It will be your responsibility to take your test to Cliff Swanson for review. You are responsible to keep track of your scheduled rides. If you are not back at the time to ride your test, you will be considered a scratch and no refund will be given.

**No Shows:** All “No Shows” that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled.

**Scratches During Show:** Competitors have responsibility to inform the Show Manager at the Show Office of their intent to scratch a ride prior to the scheduled ride time. Scratches will not be accepted at the competition arena or with the Ring Steward. Scratches are not refundable.

### **ARENAS/FOOTING:**

Competition arenas are 20m X 60m with sand/dirt footing mixture. A sand/dirt footing mixture arena is available for warm-up, with a separate lunging area.

Lunging is allowed only in the designated lunging area and not in the warm-up area during the show. Competition arenas will be open for hand walking only around the outside of the dressage arena up to one half hour prior to the start of the first class.

**NOTE:** When schooling in the warm-up or competition arena, ALL riders must wear their bridle number. Classical riders must wear a helmet.

**Food/Concessions:** Free food and beverages provided on the grounds for each paid rider and auditor.

**Parking:** No car or trailer parking between the barns and arenas. Trailers must be parked in the designated areas. Do not block the fire lanes.

**Awards:** Award and ribbon to 1st place in each division, ribbon for 2nd through 6th place in each division. Ties will be broken by the Collective Marks on Score Card.

**Management:** Show management reserves the right to refuse, accept conditionally and/or cancel awards of prizes without claims for damages & change order of classes, cancel, split, or combine classes at its discretion if entries deem necessary.

**General Information:**

**Dogs:** Dogs are only allowed on a short leash and controlled at all times. You must clean up after your dog.

Horse/Rider combination must be the same and may enter no more than two consecutive levels and a maximum of 2 tests.

Horses cannot be ridden by more than two (2) riders. Each rider/horse combination will require a separate entry fee and entry form. Rides will be limited to two (2) tests per horse/rider combination.

Rules will be governed by the United States Equestrian Federation and WDAA.

Rules are in force from the moment you enter the grounds.

Riders are required to clean up after their horses.

Riders need to provide their own callers.

Western riding attire includes boots, long sleeve shirt, trousers, a Western hat or ASTM rated helmet.

It is the rider's responsibility to be familiar with all USEF/WD rules. At least one third of the riders will be checked by the Ring Steward after each test for legal equipment & attire.

Classical riding attire is boots (tall or paddock boots with half chaps), breeches, long sleeve shirt, and an ASTM Helmet.

All liability forms for WDAAZ and American Ranch must be complete and on file at registration.

Copies of negative Coggins test (within past 12 months) and Health Certificate must be provided at registration for all out-of-state horses.

## WDAAZ Release, Wavier, & Hold Harmless Agreement

All participants of every entry (which include without limitation: the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler & the Horse).

1. Shall be subject to the constitution and rules of WDAAZ.
2. Represent that every horse, rider, and handler is eligible as entered.
3. Agree to be bound by the rules of WDAAZ and of the competition and Hold the officials, directors, employees, and volunteers harmless for any action taken.
4. Agree that as a condition of and in consideration of acceptance of entry, they authorize WDAAZ and/or the competition management to market, transfer, assign, or otherwise make any use of photographs, likenesses, films, broadcasts, audio, or videotapes taken of the horse(s) and participant(s) without compensation.
5. Agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk, serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and they agree to hold WDAAZ, the competition and their officials, directors, employees, and volunteers harmless from and against all claims including claims based on negligence, breach of contract, strict liability and/or otherwise for any injury or loss suffered during or in connection with the competition, officials, directors, employees, or volunteers of the WDAAZ competition.

### DIRECTIONS:

FROM HWY 89 HEADED SOUTH FROM CHINO VALLEY, TURN RIGHT ON OUTER LOOP ROAD AND CONTINUE TO DIRECTIONS BELOW.

FROM HWY 17, GO TO EXIT HWY 69 TOWARDS PRESCOTT. GO TO RIGHT ON FAIN ROAD, MERGE ONTO AZ-89A S (LEFT), TAKE EXIT TO HWY 89 TOWARDS PRESCOTT/CHINO VALLEY, TURN RIGHT AT EXIT FOR HWY 89, THEN FOLLOW TO LEFT ON OUTER LOOP ROAD AND FOLLOW DIRECTIONS BELOW.

GO 5.9 MILE TO LEFT ONTO WILLIAMSON VALLEY ROAD. GO DOWN 7 MILES AND TURN RIGHT ONTO N. AMERICAN RANCH ROAD. GATE CODE WILL BE PROVIDED ON FRIDAY THE 19<sup>TH</sup>. GO THROUGH GATE AND FOLLOW AROUND TO THE LEFT. FOLLOW THE HORSE SHOW SIGNS.
