## Class Details, Fees, and General Information

- **Show Start Time – 0900**
- **Dressage Tests - Arena Size:**
  - All tests and levels – Standard Arena (20x60)
- **Stabling:**
  - None available
- **Ribbons:** Ribbons are awarded thru sixth place for each class. Ribbons will be available in the show office.
- **Non-Competing Horses:** \$15 Grounds Fee.
- **Change Fee:** \$10 for any changes after entry submitted (e.g. rider or horse change, class changes, etc.)
- **Late Entry Fee:** A late entry is an entry postmarked, or received via email or fax, after the closing date. A late entry must include a \$25 late fee. Late entries accepted only if space allows.
- **Coggins:** Negative Coggins within 12 months required for all horses. Include with entry for each show.
- **Lunging:** No lunging in any of the arenas. Lunging permitted in grass areas not being used for show purposes.
- **Entries:**
  - Entries may be mailed or emailed – please see below for payment details
  - With each entry, include: 1) Entry Form; 2) Payment made out to Little Star Stables; 3) Coggins; 4) Release.
  - **Accepted entries will be held responsible for all fees.**
- **Payment:**
  - Payment is due when entry is submitted.

This is a great opportunity to improve your scores and work on areas needing improvement! DSDCTA members cost for the session is only \$100. Non-DSDCTA members cost \$125. Lunch will be included.

**AUDITING**

Lunch will be provided in a group setting. During Lunch, Lynn will set up for a question and answer session for all auditors and riders. This will be a great time to ask an experienced judge for her thoughts or input on any of those questions that have been keeping you awake at night!
