

ENTRY INFORMATION

A horse must be entered in the name of his registered owner(s) only and must be entered under its full registered name. A signature by the parent is required if a minor is showing. *Open checks are required upon check-in. Full payment by check, credit card or money order are due at check out of show. Exact cash only.*

IF SENDING BY MAIL, ALL OF THE FOLLOWING MUST BE MAILED TO THE SHOW SECRETARY:

- 1. The complete, signed entry form and all waivers.
- 2. Copies of AHA, WDAA and AQHA membership cards
- 3. Copies of Horse's Registration Papers for those competing in AHA or AQHA classes.
- 4. Fees Payable by Check or CC info to AHANM.
- 5. Please be sure to include email address on entry form.

*If you do not have a current AHA membership you must pay the AHA single event member fee or purchase annual membership. Exhibitors showing in Amateur Owner classes must be listed as an owner of the horse on the registration papers of the horse they are exhibiting.

**All entries must be made in writing on an official entry form for this show. Every owner, trainer, rider, driver, handler and parent or guardian of a junior exhibitor must sign the entry form waivers and must be an AHA Competition Member or pay the nonmember/single event fees. A horse must be entered in the name of his recorded owner. The complete address and phone number of the recorded owner must be given, even if an agent enters the horse. All horses belonging to one owner must be entered on one entry form. No horses may be entered on more than one form.

Horse Show General Rules & Information

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH. This horse show is conducted in accordance with the Rules of the United States Equestrian Federation, Arabian Horse Division. The official Rule Book of USEF will prevail for this show. This premium list is based on the rules of the current Rule Book. Any changes or corrections of rules will automatically become a part of this premium list. Each participant in the show is responsible for knowledge of and is subject to the USEF Rules. The Show Committee shall decide on questions not covered by USEF rules and its decisions will be final.

AHA MEMBERSHIP STATEMENT: EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR. WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP. SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS. EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS. EXHIBITITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS.

AHA REQUIREMENTS:

- A) All exhibitors entered in this event must be a current AHA member with a competition card, join AHA at the show, or pay a Single Event Membership fee of \$35.00 per person. This includes any owner, trainer, driver, rider, or halter handler who exhibits horses in the show ring or signs the entry form as the responsible person for any individual's horse. A photocopy of your AHA membership card must accompany your entry.
- B) AHA Membership affidavits are no longer available. If you do not have your AHA card you must pay the single event Member fee.
- C) There is an AHA mandatory fee of \$20.00 per horse. (\$10 AHA judges' commission and education/evaluation, Resolution 9-90 and \$10 AHA per horse fee).

USEF RULEBOOK AR101 ELIGIBILITY TO COMPETE:

Purebred: Horses shown in this division must have been issued a certificate of registration from the Arabian Horse Registry of America, Inc., or the Arabian Horse Association as a Purebred Arabian and/or the Canadian Arabian Horse Registry (or in the case of a foreign entry, which has not been issued said certificate of registration, have been issued a Competition Visa by the Arabian Horse Association), or, if under one year of age, be eligible for registry, and registration applied for (Exception: AR249.1) and must be entered under their full registered name. (Only weanlings that have had registration applied for may show without registration papers). A copy of the registration papers showing the owner of record with the Arabian Horse Association must be submitted with entry form at the time of making entry; competition management is responsible for notifying exhibitors of this requirement. A copy of the registration papers will be returned when exhibitors pick up their numbers. In the case of a sale or lease, it is required that a contract of the sale or lease, or statement from owner be submitted with the copy of the registration papers. (Exception: Horses under one year of age.

<u>Half-Arabians and Anglo-Arabians</u>: Horses shown in this section must have been issued a certificate of registration from the International Arabian Horse Association or the Arabian Horse Association or the Canadian Partbred Arabian Register as a Half-Arabian or Anglo-Arabian, or if under one year of age, be eligible for registry and registration applied for and must be entered under their full registered name.

ARENAS: The indoor arena is 117' x 250'; Outdoor arena is 125' x 264'. Footing in all arenas and warm up areas is sandy loam.

**Outdoor Arena will be available for schooling on March 14th, 2024 after 5:00 pm.

Horse Arena will be available for schooling on March 14, 2024 after 1:00pm. Jumping Practice Thursday.

BAD CHECKS: There will be a \$50.00 handling fee charged for any returned check or declined credit card. Action in accordance with USEF rules will be taken against any owner, exhibitor or trainer who does not make a returned check/declined credit card charge good and will be reported to AHA.

BARN OFFICE HOURS, ARRIVAL AND DEPARTURES: Barn manager is Margie Billau (505-980-6806). Early arrival or late departure is \$20 per day per stall used.

NEW MEXICO STATE FAIRGROUNDS AND/OR AHANM IS NOT RESPONSIBLE FOR ANY ITEMS LEFT UNATTENDED.

CALL FOR CLASSES: The two-minute gate will be enforced. The gate will close two minutes after the first horse enters the ring or in cases with large classes taking more than two minutes, after the entry of the final horse in a continuous string of horses. If tack changes are necessary, it is the exhibitor's responsibility to notify the gate person and request a three-minute gate hold. Note: Due to unforeseeable problems with the mechanical devices, the paddock and barn calls over the PA system must be considered a COURTESY. It is the responsibility of the exhibitor to be sure that his/her horse is at the gate at the prescribed time.

CANCELLATION OF CLASSES DUE TO EMERGENCIES: In the event that a class, or a series of classes, or all or part of the competition is cancelled due to an accident, storm, or other emergency after the start of the show (defined as initial Move-In Day), no refund of entry fees will be made. Classes are subject to change. Arenas are subject to change.

DOGS: Dogs will be permitted on the show grounds but MUST be always on leashes. No dogs will be allowed in the show arena. This is a USEF Yellow Warning card offense (GR1037 & GR1301.6).

DRESSAGE CLASSES: FOR DRESSAGE/WESTERN DRESSAGE—POST ENTRIES WILL NOT BE ACCEPTED After 2/28/24***

Dressage classes may not run in order listed in the schedule. Maximum of 55 rides available — Maximum of three (3) rides per horse/day. Dressage entries must be mailed or e-mailed and postmarked or e-mail time will determine order of entry. No hand carried entries accepted. Ride Times will be available on the AHANM Website https://www.nmarabs.org and on Facebook. Once ride times are sent/posted they will not change. We will not contact exhibitors unless there is a conflict. AQHA classes may run concurrently.

- All AQHA Dressage tests will run concurrent with the corresponding All-Breed Test.
- AQHA riders may enter the All-Breed class and any applicable AQHA divisions, but will only have one ride per test. For
 example, a rider may choose to enter Level 1, Test 2 in the All-Breed, AQHA Amateur and AQHA Open. They will ride this test
 once and be placed in all three classes. If the AQHA rider does not enter the All-Breed class, they will not be eligible for any of
 the All-Breed Awards.
- AQHA riders will be responsible for indicating which test and division (Open, Amateur and Youth) they want AQHA
 recognition for and an individual entry fee will be required for each recognition.
- All AQHA entries must have an AQHA registration number and a current AQHA membership. These numbers must be required at the time of entry and will be verified before ride times are published.
- All AQHA will pay a one-time \$10 AQHA processing fee per horse.

ENTRIES: All entries must be made on the official entry blank for this show and filled out entirely. A horse must be entered in the name of his registered owner(s) only and must be entered under its full registered name. A photocopy of all AHA membership cards and registration papers must accompany your entry form. All entries must be accompanied by a valid check or money order for the full amount of all fees made out to AHANM. A signature is required by the parent if a minor is showing. *Open check is required or credit card on file upon check in. All entries must be paid in full.* Exhibitor Numbers will be released to exhibitors ONLY when ALL the fees, signatures and information are complete or open check in office. All credit card transactions add 4% Fee.

Opening Date for Entries –January 8, 2024

Closing Date for Entries – February 28, 2024

FARRIER: A Farrier will not be available on show grounds.

FEED & BEDDING: Feed and bedding is available on the fairgrounds from 4-W Feed Store (505) 259-5341. The use of outside shavings is not permitted on fairgrounds. If a medical condition requires the use of special bedding, please provide proper documentation from a licensed veterinarian.

HEALTH REGULATIONS: All horses must have a negative Coggins Test dated within twelve (12) months (must be original not photocopy). All out of state horses must also be accompanied by an Official Health Certificate issued within 30 days of arrival that identifies the animals listed, including all vaccinations, and date and results of required test. THE ABOVE ITEMS SHOULD BE CARRIED WITH YOU – DO NOT FORWARD WITH YOUR ENTRY. Any animals brought into New Mexico must observe all regulations of the State of New Mexico, Animal Health Division. Any horse that develops a communicable disease must be removed from the show grounds.

INDEBTEDNESS TO SHOW: Any exhibitor who fails to settle his/her indebtedness to this show will automatically be reported to AHA and USEF.

JUDGES: This show will be judged according to the single judge systems. If an official is unable to perform his duties, the Show Committee reserves the right to substitute an official according to USEF rules. It is a violation of USEF Rules to commit any act or make remarks during the show that are considered offensive or made with intent to influence or cast aspersions on the judging and any exhibitor may be barred from the show for this offense by the Show Committee. No contact shall be made with the Judges during the period of the show unless accompanied by a member of the Show Committee designated by the committee for such purpose. Further, no exhibitor shall approach a Judge regarding a decision unless he first obtains permissions from the Steward, who shall arrange an appointment with the Judge at a proper time and place.

MOTORIZED VEHICLES: Golf Carts and Other Motorized Vehicles – To operate any motorized vehicle on the New Mexico State Fairgrounds, you must have a valid driver's license or operator's license as defined by the state in which you reside. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from the rule. Golf carts must be registered with NMSF to be driven anywhere on the fairgrounds.

POST ENTRIES: NO Post Entries will be accepted for Dressage or Western Dressage classes. Post entries will be accepted for all other classes with an increased Office Fee of \$30.

PRIZE LIST CHANGES AND/OR CORRECTIONS: Changes and/or corrections to the Premium, if any, will be posted on the Club's website www.nmarabs.org.

PROTECTIVE HEADGEAR: Any rider may wear protective headgear in any division or class without penalty from the judge. USEF strongly encourages all riders to wear protective headgear. It is the responsibility of the rider, parent, guardian, or trainer of the junior exhibitor to see that the headgear worn complies with safety standards and is properly fitted and in good condition. Refer to current USEF Rule Book.

REFUSAL OF ENTRIES/PROTESTS: The show Management will be governed by USEF rules with respect to refusal of entries. All decisions made by the Judge and/or Show Management are final and cannot be protested. **Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason including but not limited to unsportsmanlike like conduct and animal cruelty.**

REGRISTRATION REQUIREMENTS: Horses shown in the Arabian Division must have been issued a certificate of registration from the Arabian Horse Association and must be entered under their full registered name. Horses shown in the Half-Arabian/Anglo-Arabian Division must have been issued a certificate of registration from the Arabian Horse Association in the Half-Arabian or Anglo-Arabian Registry and entered under their registered name.

RESPONSIBILITY: All entries are accepted with the understanding that neither Arabian Horse Association of New Mexico nor the EXPO Fairgrounds will be responsible for any loss, personal injury, or damage to any horse exhibited or for any article of any kind or nature that may be lost or destroyed or in any way damaged. All horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor who will be responsible for any loss, damage, or injury of any person, animal or property occasioned by him or his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the Arabian Horse Association of New Mexico and the New Mexico State Fairgrounds against any and all legal costs, including attorney fees which may be the result thereof. The submitting of any entry form to the Show Secretary shall constitute an acceptance of the provisions herein set forth.

SCHOOLING ONLY ENTRY: Horses not entered in classes must pay for stall or grounds fee and a one time schooling fee of \$25 and office fee.

SCRATCHING CLASSES: No refund of entry fee when scratching classes.

SHOW OFFICE HOURS: Show Office will be open: Thursday from 4-6pm. Friday, Saturday and Sunday @ 7:00am.

The show office will remain open throughout the show and will close after the end of the show each day.

Please remember to check out after your last class. Check-in appointments are encouraged for large groups.

STALLIONS are not allowed in showmanship or walk-trot classes.

STALLS: Horse Stalls & Tack Stalls are available for \$25 night. Stalls and alleyways must be kept clean. Horse tie out is available with a ground tie fee of \$25 per day per horse, no overnight. Stalls can be reserved by sending in the appropriate stall fees, but no stalls will be held without proper entry. Early Arrival/Late Departure is \$20/stall/night. Stalls are 10 x 10 with a door.

VETERINARIAN: A veterinarian will not be on the fairgrounds. Information for the closest vet will be posted at Show Office.

WITHDRAWING ENTRIES: Entries may be scratched from the show PRIOR TO February 28th, 2024 with a refund of all fees EXCEPT the office fee. After that date, withdrawals accompanied by a veterinarian's certificate of inability to show will receive refunds of class entry and stall fees only. No refunds for any other reason.

DEFINITIONS & CLASS SPECIFICATIONS

<u>DEFINITIONS:</u> The following abbreviations, as defined, will be used to describe class specifications:

JOTR/JOTD — Junior Owner to Ride/Junior Owner to Drive.

<u>AOTR/AOTD</u> — Amateur Owner to Ride/Amateur Owner to Drive.

JTR/JTD — Junior Exhibitor to Ride/Junior Exhibitor to Drive.

ATR/ATD/AATR — Amateur to Ride/Amateur to Drive/Adult Amateur to Ride.

<u>SELECT — AOT, AAOT, AT, AAT, JOT, JT</u> — Refer to USEF AR113.1f

All-Breed Classes/Training Tack: DO NOT require AHA Membership or Registration Papers to participate. Membership or non-member fee will apply. Membership allows points from these classes to count towards AHANM high point awards. All-Breed (AB) classes are Open to ANY BREED. Martingales, hackamores, humane training devices and two hands are allowed in ALL AB classes. Show clothes and equipment are not necessary but may be worn in AB classes.

Amateur — Every Adult rider having reached his/her 19th birthday prior to 12/1 of the previous year must have an amateur card issued by USEF.

Amateur owners – Leased horses are not eligible for amateur owner classes. Horses entered in amateur owner and junior owner classes must be registered in the name of the competitor or a member of the competitor's family, as defined by USEF GR122. The sale of a horse does not eliminate this requirement. (Contracts of Sale or Bill of Sale will not be accepted.)

Limit Horse – A limit horse class is open to horses that have not won six (6) first-place ribbons at Regular Member Shows of USEF or the Canadian Equestrian Federation in the particular performance division in which they are shown. A Limit entry is such from the date of the closing of entries for this show.

A/HA/AA Walk Trot 10 & Under Classes: Open to riders 10 & Under as of 12/01/2023. Please provide rider's DOB.

AHA ENTRY AGREEMENT

I have read the rules concerning competitions as printed in the Arabian Horse Association (AHA) Handbook / Directory and Competition Prize List and agree to be bound by and subject to those Rules.

AHA ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION <u>This document waives very important legal rights</u>. Read it carefully before signing.

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows:

I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.

I AGREE as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals. I agree to release, hold harmless and not to sue AHA, the Competition Sponsor, their officers, directors, employees, volunteers or members concerning any decision of AHA, the Competition, its Show Commission, Show Officials or any hearing body that relates to my qualifications or my horse(s)' qualifications to enter the Competition or any results of the Competition.

I AGREE that AHA has the sole right to control, sell, supervise or give away (or assign to others the right to do so) the exclusive rights to broadcast, televise, reproduce, transmit and disseminate all or part of this event, and I agree that AHA may use or assign, in any way AHA sees fit, photographs, films, videos, audios, cablecasts, or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition or AHA.
