## **INFORMATION AND RULES**

**Awards** Test Classes and Rail Classes placed 1-6 place

**Western Dressage Tests** Current 2022 WDAA Western Dressage Tests will be used.

**Stalls** Day Stall include one bag of shavings, O/N stall will be provided 2 bags. No outside bedding allowed.

**Entries** Entries must be submitted and payments on striderpro.com. Close of entry is May 10, 2024. Entries received after May 10, 2024 are considered a post entry and will be charged a fee of \$15 per horse.

**Entries Cap** There will be a maximum of 50 rides. Post entries will only be accepted if there are time slots available. Please contact management before sending in late entries. A horse may compete in 4 rides maximum for the day

**Horse Health Requirements** All horses must present a current negative Coggins dated within 12 months of the show. **Out of state horses need a CVI dated within 30 days of the show per PA rules.**

**LIABILITY:** You assume the risk of equine activities pursuant to Pennsylvania Law.

**INDEMNITY AND RESPONSIBILITY** All entries are accepted with the understanding that neither PAWDA, WDAA, USEF, Diamond 7 Ranch, the Show, the Show Committee, nor any Show Official will be held responsible for any loss, damage, or injury to any horse exhibited or any article of any kind. All

horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him, and the exhibitor shall indemnify the above mentioned parties against any and all loss, damages and liability thus occasioned, including, but not limited to, any and all legal costs, including attorney fees, which may be incurred as a result thereof. Submitting of any entry form to the Show shall constitute an acceptance by each person signing same of the provisions herein set forth.

**Show Rules** All classes will be conducted in accordance with the rules of USEF and WDAA. Judging, class specifications, rules and conduct shall be in accordance with the current USEF/EC Rulebook. All decisions made by the Judge and/or Show Management are final and cannot be protested. Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason including but not limited to: unsportsmanlike conduct and animal cruelty.

**Refusal of Entries** The Show Management reserves the right to refuse, accept conditionally or to cancel any entries of any exhibitor.

**Refunds** In case of injury or illness of horse or rider before the event, a vet certificate or medical excuse is required before 8 am of the first day of the event. All fees except the office fee will be refunded. Refunds will be mailed within 30 days.
