- ❖ Current (within 12 months) negative Coggins and USEF Vaccine Verification **required** with entries
- ❖ All tests will be ridden in 20x60m arena, exceptions can be made for class 4
- ❖ USEF tack rules apply for USEF dressage tests First Level and above, training tack permitted at Intro and Training Levels
- ❖ WDAA tack rules apply for all WDAA tests
- ❖ Cross entries between Classical and Western Dressage classes permitted
