Time for individually judged classes is LIMITED!

Entries will be processed by time emailed or postmark order. When all times have been filled, even if before closing date, remaining entries will be placed on a waiting list.

Entries Open Feb 26 and Close March 10. Entries emailed or postmarked prior to 1201 AM on Feb 26 will be returned. Western Dressage rides are limited to approximately 35 rides and English Dressage rides are limited to approximately 65 rides. Tests are limited to three tests per horse (this does not include Equitation and Walk/Trot 10 & Under). Once the available ride times are filled, a waiting list will be established. In Hand goes are limited to approximately 60 for each type.

Western Dressage New Rule: To be eligible for Intro Level, a horse/rider combination must not have shown in a WD test at First Level or above.

Dressage tests (English & Western) may not be scheduled in the class schedule order. Ride times will be emailed once all entries have been scheduled. Horses who are entered into a Walk/Trot test, with the exception of Walk/Trot 10 & Under, may not enter any test requiring a canter.

In-Hand Classes will be run by class and an order of go assigned. Please report promptly to the paddock and check in with the paddock master when your class is called

Fees, Stabling and Entry Information

STABLING RULES PER THE TACOMA UNIT!!

- > **Stalls & tack rooms must be left clean or a \$10 fee per stall is charged to the show.**
- > **Drapes/stall decorations may only be attached to the new header board above each stall.**
- > **Nails, staples, screws or hooks are not allowed in horse or tack stalls. Bring "C" clamps, etc. to hang items & for cross ties.**
- > **Water bucket hangers are being placed in each stall to use in place of using your method.**
- > **Dumping a water bucket in a stall will incur a \$50 charge per stall which the show will collect from you.**
- > **All charges to the show by the facility for damage by you, will be collected from you.**

Entries ▶ are to be EMAILED by attaching the entry form. The form can be typed into, saved and attached or printed, filled out and scanned. "Picture files" of entry forms and cards will be returned. AHA membership cards and horse registration papers do NOT need to be sent but make certain the numbers are correct and you have included 1A, etc., for Half-Arab numbers. Please send copies of USEF card if currently a member and/or an adult showing in an amateur class.

Entry Payment ▶ Venmo to @prahaspringclassic@gmail.com is preferred. If paying by personal check, make check payable in US Funds to PRAHA. Payment, whether by Venmo or check, must be made the same day as the entry is emailed or must accompany the snail mailed entry. In fairness to all exhibitors, open checks are not allowed for the initial entry. If an open check is sent, it will be closed for the amount due at the time the entry is processed and will be deposited. Postdated checks will not be accepted. Secretary reserves the right to finalize open checks. If you will be adding classes at the show, plan to leave an open check or pay via Venmo at the time the classes are entered.

Intent to Show ▶ By submitting and signing an entry form, it is your intent to show and you are agreeing to our rules. If you have questions concerning this, please phone the secretary or show manager.

Post Entries ▶ will be accepted at the indicated post entry fee and will be closed after the last class of the session before the class is held. Post entries for dressage and in hand are only accepted in the event time is available.

Refunds ▶ Entry fees will not be refunded in the event that all or part of the competition is cancelled due to a storm, acts of God, illness, accident or other emergency at the show. Refunds for improperly entered classes only in cases of secretary error.

Refusal of Entries ▶ The Region 5 AHA Board of Directors has directed that entries must be refused from anyone that has an outstanding obligation to any Region 5 affiliated club, show or contracted services. Management reserves the right to hold classes conditionally, or cancel entries of any contestant, as stated in USEF Rules. Show management reserves the right to reject any entry if it seems to be in the best interest of the show. The show committee reserves the right to remove any owner, groom, rider, trainer, manager, coach or driver groom (header), horse or rider from the show who has shown an objectionable attitude or behavior towards its management, or previous unsportsmanlike behavior, without being liable for compensation or damages.

Signatures ▶ Entry forms must be signed by owner, trainer, and all riders. If no trainer, the owner must sign the trainer line. The person who signs as owner, trainer and/or rider must be over 18 years of age. A parent or guardian does not need to have memberships to sign on behalf of a minor.

Withdrawal of Entries (aka Vet-Out) ▶ The show committee agrees to refund fees on any horse not fit to show provided written notice is given on or before entry closing date of **Feb. 26, 2022**. After closing date and up to 7 pm Thursday, March 31, 2022, withdrawal must be accompanied by a veterinarian or doctor letter. Refund of entry fees will be reimbursed at the direction of the show committee, less a \$20.00 fee. All facility fees are non-refundable. All other refund requests shall be made in writing and submitted to the Show Committee for resolution.

COVID-19 ▶ At the time of publishing this Prize List, the following policy is in place per the Tacoma Unit: **If you are indoors and cannot maintain 6' of social distancing, then masks must be worn. Trainers are responsible for monitoring their group. By signing the entry forms, you are agreeing to all Covid-19 related policies. If restrictions are tightened or lessened by AHA, Pierce County or The Tacoma Unit, we will notify via our website, www.pacificrimarabianhorseassn.com & our Face Book page.**

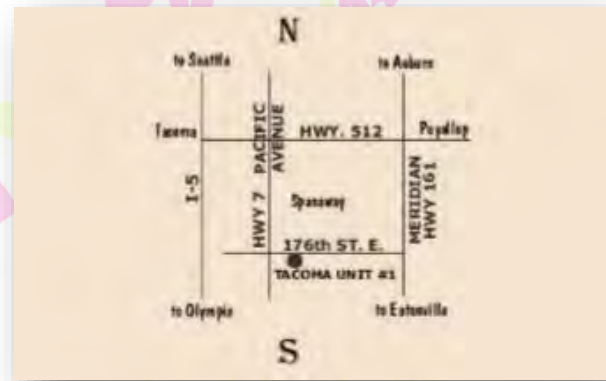

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH. EACH PARTICIPANT IS RESPONSIBLE FOR KNOWLEDGE OF AND IS SUBJECT TO THE USEF RULE BOOK. THE USEF RULE BOOK IS AVAILABLE AT www.usef.org

AHA MEMBERSHIP STATEMENT

EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR. WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP. SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS. EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS. EXHIBITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)

AHA Competition Requirements

All riders, drivers, owners, agents and handlers who exhibit horses in the show ring or sign the entry form as the responsible party for any individual's horses at the show must be AHA COMPETITION level members with competition cards or pay a Single Event Membership fee of \$35 per person. *If the recorded owner is an entity (Farm, Ranch, Syndicate, etc.) and does not have a current AHA Business membership, a Single Event Membership must be purchased for that entity.* **Exception:** Exhibitors in Walk/Trot or lead line classes, or Parent/Guardian signing for minors.

AHA Registration

Horses shown in the Arabian division must have been issued a certificate of registration from the Arabian Horse Association Registry and/or the Canadian Arabian Horse Registry or, if under one year of age, be eligible for registry, and registration applied for and must be entered under their full registered name. Half-Arabians and Anglo Arabians must be registered with the AHA Registry in the Half-Arabian and/or the Anglo-Arabian registry, or be eligible for registration and registration applied for and must be entered under their full registered name.

Admission to the arena ▶ No person may enter the space set aside for the judging or hold any communication with the judge without permission of the steward or show manager, who will arrange an appointment with the judge at the proper place and time. Failure to comply with this request could result in disqualification from subsequent classes and forfeiture of all entries, prize money, trophies and ribbons. All attendants must be neatly and properly dressed. Special attention should be given to dress and demeanor on entering the ring.

Arenas ▶ Arena footing is sandy loam. Main arena is 95' x 195'. Covered warm-up is 60' x 140'. Outdoor sand ring is approximately 100' x 100'. Dressage Intro and Training levels, Western Dressage Intro and Basic levels may be held in the short court. All others will be held in a modified long court due to arena restrictions (**dressage court is 4.3 meters short**). Unless otherwise specified, arenas will be groomed before the first class of each session.

Age of Horse and Rider ▶ For horse show purposes any horse shall be considered to be 1 year old on the first day of January following the actual foaling date. Junior exhibitors are those who have not reached their 19th birthday by 12-1-2021. Junior exhibitors are considered amateurs and do not need amateur certification.

General Rules cont'd

Amateur Owner "Family" Definition ▶ Horses entered in amateur owner and junior owner classes must be registered in the name of the competitor or a member of the competitor's family, as defined by USEF rules. (Horses registered in a farm, ranch, syndicate, partnership, corporation name may be shown in Amateur Owner classes provided the family is the sole owner of the farm or entity as defined by USEF rules). The sale of a horse does not eliminate this registration requirement. Contracts of Sale or Bill of Sale will not be accepted for owner classes. Leased horses may not be shown by the lessee in Amateur Owner classes. Combined ownership is allowed in Amateur Owner classes only when these owners are members of the same family.

Amateur Owner "Family" Definition • *For ownership by the same family, the term family includes the following: spouse, parent, step-parent, child, step-child, brother, sister, half brother and sister, aunt, uncle, niece, nephew, step-brother and sister, grandparents and grandchildren, and in-laws of the same relation as stated above.*

Combined ownership is permitted in Junior Owner's or Amateur Owner's classes under the following conditions:

1. Two distinct non-family owners may co-own a horse and show that horse in Junior Owner or Amateur Owner classes except that no family member of a professional may enter into this relationship. 'Non-family owners' are defined as two distinct individuals who are not related as family as defined by US Equestrian or Equestrian Canada.
2. A horse that is co-owned by the two distinct non-family owners must be registered with Arabian Horse Registry of America, Half Arabian Horse Registry, Anglo Arabian Horse Registry, Canadian Arabian Horse Registry or Canadian Partbred Arabian Registry, or other registry approved by the Arabian Horse Association as an "and" ownership relationship. An "or" ownership relationship does not enable two distinct non-family owners to show in Junior Owner's or Amateur Owner's classes.
3. The right to show horses in Junior Owner or Amateur Owner classes when there are two distinct non-family owners registered as the owners of said horse, does not extend to the family of these distinct non-family owners.
4. In order to show in Junior Owner or Amateur Owner classes both distinct non-family owners must be members of US Equestrian or Equestrian Canada and hold valid amateur cards or be juniors or a combination of amateur and junior.
5. Both distinct non-family owners must be individuals, no farm or corporation co-owned horses are eligible.
6. No family member of a distinct non-family owner may receive any remuneration in relation to the co-owned horse as defined in SUBCHAPTER 13-B AMATEURS AND PROFESSIONALS (or Equestrian Canada equivalent).
7. Horses co-owned by more than two distinct non-family owners cannot be shown in Junior Owner or Amateur Owner classes.
8. If the co-ownership relationship is terminated, that horse is not eligible to be co-owned by another distinct non-family person for the remainder of that show year as defined by US Equestrian. The remaining owner and his or her family members are eligible to show in Junior Owner or Amateur Owner classes.
9. A horse that is co-owned by the two distinct non-family members cannot be shown in a Maturity and Jackpot classes at any AHA national championship show.
10. An individual AHA affiliate association/club may elect to not allow horses that are co-owned by two distinct non-family members to compete in classes designated for Amateur Owner or Junior Owner for which they offer prize money, Futurity, or other restricted classes with payouts greater than \$2,500.
11. An individual member may only enter into two distinct co-owner relationships and compete with these arrangements in Amateur Owner or Junior Owner classes at USEF/EC-approved shows. Arrangements with other individuals, same as otherwise, for purposes other than competing in USEF/EC-approved shows in Amateur Owner and Junior Owner classes, are not impacted.

Awards ▶ Ribbons to 5th in each class. Junior Exhibitor Performance and Equitation will have ribbons to eight places. **Awards, tests and score sheets must be picked up at the show; they will not be mailed.**

Change of Handler/Rider ▶ It is the obligation of the exhibitor to notify the show office of any change in rider, driver, handler or cancellation of entry and exhibitors must fill out a handler/rider change form with correct association numbers and documentation in the show office **prior to their class**. This also applies to **equitation horses** changed after entry has been processed. Changes must be submitted **before the end of the session before the class is held**.

Changes to schedule or venue ▶ Management reserves the right to make changes of arenas, judges or class order to facilitate time schedule and conditions. All changes will be posted on the announcement board at the office and the appropriate announcements made during the competition. Classes with no entries by closing date may be cancelled. Competition management reserves the right to cancel, combine or split classes at its discretion. Show management reserves the right to add or substitute judges as required. Upon receipt of the preliminary ride schedule, it is the rider's responsibility to notify Show Management if they are NOT eligible to show for a substitute or added judge.

COVID RULES OF THE TACOMA UNIT: Masks must be worn indoors whenever it is not possible to maintain a distance of six feet from one another.

Common Areas ▶ The round pen, Joan Mitchell Arena, the Jack Stecker Arena, stock/holding pens, and the Twomey Barn wash rack are Tacoma Unit membership use items only, and not for exhibitors at this show. Please respect this.

Cruelty ▶ to or the abuse of a horse by any person is forbidden and renders the offender subject to penalty. The following acts are included under the words Cruelty and Abuse but are not limited thereto: Use of shackles, hock hobbles and similar devices (not to be construed as rubber or elastic exercising devices) Excessive use of a whip on any horse, in a stall, runway, schooling area, show ring, or elsewhere on the show grounds before or during a show, by any person. Attention getting devices &/or other noisemakers (including but not limited to tape measures, blow horns, altered bamboo poles, explosives, etc.) are not allowed.

General Rules cont'd

Delay of Class / "Gate Hold". *In classes where horses compete collectively, when it is found that a gate hold must be requested by an exhibitor such request shall be made to the Paddock Manager (gate person) prior to the close of judging of the class immediately before the class requiring the gate hold. The reason for the request must be stated. The gate hold will be a maximum of three (3) minutes. Gate holds are only allowed for group classes; "...in classes where horses compete individually, failure to check in with the Paddock Manager or to enter the competition arena at the assigned time will result in elimination."* [GR831.1]

When horses are competing collectively, if a first horse does not enter the in-gate ready to participate within one minute from when the class is called into the ring, a warning is issued.

- a. Exhibitors will then have one additional minute to start the steady stream of horses into the in-gate.
- b. If no horses have entered the gate at the conclusion of the additional one minute, the gate shall be closed and the class is deemed concluded.
- c. Once the first horse has entered the in-gate, a steady stream of horses must be maintained.
- d. Should the steady stream be broken after the two minutes have elapsed, the gate shall be closed and judging will commence.
- e. A steady stream is defined as a constant flow of horses moving forward through the in-gate with a reasonable and safe distance between them (i.e. two to four horse or horse and buggy lengths in between)
- f. Show Management from this procedure as circumstances warrant.

Discipline ▶ Exhibitors are warned that any act of discourtesy or disobedience to the officials on the part of the owner, trainer, groom or rider will disqualify the horse from adjudication. The show committee reserves the right to remove a horse, owner, rider or groom from the show without being liable for compensation or damages. It is a violation of our rules to commit any act or make remarks during the show that are considered offensive or made with the intent to influence or cast aspersions on the judging, and any exhibitor may be barred from the show for this offense.

Dispute Not Covered by Rules ▶ Should any question or dispute arise not provided for in the governing rules, the same shall be referred to the Show Committee whose decision shall be final.

Disposal of Needles & Medical Waste ▶ "Sharps" is the title given to hypodermic needles and syringes, even in the equestrian environment; used sharps are contaminated by contact with equine body fluids. Any owner, trainer, exhibitor or their agents, who improperly dispose of needles or other sharp instruments, may be fined \$100 by the competition management. Competition management will place sharps containers in the barns.

Fire Marshal Rules ▶ Aisle ways between stalls must remain open. Stall drapes must be fire retardant, including cordura. The Fire Marshal may inspect the grounds during competition and may ask for proof of fire proofing. Smoking is not allowed in the arenas, barn areas or stands.

Food ▶ The food concession will be open during meal hours

Leased Horses ▶ may not be shown in Amateur Owner to Ride (AOTR, AAOTR, JOTR,) classes.

Lungeing ▶ is not permitted in the warm up arena while any classes are in session or 30 minutes prior to the start of a session. Lungeing is not permitted at any time in the main arena. Your best bet is the sand arena, before and after competition hours.

Pets ▶ Dogs (and Cats) are not permitted to be loose on competition grounds and must be on a leash or otherwise contained. Individuals must not lead dogs on a leash while mounted. Pets are not allowed in the arenas at any time. Please do not leave pets unattended in stalls. Pet owners are solely responsible for any damages, claims, losses or actions resulting from their pet behaviors. Pet owners failing to comply with this rule may be subject to penalty.

No Smoking ▶ It seems foolish that we would even have to tell you this: There is NO SMOKING in the buildings, barns, kitchen, arenas or bleachers. If you are smoking, we will assume you are on fire and douse you with water immediately.

Overnight Camping Fee ▶ **The fee is \$30 per night** and applies to tents, campers, motor homes, etc. whether you are hooked up to electricity or not. Electrical hook ups are on a first-come, first-served basis. We are not responsible for working condition of electrical hook ups. NOTE!!!! Refrigerators used in the barns WILL BE CHARGED the camping fee (on top of the stall fee) and Tacoma Unit CHECKS for them!!!! RV passes must be displayed on the windshield of the vehicle, or left-hand window of the trailer if vehicle is removed. Additionally, NO ELECTRICAL cords may be run from the barn outlets to any RV's, campers or trailers. There is NO PARKING within 30 feet of the barns.

Protective Head Gear ▶ Except as may otherwise be mandated by local law riders in all Dressage, Working Hunter, Jumper, Hunter Hack, and all Hunt Seat Equitation classes (not to jump or over obstacles and when jumping anywhere on the competition grounds) must wear properly fastened protective headgear which meets or exceeds ASTM/SEI standards for equestrian use and carries the SEI tag or BSI/BS EN Standard. It must be properly fitted with harness secured. (AR111)

Responsibility ▶ The Pacific Rim Arabian Horse Association will not be responsible for any loss, damage or injury to horses exhibited or for any article of any kind or nature that may be lost or destroyed or in any way injured. Each exhibitor will be responsible for any injury that may be occasioned by any person, whomsoever, by any horse owned or exhibited by him, and shall indemnify the occasioned by any horse owned or exhibited by him or arise from the negligence of the person in charge of such horse. All horses will be exhibited in this show entirely at the owner's risk.

Returned Checks ▶ Checks returned by the bank for any reason will incur a \$50 charge per domestic check (\$100 per International check). Payments will not be processed through the bank a second time. Show packets will not be released until all debts are settled. In the event a check is returned after the completion of the show, we will contact you immediately for payment.

General Rules cont'd

Ride times ▶ will be posted at www.pacificmarabianhorseassn.com Show staff will not follow up with exhibitors who request ride times to be e-mailed but do not provide a **legible** e-mail address. Dressage announcements will NOT be made. Exhibitors are responsible for being ready to enter the arena at their assigned ride times. Exhibitors that arrive late will not get to ride and will not receive a refund.

Scoring Errors ▶ If a mathematical scoring error on the score sheet is discovered, it must be reported to Show Secretary within one hour of the official posting of the scores from the last scored class of that competition day or the error will stand with no change in class placings. Please claim all dressage test sheets and In-Hand score sheets at the Awards room before you leave the show; they will not be mailed.

Scratches and 'no shows' ▶ All exhibitors scratching their class at the gate must also complete the formal scratch form in the show office. If you don't show up for an assigned ride time, this Competition reserves the right to scratch you from all remaining dressage rides and offer them to other exhibitors. If you are unable or choose not to ride, notify the secretary immediately.

Stabling ▶ is permanent stalls with bottom doors, some with top and bottom doors. Stabling is available only for horses entered in the competition. **See important stabling information on page four (4) – there are changes per The Tacoma Unit!**

Travel Requirements ▶ You are responsible for being in compliance with Washington transport requirements.

Vaccination Policy ▶ Competition Management reserves the right to review vaccination documentation. Non-compliant entries may be quarantined or denied permission to unload, and will not be allowed to compete nor to mingle with other horses.

Regional Qualification: Participate at one (1) AHA qualifying show in order to compete at any and as many Regional Championships.

National Qualification: Regional Top 5 or better or participate at two (2) AHA approved shows (one of which may be a participation from a Regional Championship).

Dressage & Western Dressage

Regional Qualification: Participate at one (1) AHA qualifying show or "USEF/USDF, USEF/WDAA Open qualifying show" in order to compete at any and as many Regional Championships.

National Qualification: Regional Top 5 or better or participate at two (2) AHA approved shows or "Open Qualifying Shows" (one of which may be a participation from a Regional Championship)

No Qualifications needed for Regionals or Nationals

Carriage Driving (all), Working Hunter, Hunter Seat Equitation Over Fences, Hunter Hack (all), Jumpers, Green Working Hunter and Dressage Seat Equitation.

*Participation (compete in any recognized class within a section, i.e. Sport Horse Under Saddle and Sport Horse Show Hack are separate sections. For Dressage each level is a section) means finishing the class and if scored, receiving a score. If you are eliminated, excused, disqualified or don't receive a score, you do not receive credit for participating. Placing 1-6 at an AHA approved show or a Top Five at an AHA regional in 2021 can be used!

I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, leasee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.

I AGREE as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals.
