**RULES AND REGULATIONS:** GVDS Schooling Shows are governed by United States Equestrian Federation (USEF) rules, except where noted. Please see <u>USEF Dressage Division Rules</u> or <u>USEF Western Dressage Division</u> <u>Rules</u> for complete information. Please refer to the <u>GVDS website</u> for more information about dressage training and rules or the Dressage FAQ's found in the Education & Resources section of the GVDS website. The Dressage FAQ's sheet will also be posted outside the show office. Minors (17 and under) may not ride stallions in any class.

<u>USEF WESTERN DRESSAGE RULES AND TESTS</u>: Please refer to <u>Western Dressage Association of America</u> website for detailed information. <u>Western tack must conform to Western Dressage Association of America</u> standards. Please refer to the <u>WDAA Equipment and Attire Guide</u> for more information.

Entry Fees:

<u>ON-LINE ENTRIES ARE NOW AVAILABLE through HorseShowOffice, go to HorseShowOffice.com to enter the</u> show and pay on-line. Otherwise, you can still enter by mailing an entry form and check to the show secretary.

Make checks payable to Grand Valley Dressage Society. Paper entries should be mailed to Show Secretary. No rider packets/bridle tags will be released until all fees are paid in full.

Please note that the <u>trainer's signature</u> would be the person who is responsible for the horse while on the show grounds and must be 18 years of age or older.

PLEASE NOTE: The initial payment for stalls includes two bags of shavings. At least two (2) bags of shavings are mandatory as per the Mesa County Fairgrounds rules, day stalls included.

**ENTRIES:** Entries accepted on a first come, first served basis, based on (readable) postmark. Post entries (postmarked after closing date) will be accepted on a space available basis with applicable late fees. The GVDS Entry Form must be used. Once the competition is filled a wait list will be established. The wait list will be maintained through August 22, 2024. If the entry is incomplete, the horse/rider combination will be placed on the wait list until the required paperwork is received. Bridle tags are always required when a horse is outside of a stall. An entry form is required even if the horse is only schooling. Anyone not appearing for any of their dressage tests without prior notification to the show secretary will be "scratched" from their remaining classes. No refunds will be issued. Those rides will be filled if possible.

**<u>AQHA PROCESSING FEE</u>**: For horses registered with AQHA that would like their scores submitted to AQHA. This is a one-time per horse/rider combo fee. Western classes only.

**<u>SHOW COMMITTEE</u>**: The show committee reserves the right to cancel or split classes; limit class size; change arenas; limit the number of rides and the number of horses per rider; and cancel or add judges. The show committee also reserves the right to refuse any entries.

**PONY CLASSES**: Pony classes are for ponies that do not exceed 148cm in height without shoes, or 149 cm with shoes.

<u>MUSICAL FREESTYLE</u>: No minimum score requirement. Please don't forget to bring your music on a CD formatted as WMA or MP3 or email your music to <u>gvdsshowsecretary@gmail.com</u>. Sound check times will be posted in the show office.

**MATERIALE CLASS:** Judged as a group on the rail at walk, trot and canter, both directions. Judging is on the horse.

**DRESSAGE SEAT EQUITATION:** Judged as a group at medium walk, working trot (sitting and rising) and canter both ways of the ring. Minors (17 and under) may not ride stallions.

<u>RIDE TIMES:</u> To accommodate as many rides as possible each day, the 20m x 40m short court will be used if there are significant numbers of English Introductory and/or Western Introductory and Basic Level entries. If the short court is used, non-Introductory and Basic classes will be held in the 20m x 60m full court arena and will be held first both days. The short court classes will follow later each day. There is no guarantee that the full court rides will only be in the morning and the short court rides will only be in the afternoon. All freestyles will be held in the 20m x 60m ring. Provisional ride times will be available at the <u>GVDS website</u> and will be emailed to those entrants who provide a valid email address. Official times will be posted at the show office. It is the exhibitor's responsibility to check the official ride times at the beginning of each day of the show.

**<u>SUBSTITUTION</u>**: Substitution of rider, horse, ride time or class will be made only at the discretion of show management and will require a fee of \$10.00 per test in addition to the Change Fee.

**SCHOOLING (OUT OF COMPETITION) HORSES:** A horse may be brought to the show but must be registered on an entry form, with signatures and the office fee per horse/rider and any other appropriate fees (i.e. stabling, etc.) paid. Bridle tags must be worn on the horse whenever it is out of the stall. Areas where they may be ridden or hand walked may be restricted, and priority given to horses in competition. Check with the show office for details.

**<u>MINIMUM SHOW ATTIRE</u>**: Helmet, boots with heels, and clean clothes (gloves and breeches would be appreciated but are not mandatory).

**HORSE TACK**: Tack must follow USEF rules regarding acceptable tack. Disciplines may not "mix-n-match"; polo wraps/boots allowed. Please address any requests for exceptions with show management prior to riding your test. Our goal is to direct all riders toward using correct equipment. <u>Only with the permission of competition</u>

management may a horse/rider combination enter a class Hors de Concours (HC). Such entries must pay the full entry fee but scores for these entries will not be published or recorded, nor shall they count towards any prizes, placings, or Year-End awards.

**NEW as of 10/01/2023**: Junior dressage riders (13 and under) who want to ride in GVDS Schooling Shows only and in only Introductory classes using non-USDF/WDAA approved tack, may request approval by the show management to ride in alternate tack. Show management will, on a case-by-case basis, determine if the alternate tack is deemed necessary to increase safety for the child. The alternate tack must be presented in the horse show office before competing in a class. Riders must enter the Introductory class as HC (Hors de Concours) so the score sheet can be flagged for the judge. Although the child will be classified as an "HC rider" for the show and may earn a ribbon in their class, they will be ineligible for the High Score Introductory Rider for the show. *Scores earned will be eligible for year-end awards*.

**USEF HELMET RULE:** Per USEF DR 120.6, and GVDS' insurance, all classical dressage riders and anyone under age 18 regardless of western or classical discipline mounted on a horse on the competition grounds, which includes non-competing riders, must wear properly fitted protective headgear. The Western Dressage Association of America (WDAA) rules (applicable to all Western Dressage classes) encourage but do not require wearing of protective headgear. If an exhibitor chooses to wear protective headgear, they will not be penalized. GVDS Management strongly encourages all exhibitors to wear protective headgear, however we understand that not all western dressage exhibitors choose to wear this headgear. Therefore, ALL western dressage riders must execute a waiver of liability. This releases GVDS from all liability pertaining to non-use of protective headgear for any western dressage exhibitor should they choose not to wear protective headgear. No western dressage bridle tags will be released until the waiver is executed.

**SHOW OFFICE:** Office will be open from 1:00 pm to 5:00 pm on the day prior to the start of the show and one (1) hour prior to the first class each day of the show; as well as 30 minutes following the last ride each day.

**<u>REFUNDS</u>**: Up through the closing date, all fees refunded except office fee will be refunded. From the day after closing to August 22, 2024, class fees will be refunded only if ride(s) can be filled from wait list. Stabling fees will be refunded if cancellation is on or before August 22, 2024. During competition days **no refunds including Acts of God. Office fee is non-refundable.** <u>The two (2)-bag shavings minimum (\$20) and any pre-ordered shavings are non-refundable.</u>

**<u>SHARPS CONTAINERS</u>**: Sharps containers will be available in the stabling area. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.

**GVDS YEAR-END AWARDS:** Exhibitors MUST be a current RMDS/GVDS member or a GVDS Associate PRIOR to entry for scores to qualify. See <u>www.GVDS.org</u> for GVDS Year-End Awards rules. Horse owners must also be RMDS/GVDS members or GVDS Associates to be eligible for year-end awards. <u>Riders in the GVDS Dressage</u> <u>Team Challenge must be declared with the GVDS Points Chairperson, Rhiannon Rowe, prior to the start of the show for scores to count. See <u>GVDS Awards Program for rules.</u></u>

<u>GVDS YOUTH SCHOLARSHIP RECIPIENTS</u>: Scholarship Recipients must enter their applicable show entry or show fee credit on their entry form. Additionally, Scholarship Recipients must schedule their two (2) show assistance hours with the Show Manager, Pat White <u>pwhite9882@aol.com</u> or Volunteer Coordinator, Barbara Progress, <u>starman7@comcast.net</u>.

**AWARDS:** Ribbons awarded 1<sup>st</sup> through 6<sup>th</sup> place. Overall High Score and Reserve High Score will be awarded each day for the English dressage classes (classes 101-119, 201-219). Overall High Score and Reserve High Score will be awarded each day for the Western dressage classes (classes 133-160, 233-260). Separate Introductory High Score Awards will be presented each day for English (classes 101-103, 201-203) and Western (classes 133-

136, 233-236); no Reserve Introductory High Score Awards will be presented. HC riders in the Junior (13 & under) Introductory classes will not be eligible for the Introductory High Score award. **High Score competitors** are responsible for having awards picked up or shipped if they are not present at the time the awards are presented/announced.

<u>TIES</u>: In the event of a tie, the total of the collective marks will determine the placing. If the tie remains, then the tie stands.

**<u>STABLING</u>**: Permanent 10 x 12 and 12 x 12 stalls with full doors; bedding required and 2 bags will be provided with initial stall purchase, if stall ordered at time of entry. Additional bags of bedding may be ordered. Stabling available at noon on Friday, August 23, 2024 unless prearranged. Stalls DO NOT need to be cleaned or cleared after the show.

<u>ARENAS:</u> Competition arena is the larger of the two covered arenas at the facility which is a 20m x 60m covered arena with sand/dirt footing. <u>A short court arena, 20m x 40m</u>, **may** be used for Introductory, Pony Club classes and Western Dressage Introductory and Basic level classes. Use of the short court arena will be posted at the show office. Warm-up arena is also a large covered arena with sand/dirt footing located next to the competition arena. Both covered arenas watered and worked throughout the show. Lunging area will be posted. Show arena open for schooling Friday afternoon/evening until show office closes. <u>Exhibitors may hand</u> walk horses around the exterior of the show arena 30 minutes prior to the start of the show and during the lunch break.

**DOGS:** Dogs are welcome but must be leashed, held by a human or tied securely at all times.

**DIRECTIONS:** From East of Grand Junction: Take I-70 Westbound to Exit 37 (Clifton, I-70 Business Loop Exit) and proceed South to the second stop light (32 Rd, Hwy 141) and turn left. Stay on this road until it ends at the junction with Highway 50 (approximately 5-6 miles). At this junction, turn right and proceed 3.5 miles on Highway 50. You will see the Mesa County Fairgrounds on your left. At the Fairgrounds sign, enter and immediately turn left and follow the road towards the barns.

From West of Grand Junction: Take I-70 Eastbound to Exit 26. Turn right off the exit ramp onto Highway 6 & 50. Stay on Highway 50 as it winds through town. Turn right at Fifth Street at the sign for Highway 50 to Delta. Follow Fifth Street as it goes over the Colorado River and continue 2.3 miles. You will see the Mesa County Fairgrounds on your right. At the Fairgrounds sign, enter and immediately turn left and follow the road towards the barns.
