Health Requirements: By Texas law, each horse entering the state of Texas must have a <u>CURRENT 21 day HEALTH CERTIFICATE</u>, issued by a licensed veterinarian. Any horse entering the grounds must be <u>accompanied by a negative Coggins</u>, issued within the last twelve months for all horses. Any horses showing illness will be asked to leave the show grounds.

Directions: Take Hwy 249 to Decker Prairie, and head west on Decker Prairie. Turn left at stop sign and follow Decker Prairie-Rosehill Road past Peden Road to side entrance of facility.

Rules and Regulations

All participants MUST have signed releases.

Entries: Entries must be postmarked no later than the entry deadline. If entries received are postmarked after the closing date, it will be subject to a \$15.00 additional entry fee per horse. Those entries postmarked after closing will be accepted at the discretion of the show management, based on a space available basis and charged a \$15 post entry fee. All entries must be completed on an official entry form for this show and have attached a valid check or payment conformation for the total amount of class entry fees, stall fees, and grounds fees.

Entries may be emailed but must be completed and monies received. Any entries received without payment will not be valid. A horse may only be entered under the legal name of the owner. Each horse/rider must be entered on a separate entry form. In addition to entries of persons suspended or expelled from US Equestrian Federation, a Recognized competition may refuse any entry of an exhibitor or the participation of an agent, trainer, rider, or handler who has shown an objectionable attitude towards a Recognized competition or previous unsportsmanlike behavior at a Recognized competition or its management. NSF and returned checks will be charged a \$50 fee.

Non-competing Horses:

Non-competing horses are welcome on a space available basis. They must have an entry form with signed releases, a current coggins, health certificate and pay non-compete/schooling fee, office fee per show, and stall fee. Non-Competing horses must wear a number when out of stall.

Classes: Classes will be run and adjudicated based on the current USEF/WDAA Rulebook. All decisions made by the Judge and/or Show Management are final and cannot be protested. Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason including but not limited to unsportsmanlike conduct and animal cruelty. **Stalling Information**: Stalls are 10X10 with crushed granite floors. Tack stalls are available. No stalls may be used without payment of appropriate fees. Stalls will be considered reserved only when entry form and appropriate monies are received. Wash racks are available.

Ride Times: Ride times will be emailed to the exhibitors prior to the show and will be posted on the software.

Awards: Ribbons will be awarded 1st through 6th places. No paybacks in classes. Judging, class specifications and conduct shall be in accordance with the current USEF/EC/WDAA Rulebook. All decisions made by the Judge and/or Show Management are deemed final and cannot be protested. Champion and Reserve Champion awarded to horse and rider combination with the highest score at Intro, Basic, and First Level and above for Open and ATR.

Arenas/Footing/Warm-up: We have two covered and one outdoor ring. All arenas have state of the art, European footing with permanent irrigation system. We have two lunging arenas with the same footing and our Field Arena has multi-layered base with grass.

Concessions: The facility offers a concession stand & restaurant.

Children/Pets: We welcome well-mannered dogs on leashes; however, loose dogs will be impounded and will incur a \$100.00 fee which is donated to the local humane society. Children must be adult supervised at all times and remain courteous. Unruly dogs or children will be asked to leave the show area for the protection of exhibitors.

Hazardous Weather/Act of God/Accident Policy: Management reserves the right to cancel any classes due to hazardous weather, Acts of God, accident, or emergency. Every effort will be made to reschedule with priority given to any qualifying classes being offered. No refunds for cancellations/rescheduling due to hazardous weather, Acts of God, accidents, or emergencies.

Cruelty or Abuse: Cruelty or abuse of horses is strictly forbidden on the show grounds. Submitting a signed entry constitutes acceptance of this provision.

Discipline: Any act of dishonesty, discourtesy or disobedience to horse show officials on the part of the owner, trainer, or rider will disqualify the horse and exhibitor from adjudication. The show management reserves the right to remove such a person or persons from the show without being liable for compensation or damages.

Entry Refunds: Prior to the closing date, withdrawals accompanied by a Veterinarian's Certification of Inability to show will receive a refund of all fees except office fees. After the closing date only stall fees will be refunded. No refunds after the start of the show. Affirmation of the United States Equestrian Federation Helmet/Vest Rule: GR801.4 Dress Any exhibitor must wear protective headgear (ASTM/SEI) and/or a protective safety vest, specifically designed for use in equestrian sport in any division or class without penalty from the judge. The Federation recommends that the vest meet or surpass the current ASTM standard or be certified by the Safety Equipment Institute. Helmets are strongly encouraged during all schooling and required when showing. Juniors are required to wear helmets at all times. Western hats may be worn for Western dressage.

ATTENTION COMPETITORS: Each competitor is responsible for supplying management with the correct association numbers (WDAA) for the horse, owner, rider, and trainer, before the day of the competition. The scores of competitors who fail to supply correct numbers may not be eligible to be entered toward regional or national awards.

Amateurs: Every rider or driver having reached his 18th birthday prior to December 1, 2023 must have in his possession a US Equestrian Federation Amateur card to make application for such card at least two hours prior to riding in Amateur designated class. Applications may be secured at the Show Office.

Safe Sport: Only adult trainers, riders, handlers, and owners who are USEF members must complete Safe sport Training prior to the start of the show. No one will be allowed on the show grounds without proof of training and horses will not be able to compete until this is completed. This show does not require USEF membership so if you are not a member you do not need Safe Sport training. Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org. Entries are restricted for USDA confirmed Vesicular Stomatitis Affected Counties and will not be accepted. This restriction also applies to any horse which has been in a VS Affected County within 14 days prior to the start of these competitions.

Warning: Under Texas Law (Chapter 87, Civil Practices and Remedies Code), a livestock show sponsor or farm animal activity sponsor is not liable for an injury to or the death of a participant in livestock shows resulting from the inherent risks of livestock show activities.

All rules are in effect and will be enforced from the time a competitor arrives on the show grounds. Competitors, Trainers, Coaches and Owners are responsible for knowing WDAA rules, and updates.
