 - All Tests and Levels - Standard Arena (20x60)
- * **Combined Tests - Classes 36 - 41:**
 - Includes Dressage and Show Jumping
 - Pre-Amoeba - USDF Intro Test A, 12" SJ
 - Amoeba - USDF Intro Test B, 18" SJ
 - Tadpole - USDF Intro Test C, 2' SJ
 - Beg. Novice - USEF Eventing BN Test A, 2'6" SJ
 - Novice - USEF Eventing Nov. Test A, 3' SJ
 - Training - USEF Eventing Training Test A, 3'3" SJ

- * **3 Phase - Classes 22 - 25:**
 - Includes Dressage, Show Jumping and Cross Country

- * **Show Jumping - Classes 26 - 35:**
 - Division - Both Course A and B
 - Ground Poles and W/T Crossrails will run both classes as Table II - Red/Blue Classes.
 - Horse and Rider combos entering Groundpoles and/or W/T Crossrails may not cross enter into any other heights. For Walk Trot Riders Only.
 - Open Crossrails and 18" will run both classes as Table II Sec. 1 - No Jump Off
 - All Classes 2' and above will run as follows:
 - Course A - Table II Sec. 2(b)
 - Course B - Table III
 - Show follows USEF Jumper Rules regarding horse welfare and rider safety. Please review these rules at USEF.org. Failure to comply can and will get riders a warning or elimination. Eliminations will result in forfeiting entry fees for disqualified classes.

- * **Ribbons:** Ribbons are awarded through 6th place for each class. Champion ribbons will be awarded for High Score Dressage, Low Score Event, Low Score CT and Jumper Divisions.
- * **Non Competing Horses:** \$15 grounds fee plus the Office Fee.
- * **Haul In Fee:** Applicable to any horse NOT stabled at Littles Crossing or Iron Star Equestrian.
- * **Late Entry Fee:** A late entry is an entry postmarked or received via email after the closing date. A late entry must include a \$25 Late Fee. Late entries accepted only if space allows.
- * **Coggins:** Negative Coggins within 12 months is required for all horses. Include with entry for each show.
- * **Lunging:** No Lunging in any of the arenas. Lunging is permitted in grass areas not being used for show purposes.
- * **Dogs:** Absolutely NO DOGS ALLOWED. You will be asked to remove the dog if it is found on the show grounds.

NWFL DSDCTA and Littles Crossing/Iron Star Equestrian Horse Show Stay Safe Protocol

- * Pre-Entries are REQUIRED. To reduce congregation at the secretaries desk, we ask that each barn send one representative to pick up show numbers and competitor packets.
- * We will limit the number of people permitted at the secretaries desk at a time.
- * Disinfectant will be provided at the in-gate of the showing arenas, porta-potty and secretary desk.
- * We ask that all spectators practice social distancing.
- * We encourage everyone attending the show to wear a mask in public places where social distancing cannot be done.
- * In the event of rain, you will be asked to shelter in your vehicle.
- * All awards will be made available at or near the secretaries desk.
- * Trainers will be held responsible for their barns, ensuring compliance with all rules and regulations.
- * Grooming/Tacking is to be done at the trailer and there will be two hoses available at the covered arena for water and horse rinsing. DO NOT use the wash rack behind the stable at Littles Crossing/Iron Star Equestrian.
- * There may be a posted order of go for cross country and jumping classes.
- * Anyone exhibiting symptoms of illness are NOT permitted to attend the show.
- * Any individual not in compliance with these regulations will be asked to leave the grounds and not return.
- * Concessions will not be available. Water will be available at the secretaries desk and show arena in-gates.
- * Management reserves the right to change any rules or protocol at any time deemed necessary.
