RULES AND INFORMATION

1. All Pomona Chapter Dressage Shows and every class offered herein are covered by the rules and specifications of the current USEF Rule Book and will be conducted and judged in accordance therewith.

2. **ENTRY PROCEDURE:** It is preferred that entries be submitted online at <https://entry.foxvillage.com/>. Paper entries will be accepted but they must be made on the entry form in **this** prize list and must be filled out completely, including all classes entered, all signatures, organization membership numbers and fees. Make copies of both sides if you need more than one entry form. Only one horse/rider combination per entry form.

3. **MEMBERSHIP REQUIREMENTS:** CDS membership is only required for entry into classes 111 through 194. The rider, owner and trainer **must** be members of the California Dressage Society. **Please include a photocopy of current CDS membership card.** Neither WDAA nor CAWDA membership is required for entry into western dressage classes. **Failure to include required proof(s) of membership with entry will incur a \$15.00 membership verification fee.**

4. **PROOF OF VACCINATION:** Proof of vaccination for Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) within six months of entering the show grounds is required for all horses. Proof of vaccination must be on 1) the US Equestrian Vaccination Record (available at <https://www.usef.org/forms-pubs/xUbu-pT8eLM/equine-vaccination-record>), 2) the vaccination record from the horse's passport or 3) a complete copy of a report from the administering veterinarian may be provided, if it includes the name of the veterinarian, the name of the horse (the name on the entry), the name and lot number of the vaccination and the date administered. See the USEF Rulebook (GR844) for the specific requirements. Please bring the original records to the show in case there are questions. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management.

5. Entries are accepted on a first-come, first-served basis until classes are filled. All entries received after the closing date will be accepted only if the schedule permits. Each late entry shall be assessed a late fee of \$35.00. Any entry changed after the closing date will be accommodated at Horse Show Management's sole and absolute discretion and will incur a \$35.00 change fee. Riders will ride with their classes, unless riding multiple horses, in accordance with Federation rules. Each competitor is responsible for supplying Horse Show Management with Rider's full name and CDS number; Horse's name; Owner's full name and CDS number; Trainer's full name; Coach's full name (if applicable) & copies of each applicable membership card, BEFORE the day of competition. The scores of competitors who fail to supply correct numbers may not be counted toward year-end awards (see CDS Omnibus).

6. **CONDITION OF ENTRY:** Every horse entered for competition will be under the control of the Horse Show Management, but the Horse Show Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show; its Directors and Employees, and CDS Pomona Chapter; its Directors and Employees, harmless for any loss or accident, to his horse, horses or equipment which may occur from accident, sickness, fire or otherwise.

7. **CLOSING OF ENTRIES:** All entries close on **July 19, 2024**, (the "Closing Date"). Entries are accepted on a first-come, first-served basis until classes are filled. Mail-in entries must be postmarked on or before the closing date. Electronic entries must be received not later than midnight on the closing date. All electronic entries received and all mail-in entries postmarked after the closing date will be accepted only if the schedule permits. Each late entry **received after July 19, 2024** shall be assessed a late fee of \$35.00.

8. **REFUSAL OF ENTRIES:** Horse Show Management reserves the right to refuse, accept conditionally, or cancel any entries of any exhibitors.

9. **REFUNDS, CHANGES AND SCRATCHES:** Scratches made prior to the closing date will receive a refund, less the office fee. It is the rider's, owner's or trainer's responsibility to inform the Show Secretary via email, text or telephone call of their intention to scratch. **Absolutely no refunds for scratches after the Closing Date.** Class changes or additions will incur a \$35.00 change fee and will be made only at the discretion of Horse Show Management.

10. **RETURNED CHECKS:** Checks returned by the bank for any reason will be charged an additional 10% penalty (\$25.00 minimum). Accounts will be given ten (10) calendar days to be paid in full with cash or cash equivalent or they will be turned into CDS for further disciplinary action.
11. **RESPONSIBILITY:** All owners will be held responsible for any damage incurred by them, and their agents or employees, to buildings and other properties on the show grounds, and shall be handled accordingly.
12. **DISCIPLINE:** Exhibitors are warned that any act of discourtesy or disobedience to the officials of this show by the owner, exhibitor, agent, lessee, trainer, coach, groom, rider, handler or family of the above, will result in disqualification of the horse from the show. The Horse Show Management reserves the right to remove a horse, owner, exhibitor, agent, lessee, trainer, coach, groom, rider or handler from the show without being liable for compensation or damages.
13. **MANAGEMENT:** The Horse Show Management reserves the right to interpret all questions and conditions with regard to or arising out of incident to the show without claims for damages or recourse of any kind. All questions not covered in these rules and regulations shall be decided by the Horse Show Management, with their decision to be final. The Horse Show Management reserves to itself the right to: refuse, accept conditionally or cancel any entries, disqualify riders or exhibitors, prohibit entries and cancel award prizes without claim for damages, cancel or combine any classes, reschedule classes and rotate judges in order to facilitate the time schedule.
14. **CANCELLATION:** In the event of rain or inclement weather prior to the show, it is the competitor's responsibility to call the Horse Show Management to determine whether the show is canceled. Shows are not canceled due to rain unless footing is deemed unsafe. If this show is canceled for any reason, a \$40.00 per day fee will be retained from each entry fee.
15. **SHOW OFFICE:** Exhibitors are encouraged to check-in promptly upon first arrival on the show grounds. The show office will open approximately 2 hours before the start of the show and until approximately 1 hour after the last ride of the day. Horse Show Management can be reached at (657) 688-2032.
16. **TESTS:** Current USDF, USEF, USEA, FEI and WDAA tests will be used. FEI and Musical Freestyle tests are offered. Leadline test(s) are posted on the chapter website.
17. **SCORED TESTS** will only be distributed to riders, or their authorized representatives, after the results have been finalized for the class and the awards presented. The winner of each class is the competitor having the highest total points. Ties will be broken as stated as stated in the USEF Rulebook (DR123.3 or WD127.3).
18. **READING TESTS:** Reading tests is acceptable at our shows as stated in the USEF Rulebook (DR122.1 and WD126.1). Readers should be a MINIMUM of 6 feet away from any perimeter of the dressage court. Readers may stand near "E" or "B," but if two courts are present then the reader should stand OUTSIDE the fence as to be at least 6 feet away from the perimeter of the court.
19. **NUMBER OF TESTS:** Horses may compete in no more than one Recognized Competition on the same day(s) and are limited to a maximum of three Dressage rides per day at Fourth Level and below or two Dressage rides per day above Fourth Level. Dressage Seat Equitation and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.
20. **RIDE TIMES:** Ride times will be available on the Chapter website (www.cdspomonachapter.org) or at <https://foxvillage.com/> by the Wednesday of the week of the show. Please call Show Management for times if you are unable to access the website. Ride times will also be posted on the show grounds at the show office during the show. Be sure to check your times at the show office on the morning of the show to make sure nothing has changed.
21. **RIBBONS & AWARDS:** In each class, the first place winner will receive an award. Ribbons are given first to fifth place for each division (Open, Adult Amateur and Junior/Young Rider), except for the Young Horse classes.
22. **JUDGES:** If for any reason a judge fails to attend the show or to perform his duties, the Horse Show Management reserves the right to substitute a judge of the same or higher rating for one who was officially designated in the Premium.
23. **JUNIORS:** All minors/juniors must be supervised by their parent/guardian or authorized agent while at or on the show grounds, whether riding or on foot. The parent/guardian or authorized agent shall assume all responsibility to protect juniors from any injury, damage, harm and/or loss and shall identify, defend and hold CDS, USDF, USEF and Horse Show Management harmless there from. **All juniors must wear properly fitted protective headgear (ASTM/SEI) while riding anywhere on the showgrounds. The harness must be secured and properly fitted. It**

is the responsibility of the rider, or the parent or guardian of the junior exhibitor, to see to it that the headgear worn complies with appropriate safety standards for protective headgear intended for equestrian use and is properly fitted and in good condition. Horse Show Management and licensed officials are not responsible for checking headgear worn for such compliance. CDS, USDF, USEF makes no representation or warranty, express or implied, that any protective headgear and cautions riders that death or serious injury may result despite wearing such headgear as all equestrian sports involved inherent dangerous risk and as such no helmet can protect against all foreseeable injuries.

24. **ADULT & JUNIOR / YOUNG RIDERS:** Individuals are eligible as Juniors until the end of the calendar year in which they reach the age of 18. Individuals are eligible as Young Riders from the beginning of the calendar year in which they reach the age of 16 until the end of the calendar year in which they reach the age of 21. Competitors shall compete as adults from the beginning of the calendar year in which they reach the age of 22. You must specify on the entry which section you are entered in A (Am) or J (Junior)/Young Rider (YR).

25. **LEADLINE CLASSES.** Leadline classes are limited to riders ages 3 to 10.

26. **DISPENSATION/CLASSIFICATION CERTIFICATE:** All entries into classes 261 (FEI Para Test-of-Choice) and 262 (FEI Para Dressage Freestyle Test of Choice) must provide a copy of their Dispensation/Classification Certificate from the USEF Adaptive Sports Committee (see DR119.12-119.14). This requirement also applies to those individuals with a current Federation or FEI Classification who wish to use approved compensatory aids in any 100, 300, 400 or 500-series class (see DR311). The Dispensation/Classification Certificate will list all compensatory aids and adaptive equipment allowed the individual while competing. Other compensatory aids or special equipment not specifically listed on the Dispensation/Classification Certificate are not allowed. A copy of the Dispensation/Classification Certificate must be included with the individual's entry. The show secretary will include a copy attached to all applicable scoring sheets for the judge's reference. For instructions on how to apply for the Dispensation Certificate, please refer to USEF Rule GR1312.

27. **WDAA STATEMENT OF ELIGIBILITY FOR EXCEPTIONAL RIDER CLASSES.** All entries into class 180 (Western Dressage Therapeutic Riding Class) must provide a completed copy of the WDAA Statement of Eligibility for Exceptional Rider Classes. Class 180 is open to individuals with a diagnosed physical, social, or emotional disability.

28. **UNRATED CLASSES:** CDS only recognized shows may offer unrated classes including but not limited to USDF Intro tests, USEA eventing tests and Western Dressage tests. The mandatory helmet rule shall apply. Riders and horse owners in unrated classes at CDS only recognized shows are exempt from the CDS non-member fee but must complete the CDS non-member information form.

29. **DRESSAGE SEAT EQUITATION:** Junior/Young Rider class open to those riders 21 years and under. Adult Amateur class is open to adult amateur riders 22 years and older. This is a rail class. Multiple horses/riders will be in the ring together.

30. **TEST OF CHOICE CLASSES:** Horse/rider combinations may enter each Test of Choice class (161, 162, 181, 182, 261,262, 351, 352, 441, 481, 518, 672 and 698) a maximum of two times and the two tests must be different and are limited to adjacent levels. The provisions of DR119.2 and WD102.2 apply. For USEA tests, they are equivalent to USEF dressage tests are shown in the following table.

31. **PAS de DEUX:** Riders may compete in costume (boots and helmet still required) for this class only.

32. **STABLE AVAILABILITY:** No stabling is available at this show. All entries must pay the Haul-In Fee.

33. **SHARPS CONTAINER LOCATION:** The sharps container will be located in the show office.

34. **ARENA DIMENSIONS AND FOOTING:** Show arena is 20 m x 60 m. Show arena will be shortened to 20 m x 40 m for USEF Introductory, USEA Beginner Novice, Novice and Training classes, WDAA Introductory and Basic Level classes and all Leadline classes. A warm-up arena of at least 150 ft x 80 ft is provided. Footing consists of mainly sand and DG in the show arena and in the warm-up arena. Only those horses entered in the show are permitted use of the show facilities, warm-up arena and show area. All horses on the show grounds must wear competition numbers. No lunging in the warm-up arena.

35. **DOGS:** All dogs must be on a leash. No exceptions.

36. **PARKING:** Please note that only vehicles with horse trailers are allowed to park inside of the gates. All “solo” vehicles (that is, not hitched to a horse trailer) are asked to park outside of the gates nearest the show arena. There is a limited amount of available horse trailer space and we want our show to be safe and competitor friendly. In addition, we must have clear access for emergency vehicles. There is a limited amount of parking near the show office for those with special needs. Prior arrangements must be made with the Horse Show Management. *Thank you in advance for your cooperation in making this a safe and competitor friendly show.*

37. **DAILY HIGH POINT AWARD:** Daily High Point Awards will be given to the horse/rider combination that earns the highest score. High Point Awards will be given in the following categories:

- a. Dressage, Open Division
- b. Dressage, Adult Amateur Division
- c. Dressage, Junior/Young Rider Division
- d. Western Dressage, Open Division
- e. Western Dressage, Adult Amateur Division
- f. Western Dressage, Junior/Young Rider Division

Dressage scores may be earned from First Level through Grand Prix tests. Western Dressage scores may be earned from Level 1 through Level 5 tests. Scores earned at Intro and Training Level (Dressage), Intro and Basic Levels (Western Dressage) and all freestyle tests will not count towards high point awards.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals. Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved. The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed. Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life. While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival. As an educational organization, USDF has numerous programs, which teach people how to pursue accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

** Non-competing horses must pay the Non-Competing Horse Fee (\$30), the Office Fee (\$40), the Grounds Fee (\$30) and the CDFA Durg Fee (\$14).

If not specified as Open (O), Adult Amateur (AA) or Junior/Young Rider (JR/YR) on the entry form, you will be entered in the OPEN division.

PROTECTIVE HEADGEAR

From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.

Regional Adult Amateur Competition

MISSION: The mission of these competitions is to provide an opportunity for all CDS Adult Amateur riders to qualify and com-pete against others of similar skills and experience. The regional nature of these shows will help to provide our membership with a developmental path for gaining competitive experience, promote excellence and increase awareness of and support for the Chapters.

GOALS:

#1 – For the Chapters: These regional or “mid” level adult amateur competitions are designed to promote and enhance awareness and participation by the CDS Chapters, provide State level support in funding and advertisement, and a chance to generate funds at the chapter level.

#2 – For the Riders: These competitions will provide a positive “introductory” show experience for some, which will hopefully be a stepping stone to bigger things, while offering the other more experienced amateur riders a warm-up for the Championship Show.

#3 – For the Whole Organization: These competitions are designed to bridge the gap between the local chapter shows with individual year end awards programs and the tremendously difficult, top caliber competition at the Annual CDS Championship Show.

LOCATIONS: Three Regional CDS Chapter Adult Amateur Competitions will be held each year, one in each of the regions as defined in the CDS bylaws; north, central and south.

ELIGIBILITY:

- Participants at the RAAC shows must be current members of CDS, must have a USEF Amateur Card under Dressage Rules, and must be 22 year of age or older.
- The horse owner must be a current member of CDS.
- Qualification is for an amateur rider/horse team.
- To be eligible to compete, the **\$25 registration fee for each horse and rider team per level MUST BE PAID to the CDS Central Office by close of business no later than 12 days prior to the first day of competition at the regional show entered.**
- Scores earned before paying the fee will count provided the payment is received at the Central Office prior to close of business as specified above.
- **2024 Qualifying Opens: August 28, 2023 at any show with CDS recognition.**
- 2024 Qualifying Closes: 12 days prior to the first competition day of the regional show entered.
- Scores earned at the CDS Championship Show will NOT count towards qualification.
- Horse/rider teams who qualify MAY compete in ONLY ONE regional competition

Qualification scores must be earned at CDS recognized shows and are as follows, scores can be earned at any test of the level:

- 3 scores from 2 judges at Introductory C of 65% or higher, USDF Intro C only, Novice only
- 3 scores from 2 judges at Training Level of 60% or higher, any test
- 3 scores from 2 judges at 1st level of 60% or higher, any test
- 3 scores from 2 judges at 2nd level of 60% or higher, any test
- 3 scores from 2 judges at 3rd level of 60% or higher, any test
- 3 scores from 2 judges at 4th level of 60% or higher, any test
- 3 scores from 2 judges at PSG of 60% or higher
- 3 scores from 2 judges at Int-1 of 60% or higher

Elite horse and rider teams that have won either Champion or Reserve Champion at the CDS Annual Championship Show at Training, and 1st Levels are not eligible to compete in the RAAC shows at that level.

Elite Adult Amateurs for riders that have competed in a CDS Championship Show.

Novice: Adult Amateurs for riders who have never competed in the CDS Championship Show.

ROSES Award neck ribbons will be awarded in three divisions for the High Percentage Elite and Novice Rider 50 years of age and older who officially sign-up for the division prior to their RAAC ride. Divisions: Basic through First; Second through Fourth; and FEL.

2024 YEAR-END AWARDS QUALIFICATIONS

To be eligible for any Pomona Chapter Year End Awards, the rider must comply with the following:

- Be a Pomona Chapter active member in good standing at the time the scores are earned OR pay a nominating fee of \$35 to the Pomona Chapter. The nominating fee allows non-Pomona Chapter members to be eligible for year-end awards. The fee must be paid on or before the final show of the competition year (our Midsummer Days Dressage show).
- Donate four hours of volunteer service are required for each horse/rider combination (ie) a rider showing 3 horses must have a total of 12 volunteer hours to be eligible for CDS Pomona Chapter Year End Awards. These hours can be obtained by donating time to volunteer/staff horse shows, being an elected member of the Board, being appointed to one of the numerous committees, or by providing \$100.00 cash donation (equivalent to four (4) hours of service) to the Chapter on or before of the final show of the competition year (our Midsummer Days Dressage show). Hours can only be donated to a rider by an immediate family member or the owner of the horse that is being ridden.
- The Champion horse/rider combination at any given level may NOT be won in two (2) consecutive years. The Reserve Champion horse/rider combination at any given level is eligible to compete for Championship at the same level in consecutive years.
- For Introductory through Fourth Level, the horse/rider combination must compete at a MINIMUM of two Chapter recognized shows and obtain a MINIMUM of three scores at the same level/division. For Prix St. Georges through Grand Prix, the horse/rider combination must compete in a MINIMUM of two Chapter recognized shows and obtain a MINIMUM of two scores at the same level/division. The scores will be averaged, and the highest percentage will be Champion, the second highest percentage will be Reserve Champion in each division, as described above.
- Dressage Seat Equitation Awards are available as Adult Amateur and Junior/Young Rider and based on RIDER ONLY. The rider must compete at a MINIMUM of two Chapter recognized shows and obtain a MINIMUM of two scores in the Dressage Seat Equitation classes offered at any Pomona Chapter recognized show. The scores will be averaged, and the highest percentage will be Champion and the second highest percentage will be Reserve Champion.
- Season High Score Awards are available to Open, Adult Amateur or Junior/Young Rider. Prior year Pomona Chapter Champion and Reserve Champion at a given level may win a Season High Score Award at the same level in successive years.
- Horse/rider combinations are only eligible for awards in consecutive levels (i.e. Training and First, but not Training and Second)

These changes will increase membership involvement in the day-to-day running of the Chapter and give each competitor a fair opportunity for an award.

The WDAA Horse Lifetime Points & Awards program tracks points achieved by a horse throughout their Western Dressage career.

Points must be earned at WDAA recognized shows.

Open to all horses, ponies and mules regardless of breed, type, age, etc.

Points may be earned with more than one rider.

Owners and persons participating and/or riding a horse in the program must be current WDAA members in good standing.

Points awarded at all WD levels and Freestyle test, as well as for rail classes.

WDAA World Championship Show test/classes earn triple points.

USEF shows with a USEF-licensed Western Dressage judge earn double points. Check the WD judge directory on the WDAA home page under "Important Links" to see whether your judge qualifies for double points.
