## DSDCTA Dressage/CT/Jumping Show Class Details, Fees, and General Information

- **Show Start Time – 0800**
- **Dressage Tests - Arena Size:**
  - CT Tests (20x40)
  - Intro/Basic/Training (20x40 or 20x60 depending on number of rides – ring size will be announced with schedule)
  - First Level and above, Musical Freestyles (20x60)
- **Combined Tests** (Classes 30-36):
  - Includes Dressage and Show Jumping
  - Puddle Jumper – USDF Intro Test A
  - Pre-Amoeba – USDF Intro Test A
  - Amoeba – USDF Intro Test B
  - Tadpole – USDF Intro Test C
  - Beginner Novice thru Adv. – USEF Eventing Test A (unless you request Test B)
  - Show Jumping: Puddle Jumper – Groundpoles, Pre-Amoeba – 12”; Amoeba – 18”; Tadpole – 2’; Beginner Novice A – 2’3”; Beginner Novice B -2’6”, Novice – 2’9”; Training – 3’3”; Preliminary – 3’6”
  - CT Show Jumping Course A
  - If you need a specific Test/Height combination-we are happy to accommodate, please annotate on entry.
- **Leadline Class:** Request test from Show Secretary
- **Show Jumping Classes** (Classes 37-43)
  - Show jumping division – both course A and B
  - Show Jumping course A – only riding course A (clean round with jump off)
  - Show jumping course B- only riding course B (fastest time)
- **Stabling:**
  - Day Stabling: \$25 per day
  - Weekend Stabling: \$40
- **Attire:**
  - Neat and tidy. Anyone mounted must wear protective headgear. Boots/shoes worn while riding anywhere on the competition grounds should have a distinguishable heel. **ASTM hard hats/helmets required when mounted.**
- **Equipment and Tack:**
  - We will adhere to USEF equipment and tack requirements. Improper equipment/tack could result in disqualification.
- **AQHA RECORDING INFORMATION:**
  - Include on entries the following:
    - Horse Registration #
    - Horse Registered Name
    - Rider/Owner Member #
- **Ribbons:** Ribbons are awarded thru sixth place for each class. Ribbons will be available in the show office.
- **Non-Competing Horses:** \$15 Grounds Fee.
- **Change Fee:** \$15 for any changes after entry submitted (e.g. rider or horse change, class changes, etc.)
- **Late Entry Fee:** A late entry is an entry postmarked, or received via email or fax, after the closing date. A late entry must include a \$25 late fee. Late entries accepted only if space allows.
- **Coggins:** Negative Coggins within 12 months required for all horses. Include with entry for each show.
- **Lunging:** Lunging permitted in areas not being used for show purposes.
- **Entries:**
  - Entries may be mailed or emailed – please see below for payment details
  - With each entry, include: 1) Entry Form; 2) Payment made out to DSDCTA; 3) Coggins; 4) Release.
  - **Accepted entries will be held responsible for all fees.**
- **Payment:**
  - Payment is due when entry is submitted.

  - Entries will be refunded and a request made to pay correctly if you pay goods and services.
  - For mail in make checks payable to DSDCTA.
