COPY TO THE SHOW OFFICE OR A NUMBER WILL NOT BE ISSUED**

1. NO ENTRIES WILL BE ACCEPTED WITHOUT COGGINS.
2. Entries must be received by Midnight of the closing date in the time zone of the competition. Any entry requiring a signature will be considered incomplete and may incur additional fees.
3. No refunds after closing date, for any reason.
4. All fees must be paid in US funds.
5. Entries postmarked or submitted after closing date will be considered late.
6. Numbers will not be given out until entries have been submitted to the show AND owners, riders and coaches or trainers have signed all entry blanks.
7. All entries for Open Classes are taken on a first come, first served basis. Only one horse-rider combination per entry form
8. Late Entries: Late entries will be accepted after the closing date if space is available, upon *payment of an additional late entry fee*.
9. Cancellation prior to or on closing date - entire entry minus office fee.
10. Weather/Acts of God/Accidents or Emergency Policy: Management reserves the right to cancel any classes due to hazardous weather, Acts of God, Accidents or Emergencies. Every effort will be made to reschedule. No refunds for cancellations due to hazardous weather, Acts of God, Accidents or Emergencies.
11. **No Shows:** All "No Shows" that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

- * **Awards for Classes:** Divisions (Jr/Yr, AA, Open) may be run concurrently as one class. Divisions will be pinned separately.
- * Riders must clearly specify division choice. When no designation is made, riders will automatically be entered as open.
- * Riders may enter only one division per class.
- * Ribbons to sixth for each class. No awards for qualifying classes.
- * Champion and Reserve ribbon awarded for the highest percentage at each per division (Open/Adult Amateur/Jr) for the weekend.
- * **Awards Notice:** It is the responsibility of the competitor to retrieve any awards obtained during the competition. Unclaimed awards will be assumed unwanted unless other arrangements are made prior to the completion of the competition.
- * **Junior/Young Rider Classes:** Open to Junior and Young Riders only; any rider is eligible until the end of the calendar year in which they reach 21
- * **Adult Amateur Classes (AA):** Participants must possess a current USEF Amateur Card and qualify under the USEF Amateur rules. Open to Amateurs only; Riders must compete as adults from the beginning of the calendar year to have an amateur status with USEF.
- * **Open Classes:** Open classes are for all participants.
- * **Protective Headgear Rule:** From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds including non-competing riders, riders on non-competing horses and those competing in all classes and tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must be immediately prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.
- * Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/or stall fee before or during the show for cause; all without being liable for damage or compensation.

FACILITY:

- * Important notice to all affected parties: Third parties may come upon the property or enter the facilities where any herein described or listed event will occur; provided, that this is a license to enter the premises, for the purpose of observing or participating in the event, but not otherwise, and such license to any individual is subject to revocation by the owner, lessee or organizer, and entry for any purpose other than granted herein, shall be deemed criminal trespass and subject to appropriate legal proceedings.

- * **Stabling:** Permanent stalls with doors, stall size 12x12
- * **Bedding:** Additional bags available on the entry form
- * **Arenas:** A sand/clay mixture footing is in both arenas. Both the warm up and competition arenas are covered.
- * All classes will be conducted in a standard size arena 20x60
- * **Dogs:** Facility rules require that dogs must be on a leash (not to exceed 6 feet in length) or suitably restrained in a tack stall/cage etc. Loose animals/animals left in vehicles in distress, etc. can and will be removed from the grounds at the owner's expense.
- * **Photography:** Centerline Show Series will be using a professional photographer for the duration of the show. By entering the competition competitors are giving the show permission to take photographs and to use those photographs in promotion of this event and future events.
- * **Directions:** From I-24 E - Take exit I-75 N towards Knoxville. In 19 miles take exit 20 onto US-64 East. Turn left onto Bypass US-64. Continue onto Pleasant Grove Rd. In half a mile turn right and you will arrive at facility

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of Centerline Show Series("CSS") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer, or volunteer) in a CSS Event including but not limited to equestrian clinics, practices, shows, competitions, and related or incidental activities (CSS Events); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

- A. **RULES AND REGULATIONS:** I hereby agree to be bound and abide by the rules and policies of CSS and The USEF
- B. **ACKNOWLEDGMENT OF RISK:** I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any CSS Event involves risk and dangers including, without limitation, the potential for serious bodily injury(including broken bones, head or neck injuries), sickness and disease(including communicable disease), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property(including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers, or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment(including helmets); inadequate safety , measures; participants of varying skill levels; situations beyond the immediate control of the CSS event organizers and competition management; and other undefined, not readily foreseeable and presently unknow risks and dangers("risks").
- C. **ASSUMPTION OF RISK:** I understand that the aforementioned Risks may be caused in whole or in part of result directly or indirectly from the negligence of my own actions or inactions of others participating in the CSS Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such risks and responsibilities for any damages, liabilities, losses, or expenses that I incur as a result of my participation of CSS Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any CSS Event.
- D. **WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY:** In conjunction with my participation in any CSS Event , I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless CSS, members, Event participants(including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; promoters, sponsors, or advertisers of any CSS Event; the owners, managers, or lessors of any facilities or premises where a CSS Event may be held; and all directors , officers, employees, agents, contractors, and volunteers of any of the aforementioned parties(individual and collectively, the "released parties" or "Event Organizers"), with respect to any liability , claim(s), demand(s), cause(s) of action, damage(s), loss, or expense(including court costs and reasonable attorney fees) of any kind or nature("Liability")which may arise out of, result from, or relate in any way to my participation in the CSS Events, including claims for liability caused in whole or in part by the negligent acts or omissions of the Related Parties.
- E. **COMPLETE AGREEMENT AND SERVERABILITY CLAUSE:** This agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability for any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLINGATIONS.

WARNING: Under Tennessee Law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Tennessee Code Annotated, title 44, chapter 20.

By signing below, I (as the participant or as the Parent/Legal Guardian of the minor identified below) hereby accept and agree to the terms and conditions of this Agreement in connection with my (or the minor's) participation in any CSS Event. If, despite this Agreement, I, or anyone on my behalf or the minor's behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities as the result of such claim.

If I am signing electrically, I acknowledge that my electronic signature shall have the same validity, force and effects as if I affixed my signature by my own hand.
