**Entries close on August 18<sup>th</sup>.** No entries accepted by phone. A check for FULL payment or Credit Card info must accompany entries. Entries postmarked after August 18<sup>th</sup> will be charged a late fee of \$25.00 per horse. Class fees will be at the regular fees, no additional post entry fees will be charged.

Canadian exhibitors must pay in US Funds.

**Post Entries** for additional classes will be accepted until the end of the session prior. Morning classes by 8PM the evening before. If you enter after that time, there will be an additional fee of \$5.00 for regular classes, and \$10.00 for championship classes. If not entered when shown, the exhibitor will be charged a double entry fee.

**Returned Checks** Checks returned by the bank for NSF will be charged 10% of the face value of the check or \$50.00, whichever is the greater amount.

**Show Accounts** An open account may be started at the show for post entries only if a signed, blank check made payable to Silver Spur Horse Show or credit card is on file in the show office. If a posted class is charged to the exhibitors account, and is later scratched, the exhibitor is still responsible for payment of that class. Even exchanges for posts and scratches will be allowed, except for Dressage classes. No prize money will be issued until the exhibitor has cleared their show account. Prize money vouchers may be used as credit against the exhibitors show account.

**Prize Money** Vouchers & Awards will be given out with ribbons. Prize \$ vouchers may be turned in at the show office for prize money. Prize money and other awards not claimed will not be mailed. Championship classes with less than 4 entries will receive 1<sup>st</sup> Place prize money ONLY. Prize \$ paid in championship classes only, all other classes will receive an award of the exhibitors choice.

**Refunds/Vet Scratches** Full refund, less office fee if a vet note is submitted to Show Secretary before the start of the show. No Refunds once on the Show Grounds. In the case where a horse has been entered, and not shown all fees will be forfeited.

**Scratches** The office must be notified if a horse does not intend to show in a class for which it has been entered. A \$25.00 no show fee will be charged to the exhibitor for not notifying the office. In the case where a horse has been entered and not shown, class fees will be forfeited.

**Warm Up Ring** There is to be no lunging or long lining in the warm up ring when classes are in session. The rings will have lights on until 11pm Thursday, Friday & Saturday night.

**I AGREE** that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. **I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. 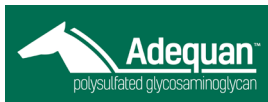
