Fees Horses entered in the A/HA/AA classes must pay the AHA fees.

Western Dressage Tests Current 2022 WDAA Western Dressage Tests will be used.

Entries Online entries via Equestrian Entries is preferred. If mailing entries, entries must be submitted on the official entry form for this show; photocopies are accepted; both sides of entry form required. Please type or print legibly. Make all checks payable to CJ Gates Show Services, LLC. Entries received after the entry close date will incur a \$25 late fee. A wait list will be maintained.

Entries Cap There will be a maximum of 60 rides. Post entries will only be accepted if there are time slots available. Please contact management before sending in late entries.

Horse Health Requirements All horses must present a current negative Coggins dated within 12 months of the show. Out of state horses need a CVI dated within 30 days of the show per state rules.

LIABILITY: You assume the risk of equine activities pursuant to Pennsylvania Law.

INDEMNITY AND RESPONSIBILITY All entries are accepted with the understanding that neither CJ Gates Show Services, LLC, WDAA, AHA, Blue Goose Stables LLC, the Harford County Equestrian Center, the Show, the Show Committee, nor any Show Official will be held responsible for any loss, damage, or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him, and the exhibitor shall indemnify the above mentioned parties against any and all loss, damages and liability thus occasioned, including, but not limited to, any and all legal costs, including attorney fees, which may be incurred as a result thereof. Submitting of any entry form to the Show shall constitute an acceptance by each person signing same of the provisions herein set forth.

Show Rules All classes will be conducted in accordance with the rules of USEF and WDAA. Judging, class specifications, rules and conduct shall be in accordance with the current USEF/EC Rulebook. All decisions made by the Judge and/or Show Management are final and cannot be protested. Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason including but not limited to: unsportsmanlike conduct and animal cruelty.

Refusal of Entries The Show Management reserves the right to refuse, accept conditionally or to cancel any entries of any exhibitor.

Refunds In case of injury or illness of horse or rider before the event, a vet certificate or medical excuse is required before 8 am of the first day of the event. All fees except the office fee (\$10) will be refunded. Refunds will be mailed within 30 days.

Information & Rules

AHA Registry Requirements A copy of the registration certificate showing proof of ownership must be submitted with the entry form at the time of making entry. In case of a lessee, pending transfer, contract of sale, or cash sale, a copy of the registration certificate must be submitted, along with proof of lease or ownership and these documents must be attached to the copy of the registration certificate and must contain the correct registered name and number of the horse, date, and the signature of the seller or lessee.

AHA MEMBERSHIP STATEMENT: EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITION.
