**TAGDEA Release, Assumption of Risk, Waiver and Indemnification**

**This document waives important legal rights; read carefully before signing**

By participating in the horseback riding activities and/or mounted or unmounted events ("Event") offered, hosted or sponsored by Tennessee Alabama Georgia Dressage and Eventing Association ("TAGDEA"), and by my signature hereon, I hereby assume all risks, known and unknown, associated with horseback riding and working around horses, and hereby waive any and all claims, actions, causes of action that I may now or hereafter have against, and I release and will indemnify and hold harmless from the same, TAGDEA, and its employees for all injuries and damages that I, or my minor children, may suffer or sustain in connection with, or arising from my participation, or my minor child's participation in the horseback riding activities offered by TAGDEA.

I AGREE, in consideration for my participation in this event to the following:

I AGREE that TAGDEA as used herein includes Tennessee Alabama Georgia Dressage and Eventing Association, its officers, assigns, officials, directors, employees, agents, personnel, affiliates and volunteers. I AGREE that I choose to participate voluntarily in the activity with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as a parent or guardian of a junior exhibitor or participant. I am fully aware and acknowledge that horse sports and the Event involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). I AGREE to hold harmless and release TAGDEA and the Event from all claims for money damages or otherwise for any Harm to me or my horse, and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results resulted, directly or indirectly, from the negligence of TAGDEA or the Event. I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of TAGDEA or the Event. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) TAGDEA and the Event and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Event. I have read the United States Equestrian Federation ("USEF") Rules about protective equipment, including GR801 and if applicable, EV114, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that TAGDEA strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior participant, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. I represent that I have the requisite training, coaching and abilities to safely compete at, or participate in, this Event. I AGREE that if I am injured at this Event, the medical personnel treating my injuries may provide information on my injury and treatment to TAGDEA on the official accident/injury report form.

BY SIGNING BELOW, I AGREE to be bound by all applicable TAGDEA Rules AND all USEF Rules and all the terms and provisions of this Release. If I am signing electronically, I acknowledge that my electronic signature shall have the same validity, force and effect as if I affixed my signature by my own hand.
