Rules and Guidelines for Virtual Show

This show will be run by WDAA rules. Each horse/rider combination must stay within 2 levels and a maximum of 4 rides. Entries will be accepted on the first received and first paid basis. Entry fee is \$30.00 per ride. Office fee is \$15 per entry form.

Equipment:

Western Dressage: Legal attire can be as simple as jeans, western type shirt and western type boots, and a cowboy hat or an ASTM SEI approved riding helmet. A simple western saddle and western type bridle with a simple snaffle bit are correct and legal for ALL levels of Western Dressage. A Hackamore(bosal) is permitted on a horse of any age at any level.

Classical Dressage: An ASTM SEI approved riding helmet is required. For this schooling show both informal attire or the more formal attire are acceptable.

All equipment must comply with USEF rules.

For Western Dressage classes see USEF rulebook Western Dressage rules.

For Classical Dressage see USEF rulebook Dressage DR rule 120 and 121.

Ear nets are permitted.

Side reins, running reins, or martingales of any kind are NOT ALLOWED.

All boots or bandages are not allowed.

Fly masks are not allowed.

Online Show Guidelines

- 1. Use arenas that are as close to regulation size as possible. Be sure the letters are set appropriately to be viewed by the judge.
- 2. Videos of tests must be unedited from start to finish, including the equipment, attire, and bit check. They must be one continuous recording with the horse and rider visible at all times.
- 3. Videos of tests MUST be shot in LANDSCAPE orientation.
- 4. The test must be shot from behind C, where the judge would normally be seated.
- 5. Prior to beginning of the test, the PREFILLED CLASS INFORMATION SIGN (including the DATE filmed) must be videoed for 5 seconds. Remove the sign just before the ride begins. The videographer can hold the sign sign then move back to behind the camera or hold the sign in front of the camera at arm's length while also holding the camera.
- 6. Keep the horse in frame, paying close attention to the near corners. You may zoom in slightly on the far corners. Videos must be in focus.
- 7. Make sure to keep the letters in the frame that are elements of the test being performed.
- 8. As soon as the test is finished, the camera must slowly circle the horse and rider showing all equipment and attire, including spurs and whip if used. If the videographer is unable to enter the arena, at G the rider may turn the horse slowly, wait for five seconds, then turn slowly to show the second side, and wait an additional 5 seconds to complete filming of the equipment.
- 9. Following equipment check, the rider will dismount and show that two fingers can fit between the Bosal or Cavesson and the horse's cheek, then drop the bit so it can be evaluated. NOTE: Hold the bridle so as not to obscure the curb strap or curb chain. Demonstrate that the curb strap or chain is flexible and is at least 1/2 inch wide. Make sure the judge can see all parts of the bridle, including bit and reins clearly.
- 10. Exceptional riders are exempt from the dropping the bit requirement.
- 11. Coaching during the test is not allowed EXCEPT for exceptional rider tests.
- 12. The natural background sound for the test must be audible. Tests with no sound at all will not be accepted.
- 13. No horse may be ridden more than once in any class.
- 14. The test may be called.
- 15. THE VIDEO MAY NOT BE A RIDE FROM A PREVIOUS SHOW.

PLEASE NOTE--Show management will review all submissions to ensure adherence to the guidelines as stated above. If a test is submitted that does not comply with these guidelines, Show Management will contact the exhibitor immediately via email or phone. The exhibitor will have 48 hours to resubmit their test from the time of the notification. Please take all guidelines into consideration when preparing your test submission.

To submit your video, choose your file sharing service(YouTube, Drop box, the Cloud as examples) and send the link to WDAAZ1234@gmail.com. One ride per email. Must include your name and Test in the subject line of the email.
