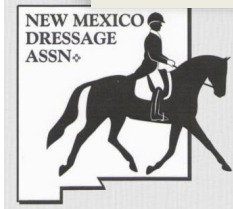

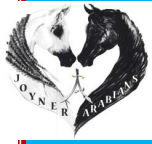

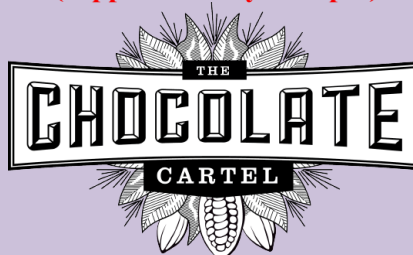

# ZIA CLASSIC AVS ENTRY INFORMATION

A horse must be entered in the name of his registered owner(s) only and must be entered under its full registered name. **All entries must be accompanied by a valid check or money order for the full amount of all fees made out to AHANM or pay with the credit card option.** A signature by the parent is required if a minor is showing. *Open checks are required upon check in. All entries must be paid in full. Checks will be deposited upon receipt. All checks payable to AHANM for BOTH shows.*

## IF SENDING BY MAIL, ALL OF THE FOLLOWING MUST BE MAILED TO THE SHOW SECRETARY:

1. The complete, signed entry form and all waivers for each show.
2. Copies of AHA, USEF, AQHA, WDAA membership cards as applicable.
3. Copies of Horse's Registration Papers for those competing in AHA or AQHA classes.
4. Fees Payable to AHANM.
5. Please be sure to include email address on entry form.

Exhibitors showing in Amateur Owner classes must be listed as an owner of the horse on the registration papers of the horse they are exhibiting.

**\*\*AHA requires current membership and competition card to compete at Region 8 Championships.**

**\*\*\*All entries must be made in writing on an official entry form for this show or the online entry system.** Every owner, trainer, rider, driver, handler and parent or guardian of a junior exhibitor must sign the entry form waivers and must be an AHA Competition Member or pay the nonmember/single event fees and Non-Member Fees (Zia Classic only). A horse must be entered in the name of his/her recorded owner. The complete address and phone number of the recorded owner must be given, even if an agent enters the horse. No horses may be entered on more than one form.

This horse show is conducted in accordance with the Rules of the United States Equestrian Federation, Arabian Horse Division. The official Rule Book of USEF will prevail for this show. This premium list is based on the rules of the current Rule Book. Any changes or corrections of rules will automatically become a part of this premium list. Each participant in the show is responsible for knowledge of and is subject to the USEF Rules. The Show Committee shall decide questions not covered by USEF rules and its decisions will be final.

**AHA MEMBERSHIP STATEMENT: EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR. WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP. SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS. EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS. EXHIBITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS.**

**AHA REQUIREMENTS:**

- A) At Zia Classic Show, all exhibitors entered in A/HA/AA classes must be a current AHA member with a competition card, join AHA at the show, or pay a Single Event Membership fee of \$35.00 per person. This includes any owner, trainer, driver, rider, or halter handler who exhibits horses in the show ring or signs the entry form as the responsible person for any individual's horse. A photocopy of your AHA membership card must accompany your entry. No Single Event Memberships are available at the Region 8 Championship Show.
- B) AHA Membership affidavits are no longer available. If you do not have your AHA card you must pay the single event Member fee.
- C) There is an AHA fee of \$10.00 per horse for Zia Classic (\$5 AHA judges' commission and education/evaluation, Resolution 9-90 and \$5 AHA per horse fee) and a \$25.00 AHA Fee for all Regional Classes.

**USEF RULEBOOK AR101 ELIGIBILITY TO COMPETE(Region 8):**

**Purebred:** Horses shown in this division must have been issued a certificate of registration from the Arabian Horse Registry of America, Inc., or the Arabian Horse Association as a Purebred Arabian and/or the Canadian Arabian Horse Registry (or in the case of a foreign entry, which has not been issued said certificate of registration, have been issued a Competition Visa by the Arabian Horse Association), or, **if under one year of age, be eligible for registry, and registration applied for** (Exception: AR249.1) **and must be entered under their full registered name.** (Only weanlings that have had registration applied for may show without registration papers). A copy of the registration papers showing the owner of record with the Arabian Horse Association must be submitted with entry form at the time of making entry; competition management is responsible for notifying exhibitors of this requirement. A copy of the registration papers will be returned when exhibitors pick up their numbers. In the case of a sale or lease, it is required that a contract of the sale or lease, or statement from owner be submitted with the copy of the registration papers. (Exception: Horses under one year of age).

**Half-Arabians and Anglo-Arabians:** Horses shown in this section must have been issued a certificate of registration from the International Arabian Horse Association or the Arabian Horse Association or the Canadian Partbred Arabian Register as a Half-Arabian or Anglo-Arabian, **or if under one year of age, be eligible for registry and registration applied for and must be entered under their full registered name.**

**USEF MEMBERSHIP STATEMENT:** Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR218) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) All Breed classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

**ARENAS:** The indoor arena is 117' x 250'; Outdoor arena is 125' x 264'. Footing in all arenas and warm up areas is sandy loam. \*\*Arenas will be available for schooling on May 24th.

**BAD CHECKS/DECLINED CREDIT CARDS:** There will be a \$50.00 handling fee charged for any returned check or declined credit card. Action in accordance with USEF rules will be taken against any owner, exhibitor or trainer who does not make a returned check/declined credit card charge good and will be reported to AHA.

**BARN OFFICE:** Barn manager is Margie Billau (505) 980-6806. Early arrival or late departure is \$25 per day per stall used. **NEW MEXICO STATE FAIRGROUNDS AND/OR AHANM IS NOT RESPONSIBLE FOR ANY ITEMS LEFT UNATTENDED.**

**CALL FOR CLASSES:** The two-minute gate will be enforced. The gate will close two minutes after the first horse enters the ring or in cases with large classes taking more than two minutes, after the entry of the final horse in a continuous string of horses. If tack changes are necessary, it is the exhibitor's responsibility to notify the gate person and request a three-minute gate hold. Note: Due to unforeseeable problems with the mechanical devices, the paddock and barn calls over the PA system must be considered a COURTESY. It is the responsibility of the exhibitor to be sure that his/her horse is at the gate at the prescribed time.

**CANCELLATION OF CLASSES DUE TO EMERGENCIES:** In the event that a class, or a series of classes, or all or part of the competition is cancelled due to an accident, storm, or other emergency after the start of the show (defined as initial Move-In Day), no refund of entry fees will be made. Classes are subject to change.

**DOGS:** Dogs will be permitted on the show grounds but **MUST** be always on leashes. No dogs will be allowed in the show arena. This is a USEF Yellow Warning card offense (GR1037 & GR1301.6).

**DRESSAGE CLASSES: FOR DRESSAGE/WESTERN DRESSAGE—POST ENTRIES WILL NOT BE ACCEPTED\*\*\***  
Dressage classes may not run in order listed in the schedule. Maximum of 55 rides/day available – Maximum of three (3) rides per horse/day. Dressage entries must be mailed or e-mailed and postmarked or e-mail time will determine order of entry. No hand carried entries accepted. Ride Times will be available on the AHANM Website <https://www.nmarabs.org> and on Manneconnexions.com. Once ride times are sent/posted they will not change. Zia Classic is a USDF Recognized Schooling Show & Region 8 USDF Breed Restricted Dressage/Western Dressage. \*\*Dressage Coordinator is Teresa Heine [hawaiianwhitechick@yahoo.com](mailto:hawaiianwhitechick@yahoo.com). **All Region 8 Dressage & Western Dressage MUST BE PRE-ENTERED.**

**ENTRIES: All entries must be made on the official entry blank for this show or on the online entry system.** A horse must be entered in the name of his registered owner(s) only and must be entered under its full registered name. A photocopy of all AHA membership cards and registration papers must accompany your entry form or be uploaded to the online entry system. All entries must be accompanied by a valid check or money order for the full amount of all fees made out to AHANM. A signature is required by the parent if a minor is showing. *No entries will be accepted with open checks. All entries must be paid in full. Checks will be deposited upon receipt. Open checks will only be accepted for post entries.* Exhibitor Numbers will be released to exhibitors **ONLY** when **ALL** the fees, signatures and information are complete. **Closing Date for Entries – May 10<sup>th</sup>, 2023**

**FARRIER:** A Farrier will be available on show grounds.

**FEED & BEDDING:** Feed and bedding is available on the fairgrounds from 4-W Feed Store (505) 934-2681. The use of outside shavings is not permitted on fairgrounds. If a medical condition requires the use of special bedding, please provide proper documentation from a licensed veterinarian.

**HEALTH REGULATIONS:** All horses must have a negative Coggins Test dated within twelve (12) months (must be original not photocopy). All out of state horses must also be accompanied by an Official Health Certificate issued within 30 days of arrival that identifies the animals listed, including all vaccinations, and date and results of required test. **THE ABOVE ITEMS SHOULD BE CARRIED WITH YOU – DO NOT FORWARD WITH YOUR ENTRY.** Any animals brought into New Mexico must observe all regulations of the State of New Mexico, Animal Health Division. Any horse that develops a communicable disease must be removed from the show grounds.

#### **USEF GR845 Equine Vaccination Rule**

1. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturer's or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian. 2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration. 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management,

showed, or technical delegate when requested. 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee. BOD 1/17/15 Effective 12/1/15.

**INDEBTEDNESS TO SHOW:** Any exhibitor who fails to settle his/her indebtedness to this show will automatically be reported to AHA and USEF.

**JUDGES:** This show will be judged according to the single judge systems. If an official is unable to perform his duties, the Show Committee reserves the right to substitute an official according to USEF rules. It is a violation of USEF Rules to commit any act or make remarks during the show that are considered offensive or made with intent to influence or cast aspersions on the judging and any exhibitor may be barred from the show for this offense by the Show Committee. No contact shall be made with the Judges during the period of the show unless accompanied by a member of the Show Committee designated by the committee for such purpose. Further, no exhibitor shall approach a Judge regarding a decision unless he first obtains permissions from the Steward, who shall arrange an appointment with the Judge at a proper time and place.

**MOTORIZED VEHICLES:** Golf Carts and Other Motorized Vehicles – To operate any motorized vehicle on the New Mexico State Fairgrounds, you must have a valid driver's license or operator's license as defined by the state in which you reside. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from the rule. Golf carts must be registered with NMSF to be driven anywhere on the fairgrounds.

**\*\*Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.**

**The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.**

**POST ENTRIES:** NO Post Entries will be accepted for Dressage or Western Dressage classes. Post entries will be accepted for all other Zia classes with an added Class Fee of \$5/class. Entry close date is May 10<sup>th</sup>, 2023. For Region 8—no post entry fees if qualifying for the first time at Zia Classic.

**PRIZE LIST CHANGES AND/OR CORRECTIONS:** Changes and/or corrections to the Premium, if any, will be posted on the Club's website [www.nmarabs.org](http://www.nmarabs.org) and Facebook page for AHANM.

**PROTECTIVE HEADGEAR:** Any rider may wear protective headgear in any division or class without penalty from the judge. USEF strongly encourages all riders to wear protective headgear. It is the responsibility of the rider, parent, guardian, or trainer of the junior exhibitor to see that the headgear worn complies with safety standards and is properly fitted and in good condition. Refer to current USEF Rule Book.

**PROTESTS.** Any protest must be made in accordance with USEF rules governing protests.

**REFUSAL OF ENTRIES/PROTESTS:** The show Management will be governed by USEF rules with respect to refusal of entries. All decisions made by the Judge and/or Show Management are final and cannot be protested. **Show Management reserves the right to ask any exhibitor to leave the show grounds for any reason including but not limited to unsportsmanlike like conduct and animal cruelty.**

**REGISTRATION REQUIREMENTS:** Horses shown in the Arabian Division must have been issued a certificate of registration from the Arabian Horse Association and must be entered under their full registered name. Horses shown in the Half-Arabian/Anglo-Arabian Division must have been issued a certificate of registration from the Arabian Horse Association in the Half-Arabian or Anglo-Arabian Registry and entered under their registered name.

**RESPONSIBILITY:** All entries are accepted with the understanding that neither Arabian Horse Association of New Mexico nor the EXPO Fairgrounds will be responsible for any loss, personal injury, or damage to any horse exhibited or for any article of any kind or nature that may be lost or destroyed or in any way damaged. All horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor who will be responsible for any loss, damage, or injury of any person, animal or property occasioned by him or his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the Arabian Horse Association of New Mexico and



the New Mexico State Fairgrounds against any and all legal costs, including attorney fees which may be the result thereof. The submitting of any entry form to the Show Secretary shall constitute an acceptance of the provisions herein set forth.

**SAFE SPORT STATEMENT:** Effective immediately, any competition with the start date of September 1, 2020 and later will be required to include the following Safe Sport statement in the Rules and Regulation section of the prize list: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. **SCRATCHING CLASSES:** No refund of entry fee when scratching classes.

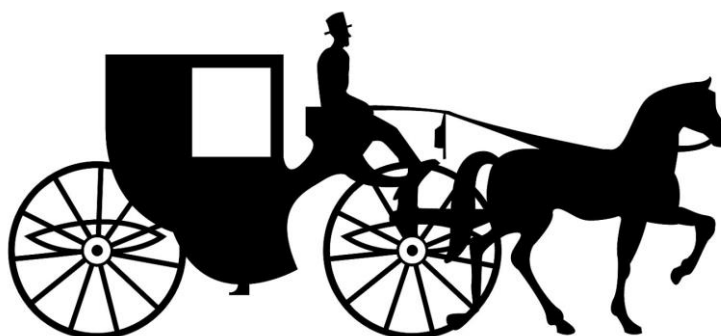
**SHOW OFFICE HOURS:** Show Office will be open May 23rd. Check in appointments are encouraged for groups of 6 or more. The show office will remain open throughout the show and will close 30 minutes after the last class of the show each day. Please remember to check out after your last class. There is a Courtesy Fee of \$20 for not closing out your show bill.

**STALLIONS** are not allowed in showmanship or walk-trot classes.

**STALLS:** Horse Stalls & Tack Stalls are available for \$25 night. Stalls and alleyways must be kept clean. Horse tie out is available with a ground tie fee of \$25 per day per horse, no overnight. Stalls can be reserved by sending in the appropriate stall fees, but no stalls will be held without payment. Early Arrival/Late Departure is \$25/stall/night. Stalls are 10 x 10 with a door. Early or Late Arrivals, please contact the Barn Manager.

**VETERINARIAN:** A veterinarian will not be on the fairgrounds. Information for the closest vet will be posted at Show Office.

**WITHDRAWING ENTRIES:** Entries may be scratched from the show PRIOR TO May 10<sup>th</sup>, 2023 with a refund of all fees EXCEPT the office fee. After that date, withdrawals accompanied by a veterinarian's certificate of inability to show will receive refunds of class entry fees only. No refunds for scratched classes—No exceptions.



# DEFINITIONS & CLASS SPECIFICATIONS

**DEFINITIONS:** The following abbreviations, as defined, will be used to describe class specifications:

**JOTR/JOTD** — Junior Owner to Ride/Junior Owner to Drive.

**AOTR/AOTD** — Amateur Owner to Ride/Amateur Owner to Drive.

**JTR/JTD** — Junior Exhibitor to Ride/Junior Exhibitor to Drive.

**ATR/ATD/AATR** — Amateur to Ride/Amateur to Drive/Adult Amateur to Ride.

**SELECT** — AOT, AAOT, AT, AAT, JOT, JT — Refer to USEF AR113.1f

**All Breed Classes:** Are for any breed and DO NOT need AHA Membership or Registration Papers. All Breed classes are Open to ANY BREED. Martingales, hackamores, humane training devices and two hands are allowed in ALL All Breed classes. Show clothes and equipment are not necessary but may be worn in All Breed classes.

**Amateur** — Every Adult rider having reached his/her 19<sup>th</sup> birthday prior to 12/1 of the previous year must have an amateur card issued by USEF.

**Amateur owners** — Leased horses are not eligible for amateur owner classes. Horses entered in amateur owner and junior owner classes must be registered in the name of the competitor or a member of the competitor's family, as defined by USEF GR122. The sale of a horse does not eliminate this requirement. (Contracts of Sale or Bill of Sale will not be accepted.)

## **Regional Dressage/Western Dressage Class Information**

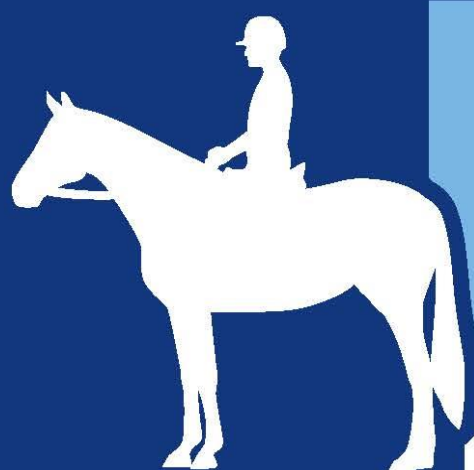
**Dressage & Western dressage classes may not be scheduled in order shown.** Depending on number of entries, this class schedule may be altered. For western dressage, Show Management reserves the right to limit any horse/rider combination to a maximum of two consecutive levels. Current Dressage and 2022 WDAA tests will be used.

\*\*Regional ride times for Region 8 Show will be available the day before the classes will be held. Responsibility for acquiring the ride times remains with the exhibitor.

NO POST ENTRIES. ALL Rides must be pre-entered by closing date of May 10, 2023. Qualification is based on participation. If an entry does not meet qualification, class fee will be refunded. **WE WILL NOT ADD RIDE TIMES AT THE SHOW.**

## **Sport Horse In-Hand Information**

In-Hand classes will run on an Open Card. Entries will be accepted on a first come, first serve basis. It is the exhibitor's responsibility to follow the speed at which the classes are progressing and to be present at the appropriate time for each go.

**USDF Membership Benefits:** USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at [www.usdf.org](http://www.usdf.org).

**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

**Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

**Memberships Defined**

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

**How to Join USDF**

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: [www.usdf.org](http://www.usdf.org). You can submit the application online or download the form and fax or mail it to the USDF office.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at [www.usef.org](http://www.usef.org), as amended from time to time.

B.
